This economy, combined with the facilities and communications available, makes it ideal for official entertainment, meetings and/or relaxation. A maximum of 40 people can be accommodated on board; 22 for a sit-down dinner.

Boarding and debarkation is from the Naval Administrative Unit secure compound at the Washington Navy Yard in Southeast Washington, 8-10 minutes driving time from the White House. Cruises can be tailored to any duration -- including overnight. Typical cruises in the past have varied, but have included: Navy Yard, up the Washington Channel to Hogates and return $(l\frac{1}{2})$ hours); Navy Yard to Mount Vernon and return (5 hours); Navy Yard to Mount Vernon $(2\frac{1}{2}$ hours) and helicopter to the South Lawn (10 minutes), or Camp David (40 minutes). > Since frequently the groups were also on tour at the White House, Mike Farrell's office handled these bookings in conjunction with the First Lady.

Other White House Staff and Administration Officials - On a case by case basis, White House Staff (primarily the Congressional Office, Public Liaison Office, Domestic Council and Press Office, and other high Administration officials have been permitted to use the SEQUOIA for "Official Use."

As is the precedent for Camp David, members of the press have not been included as guests aboard the SEQUOIA.

The Staff Secretary's Office handled the White House Staff requests. The Cabinet Secretary handled the others.

"Official Use" by the President, First Family (including the First Lady's afternoon program) has been paid out of appropriated funds, specifically the <u>White House Entertainment Account</u> (Reception and Representation Account) or by the Department or agency of primary responsibility (i. e. when the President entertains a State Visitor, the Department of State picks up the tab).

For Cabinet Members or high government officials, the appropriate Department or agency pays the entertainment expenses.

For non-official or political use, payment was received from the President's personal entertainment account or from the RNC.

Before deciding on a plan for using the SEQUOIA, the President might want to consider giving up the yacht. WHO MAY HOST GROUPS ON THE SEQUOIA

1. Cabinet - After the President and First Family, the Cabinet Members have priority on booking the boat. Only the President and First Family may use the boat for personal entertainment. All other outings must be for "Official Use" purposes. The Cabinet may schedule the boat on a first-come, first-serve basis. When they may schedule the boat with respect to the President's schedule is discussed below.

The Cabinet Secretary will handle Cabinet requests for the boat and will insure that the use is "official."

Preferred Staff Use - The Congressional Office and the Public Liaison Office (Baroody operation) will be given equal footing with the Cabinet for scheduling the SEQUOIA two times each per month for "official use".

THE KEY QUESTION

Use by the Cabinet, staff and other government officials must be limited by the perspective use of the President. Clearly, on nights when the President's schedule is committed to other activities, the SEQUOIA is available and there is no problem involved in booking it. The question is, what about the President's free nights?

The answer to this question will, of course, depend on how often the President plans to use the boat.

One way to handle this is to reserve the boat for the President one or two nights a week in case he should decide to go out at the last minute.

Another alternative would be for the schedule office to raise the question three weeks in advance and if the President said no to a particular date, it would be available for others. The only problem with this is that it would limit the President's ability to take advantage of a nice evening and go out at the last minute.

The Staff Secretary's Office handled the White House Staff requests. The Cabinet Secretary handled the others.

THE KEY QUESTION

To use the boat effectively when the President is not using her, the Cabinet and staff need to lock up dates far enough in advance to plan for the outing and extend invitations, particularly when dealing with out of town guests.

This raises the key question of how often the President will use the boat. In the past, whenever the President was in town and did not have another commitment, the boat was held just in case he decided to go out at the last minute. This resulted in the SEQUOIA not being used most of the time.

One way to handle this is to reserve the boat for the President one or two free nights a week in case he should decide to go out at the last minute, and let others use it the remainder of the week.

Another alternative is for the scheduling office to raise the question of Presidential usage three weeks in advance and if the President says no to a particular date, it would be available for others.

Jim, we definitely do want to keep the boat in service this year and we would like to use it from time-to-time for working dinners and with dignitaries, either from the U.S. or abroad.

You ought to think about using it for a Goldwin Seminar. Tell Goldwin that and get him thinking about how we might most effectively use it. We could provide for about a three hour trip, which would be ideal, do it some evening, keep the group small and we wouldn't have the problems we had with sound and so forth at the Cabinet Meeting.

The President will not end up using it at the very last minute. That is, we'll know a few days in advance as to whether or not he's going to use it, so it will be possible for others to make firm decisions and commitments say three days in advance of the sailing date.

The Cabinet should definitely be able to use it. That should include those senior White House staff members who are members of the Cabinet.

We do not want to treat it like we do the Kennedy Center Box where we allocate a certain number of days to the Congressional Shop or to the Baroody or Friedersdorf operation.

If someone wants to use it, they'll have to submit for approval each time, and I'd want that to come up to me for sign off unless a Cabinet Member has requested it.

Finally, you ought to sit down with Jones and maybe some other people and see if you can come up with some creative ways to use it to help the President.
