



Per your request, attached is a copy of your memorandum to the President of October 31, 1974, regarding acceptance of honorary memberships by the President and his family.

The memorandum establishes a general policy of declining membership in all organizations except (a) public and quasi-public organizations with which Presidents and their families have traditionally been associated (Boy Scouts, Red Cross, United Fund, etc.), and (b) certain organizations that are personal to the President, including civic or professional associations predating his presidency and not inconsistent with the conduct of his office. The latter exception also recognizes that there may be some political or home town organizations that are distinguishable and that are to be dealt with on an ad hoc basis.

With respect to these two categories of exceptions, established procedure provides that membership requests that cannot be handled by a routine letter of rejection are to be reviewed by Roland Elliott. If Roland recommends acceptance (a determination which is usually made based upon protocol and a rather substantial body of precedents), then the matter is referred to Counsel's office for final review. However, before a final decision is made on accepting any membership so recommended, the matter is referred to the President for his review. (The latter step was added at the President's specific request, although previous Presidents have not regularly involved themselves in such matters).

With respect to the Chevy Chase Club, it has been traditional for the President to maintain membership on only one Washington area country club (usually Burning Tree). All other offers of country club membership

are uniformly rejected. (Depending upon the prestige of the club, the "turn down" may be made with a Presidential letter--as was the case with Chevy Chase). The reason for this practice is that to accept membership in one country club would be to discriminate against all other clubs; and to accept all memberships could result in the President being affiliated with clubs of questionable repute or with restricted admission policies. Accordingly, Roland recommended declining the Chevy Chase Club, and I concurred in that determination.

Honorary Mamberships and Endorsaments for the President and his Family

The President continuously receives offers of honorary memberships and requests to join this or that organization or endorse a cause. The policy adopted by the previous Administration after the first year of struggling with such decisions was to reject them all, with a few exceptions.

I. General Policy to Decline Memberships and Endorsements.

The principal hazards in accepting such offers are (1) the uneven extension of Presidential favors, creating an appearance of favoritism and proliferating even more such requests, and (2) linking the President's name to solicitation of funds and the like,

The reason for rejection stated in the answering correspondence is that "the President receives so many requests of this kind that the only fair course is to deny them all." The words "of this kind" previde a hedge for whatever exceptions are made.

Many offers of honorary memberships are accompanied by cards or cartificates. These are kept, even though the membership is declined "as a token of your thoughtfulness" in making the offer. The rationals for retention is (1) to avoid a seeming plays in the face by return of the entire package, and (2) the human interest value in the accumulation of such tokens.



Fund raising and commercial offers have been rejected on principle as inappropriate for the President, except as noted below.

H. Exceptions

A. Publis and Quasi Public Organizations

Presidents have traditionally consented to honorary titles and patrosage of official and quasi official organizations. Examples include the American National Red Cross, the United Fund, the United Nations Association, the Boy Scouts of America, and the like. A tradition of membership by past Presidents may sometimes be regarded as conferring a quasi-public character on an organization. For such organizations as the Red Gross and Boy Scouts, which have both national and local organizations, Presidential participation has been limited to the national organization.

B. Other Exceptions

An occasional exception is made because of associations that are personal to the incumbent President, such as his own membership in a golf club, or civic or professional affiliations pre-dating his Presidency and not inconsistent with the office. There may also be some personal or political interest or hometown associations that are distinguishable and can be dealt with on a case by case basis.

It is recommended that the same policies be followed by the mambers of your family.

III. Recommended Disposition of Offers and Requests

We have accumulated offers received since you took office pending adoption of a general policy, except for a few that required immediate action. On the basis of the policies described above they have been divided into three general groups as follows:

- Tab A: Public and quasi-public organizations for which acceptance is recommended.
- Tab B: (1) Possible approvals as exceptions depending on guidance from you or a designated adviser.
 - (2) For consideration on the same basis, all Masonis offers have been segregated under this tab.
- Tab C: (1) Proposed rejections under the general policy.
 - (2) Proposed rejections subject to review in case an exception should be made for political reasons.

My recommendation would be that you authorize acceptance now for all organizations listed at Tab A. I believe the remainder should be reviewed by an adviser from a political standpoint under whatever general policy you direct in response to this memorandum. Any acceptance which may be thus recommended should be forwarded to the Counsel's office. Per your request, attached is a copy of your memorandum to the President of October 31, 1974, regarding acceptance of honorary memberships by the President and his family.

The memorandum establishes a general policy of declining membership in all organizations except (a) public and quasi-public organizations with which Presidents and their families have traditionally been associated (Boy Scouts, Red Cross, United Fund, etc.), and (b) certain organizations that are personal to the President, including civic or professional associations predating his presidency and not inconsistent with the conduct of his office. The latter exception also recognizes that there may be some political or home town organizations that are distinguishable and that are to be dealt with on an ad hoc basis.

With respect to these two categories of exceptions, established procedure provides that membership requests that cannot be handled by a routine letter of rejection are to be reviewed by Roland Elliott. If Roland recommends acceptance (a determination which is usually made based upon protocol and a rather substantial body of precedents), then the matter is referred to Counsel's office for final review. However, before a final decision is made on accepting any membership so recommended, the matter is referred to the President for his review. (The latter step was added at the President's specific request, although previous Presidents have not regularly involved themselves in such matters).

With respect to the Chevy Chase Club, it has been traditional for the President to maintain membership on only one Washington area country club (usually Burning Tree). All other offers of country club membership



are uniformly rejected. (Depending upon the prestige of the club, the 'turn down' may be made with a Presidential letter--as was the case with Chevy Chase). The reason for this practice is that to accept membership in one country club would be to discriminate against all other clubs; and to accept all memberships could result in the President being affiliated with clubs of questionable repute or with restricted admission policies. Accordingly, Roland recommended declining the Chevy Chase Club, and I concurred in that determination.

After you sent me the President's note indicating that he wished to accept the offer of an honorary membership in the Chevy Chase Club, you asked me to check back on the approved procedures in this regard.

Therefore, I enclose the following:

With respect to these two categories of exceptions, established procedure provides that membership requests that cannot be handled by a routine letter of rejection are to be reviewed by Roland Elliott. If Roland recommends acceptance (a determination which is usually made based upon protocol and a rather substantial body of precedents), then the matter is referred to Bill Casselman for final review. However, before a final decision is made on accepting any membership so recommended, the matter is referred to the President for his review. (The latter step was added at the President's specific request, (Tab D), although previous Presidents have not regularly involved themselves in such matters.)

In the case of the Chevy Chase Club, Roland Elliott recommended declining the offer of membership in accordance with the general policy of Tab A, and Bill Casselman concurred in the determination and prepared a letter for the President's signature declining the invitation to become an honorary member, (Tab E).

The President already has his personal membership in Burning Tree which he had joined much earlier, and acceptance of the Chevy Chase Club offer does not come within the exceptions set forth in paragraph II.B, of Tab A. Also, conferring by the Chevy Chase Club of full membership priviliges on the President for his lifetime represents a substantial benefit, in that the Club ordinarily requires payment of a \$5,000 initiation fee and substantial annual dues.

I am also returning to you the President's handwritten note in reference to the Chevy Chase Club, (Tab F).

The President continuously receives offers of honorary memberships and requests to join this or that organization or endorse a cause. The policy adopted by the previous Administration after the first year of struggling with such decisions was to reject them all, with a few exceptions.

1. General Policy to Decline Memberships and Endorsements.

The principal hazards in accepting such offers are (1) the uneven extension of Presidential favors, creating an appearance of favoritism and proliferating even more such requests, and (2) linking the President's name to solicitation of funds and the like,

The reason for rejection stated in the answering correspondence is that "the President receives so many requests of this kind that the only fair course is to deay them all." The words "of this kind" preside a hedge for whatever exceptions are made.

Many offers of honorary memberships are accompanied by cards or cartificates. These are kept, even though the membership is declined "as a token of your thoughtfulness" in making the offer. The rationals for retention is (1) to avoid a seeming play in the face by return of the entire package, and (2) the human interest value in the accumulation of such tokens.



Fund raising and commercial offers have been rejected on principle as inappropriate for the President, except as noted below.

H. Exceptions

A. Publis and Quasi Public Organizations

Presidents have traditionally consented to honorary titles and patrosage of official and quasi official organizations. Examples include the American National Red Cross, the United Fund, the United Nations Association, the Boy Scouts of America, and the like. A tradition of membership by past Presidents may sometimes be regarded as conferring a quasi-public character on an organization. For such organizations as the Red Cross and Boy Scouts, which have both national and local organizations, Presidential participation has been limited to the national organization.

B. Other Exceptions

An occasional exception is made because of associations that are personal to the incumbent President, such as his own membership in a golf club, or civic or professional affiliations pre-dating his Presidency and not inconsistent with the office. There may also be some personal or political interest or hometown associations that are distinguishable and can be dealt with on a case by case basis.

It is recommended that the same policies be followed by the members of your family.

III. Recommanded Disposition of Offers and Requests

We have accumulated offers received since you took office pending adoption of a general policy, except for a few that required immediate action. On the basis of the policies described above they have been divided into three general groups as follows:

- Tab A: Public and quasi-public organizations for which acceptance is recommended.
- Tab B: (1) Possible approvals as exceptions depending on guidance from you or a designated adviser.
 - (2) For consideration on the same basis, all Masonis offers have been segregated under this tab.
- Tab C: (1) Proposed rejections under the general policy.
 - (2) Proposed rejections subject to review in case an exception should be made for political reasons.

My recommendation would be that you authorize acceptance now for all organizations listed at Tab A. I believe the remainder should be reviewed by an adviser from a political standpoint under whatever general policy you direct in response to this memorandum. Any acceptance which may be thus recommended should be forwarded to the Counsel's office. Hereafter, I would propose that membership requests that cannot be handled by a routine letter of rejection be forwarded to the same person for political review, and then to the Counsel's office if acceptance is recommended.
