This memo is in response to the attached letter from Edward J. Frey which you referred to me for inquiry.

Normally, commercial attaches in our embassies collect information on foreign corporations which is channeled to the Office of Export Development at the Department of Commerce. American businessmen may obtain this information by contacting that office and requesting a World Traders Data Report on a particular foreign company. In Puerto Rico, however, there are no State Department facilities. Therefore, data reports are not available on Puerto Rican companies.

The Department of Commerce has a field office in Puerto Rico which collects some information on businesses, and I suggest that Mr. Frey make direct contact with that office.

There is no legal reason why we could not request such information from the Department of Commerce in behalf of Mr. Frey. However, I am concerned that a White House inquiry might appear to be favoritism. Also, Mr. Frey could undoubtedly obtain and evaluate this information more quickly than if we assist him.

If you agree, attached is a suggested response.

Thank you for your letter of April 29, 1975.

Normally, commercial attaches in our embassies overseas collect information on foreign businesses, and this information is made available to American businessmen through the Department of Commerce. However, because Puerto Rico is a commonwealth, the State Department does not maintain facilities there.

The Department of Commerce does have a field office in San Juan, and the information you are seeking, if it has been collected, would be available at that office. Dear Mr. Buchen:

I received a copy of your letter of July 26 to Charlie Potter concerning the problem of foreign payoffs by U. S. companies. He also wrote to me on this matter and I am enclosing a copy of my response.

There are so many aspects to this that have to be examined that judgments at this time would be premature. The securities and tax laws are involved and the antitrust laws may also have application when U. S. firms make payments to foreign government officials. Where specific U. S. statutes may have been violated, obviously the matter has to be left to the respective enforcement officials. In general, I would hope that the United States would not legislate in the area of purely private commercial conduct overseas but leave such cases to be resolved by the local authorities in accordance with local laws.

In view of recent disclosures and current interests, I suggest that this problem be brought up for discussion by the Economic Policy Board.

Dear Mr. Potter:

Thank you for your letter of July 22 concerning the reported practices of some U.S. companies overseas in paying commission fees or other benefits in return for concessions, services or contracts in foreign countries. I am glad to have your views on this important question.

The President spoke on this subject at his press conference Saturcay, July 12. In answering a question that dealt with payments made to secure business under a military sales contract, he said that legislation should prohibit such payments in the circumstances described. A number of agencies are now exploring the matter very carefully from the standpoint of determining whether the practices are compatible with various statutory provisions.

I agree that a prime consideration in weighing various alternative courses of action is preserving the ability of U.S. companies to compete in the affected foreign markets on an equal basis with other same pliers. It is also in our national best interest to seek the efficination of such payments as a long-term solution. However, the matter has many ramifications and will not be susceptible to easy solutions. Until the review of the problem which is now going on within the Electroment is complete it would be inappropriate for me to comment furtres.
