
Dear Mr. President:

Dear Sirs:

This is to commend you for your vote against Senate Bill #354 (national no fault).

I notice from the newspaper that President Ford has nominated a Louisville judge to replace Judge James F. Gordon for the United States District Court for the Western District of Kentucky. The majority of lawyers in West Kentucky favor the appointment of a lawyer from some county other than Jefferson. Federal judges wield tremendous power--so much power that they command lawyers from Paducah to travel a 440 mile round trip to Louisville for a 20 minute pretrial conference solely because the Louisville orientated judge did not want to travel to Paducah. Lawyers from Paducah, the deputy clerk from Paducah, and the deputy marshal have had to travel to Louisville because the federal judge did not want to come to Paducah to hold court. This was not one case but several cases. It is the feeling of the majority of West Kentucky lawyers that someone not so deeply rooted in Louisville would be more willing to travel to Paducah.
