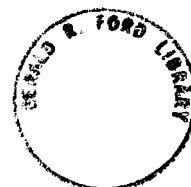
BACKGROUND: An annual White House reception for the Federal Judiciary was traditional for a number of years prior to 1965. In 1967 President Johnson had a reception for selected members. Since then the tradition has not been continued.

To return to this tradition would be a warm and friendly gesture, as well as an appropriate and much deserved tribute to the members of the Federal Judiciary.

Additionally, the National Conference on Citizenship has been scheduled for September 17 and 18, 1975 with a special ceremony at the National Archives on September 17, the only day the entire Constitution will be on display prior to our nation's 200th anniversary.

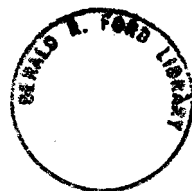
I have, at your recent suggestion, looked into the history of White House Receptions for the Federal Judiciary. Limited to oral reports, based on the memory of a few who are still around, I have been told the following:

1. Until 1965, it had been an annual "tradition" for the White House to hold a formal reception for the Federal Judiciary.

2. President Johnson held a reception or dinner, attended by some members of the Federal Judiciary, in 1967 or 1968.

3. Thus the tradition has apparently lain untouched, at least since 1968.

4. No one is quite sure as to what happened. Some think the guest list may have unduly expanded by 1965. That view may stem from President Johnson's limitation of the number invited.



If President Ford should elect to reinstate the tradition, there may be some concern regarding the size of the guest list; hence the enclosures.
