RE: State of the Union Survey

The possibility of doing a telephone poll converning the State of the Union have been raised at the Committee and by Gordon Strachan. The Attorney General is in agreement with doing such a poll if the data would be useful to you.

I would like to know if you would like such a poll done and if so, what items you would like included. If such a poll is done I think that it should be done on Monday and Tuesday after the weekend papers and the Democrats have had a chance to comment and should consist of 1,000 telephone interviews done by ORC similarly to those done for you in the past. The poll would cover:

the awareness of the address general impression most important/favorite points least favorite points reaction to specific proposals

I also think that it would be useful to measure Muskie's responst to the speech. This might be done by reading teh respondent the President's and Muskie's statements on several of the problems covered in the speech and asking which position they were most in agreement with.

If we do this poll we need to close the questionnaire by late Thrusday and would appreciate your reply by Thursday.
