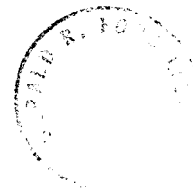


The purposes of the meetings are to elect officers and members, review the progress of the Alliance, and make determinations regarding its future policies.
