Dear Mr. President:

We are happy to cooperate in meeting the proposals you made in your address to Congress last night. You were right in asking the Joint Economic Committee for findings with respect to the just authorized inflation study within six weeks instead of six months. You will have a report including findings and recommendations by September 23.

This will be an interim report. We are sure you would agree that inflation is so complex and serious that the Committee should take at least the full time authorized by the Congress to make as far reaching and comprehensive and considered a study as possible.

We will make recommendations with respect to federal government spending and taxing, monetary policy and interest rates, antitrust policy, use of the authority and power of the federal government to win non-inflationary decisions with respect to prices and wages in the private sector, and American initiatives to lessen world inflationary pressures.

With respect to findings and recommendations in these areas and a number of others, the report will recommend action that can and should be taken at once by both the Congress and the Executive. The Committee will recommend additional action by the end of the year.
