MEMORANDUM FOR THE PRESIDENT

SUBJECT: Amendment of the Employment Act of 1946

With your strong emphasis on inflation as the number one national problem, I recommend that the Employment Act of 1946 be amended to make price stability an explicit goal of national economic policy. This could help to provide orientation for an anti-inflationary effort which is almost certainly going to be long and arduous.

When the Employment Act of 1946 was enacted, the principal concern was that reconversion from the World War II effort threatened severe recession and even depression. Consequently, the Employment Act declares that it is the policy and responsibility of the Federal Government "...to promote maximum employment, production, and purchasing power."

While it has been argued "that maximum purchasing power" implies price stability, with the problem of inflation so pressing, it would be appropriate at this time to make the Federal policy and responsibility much more explicit.

This can be done by adding to the declaration of policy the phrase "and to achieve and maintain price stability." Similar amendments to other sections of the Act to underline the emphasis on price stability would also be appropriate.
