BACKGROUND:

Governor Wilson will testify tomorrow before a hearing being conducted by the Senate-House Conference Committee on the Williams-Minish (S. 386) two-year mass transit operating subsidy bills.

The Governor, Senators Williams and Javits, and others are pushing very hard for this two-year bill as a means of providing immediate transit operating funds. They claim that a long-term bill (such as you support) is not possible this session and S. 386 is a means to provide temporary relief while the comprehensive transit bill is considered by Congress next year.

The S. 386 Conferees are likely to adopt compromise provisions such as the use of a formula to permit local/state decision on the operating-capital choice and substantial reduction in funding levels. This is an attempt to make the bill acceptable to you but any short-term operating subsidy bill may substantially reduce the chances for a comprehensive, long-term bill next year.
