John Flynt Recommends that Fletcher Thompson be appointed to the Board of Directors of the Legal Services Corporation. Matthew J. Rinaldo Says "I appreciate your acceding to my request to include my white paper on the economy into the record of your Economic Summit Conference." Enclosed his paper. Requests an appointment to discuss with the President Bill Chappell a program now functioning in DeLand, Fla., called the "Why I Love America" Program; would like the President to issue a proclamation in DeLand designating a "Why I Love America Week." Read with interest the front page story in the Star-News Joseph Karth reporting that tax cuts to help low-income workers cope with inflation are being considered seriously by the Administration. He introduced just such an amendment to the pending tax reform bill now before the Committee on Ways and Means; would be happy to meet with any of the President's advisors to discuss this plan. Urges the President to sign House Joint Resolution John Dingell 910, to establish National Hunting and Fishing Day as September 28. Edw Eshleman Sends in suggestion from an editor in his District that the President hold a press conference in Harrisburg with representatives of the press from newspapers, radio and television in cities in Pennsylvania, Maryland, and Delaware, and that the Washington press corps be excluded. AA to Thanks President for the invitation to the White House for Capitol Hill "staffers." He was most impressed Cong Bob Price with the warmth and relaxed atmosphere which the President departed.
