Job Vacancy Status Report and Discussions with Defeated Members

This memorandum is to advise you of the very limited number of current vacancies in positions above the GS-16 level, and to let you know of discussions we have had with defeated Members of Congress who have sought our assistance.

# 1. Vacancy Status

As you know, there are 560 full time executive level positions. Currently, 48 positions are vacant and are listed at Tab A. You will note that many of them are positions requiring specialized professional experience and defeated Members would not, in most cases, be well qualified candidates. Moreover, 12 of these vacancies are accounted for by two new agencies, the Commodity Futures Trading Corporation (5) and the Energy Research and Development Administration (7). That leaves a balance of 36 Executive Level positions currently vacant elsewhere in government.

There are, in addition, approximately 600 non-career supergrade positions. Currently, there are only 24 vacancies in this category. Some of them also require specialized qualifications.

There are virtually no vacancies in the Ambassadorial ranks at the present time, though some of your nominees have not yet been announced.

Aside from concern about placing defeated Members, these figures suggest several other observations. First, there are only a handful of jobs available. This makes it difficult to be expansive about being able to place people quickly. Second, should you decide to make some Cabinet changes, many more positions will open up, both at the Executive Level and among the super-grades. This approach proceeds "from the top down" and is probably a more orderly procedure from a management standpoint. Alternatively, however, there may be incumbents now occupying positions who could be removed on a "rifle shot" basis. more awkward, since most of the incumbents were selected with the approval of your current Cabinet and agency heads. However, if you wish a proposal for making selected changes on this "rifle shot" basis, we can do so. Yes ; No

For your information, I have also attached at Tab B a listing of these Executive Level and super-grade positions which are currently in the process of being filled and where candidates have either been selected and are in clearance or are in final staffing and will be presented to you shortly. The list also includes a few positions which particular agencies or Departments do not want filled. This list comprises 20 Executive Level positions and 31 super-grades.

#### 2. Contacts with Defeated Members

Attached at Tab C is a status report on efforts being made on behalf of defeated Members of Congress who have contacted Congressional Relations or my office for assistance (not all have done so). All of the House Members have been contacted either by me or a member of my staff and in virtually all cases, we have put them directly in touch with one or more agencies and Departments to discuss positions. While almost no final placements have been effected, we are optimistic about being able to reach a successful conclusion soon in many of the cases.

Status of Congressional Personnel Requests

The following is a list of defeated or retiring Members of the House and Senate who have approached us with regard to Federal Employment. I or a member of my staff have been in touch with each of the House Members listed below.

#### SENATE

- Senator Marlow Cook has a meeting scheduled with you.
   He is interested in a Federal Judgeship.
- 2. Senator Peter Dominick is interested in an Ambassadorship --we are working with the State Department on this.
- 3. Senator Wallace Bennett would like to serve on a parttime Board or Commission dealing with financial matters. We will be able to work this out. Membership on the Advisory Commission on Intergovernmental Relations was discussed with him, but he declined.

#### HOUSE

1. Congressman Les Arends was interested in serving on the Federal Elections Commission; however, the Commission will be a full time position and he would have to delay his Congressional pension. Since he does not want to do this, we plan to propose him for membership on the Pennsylvania Avenue Development Commission.

- 2. Congressman Lamar Baker wished to be considered for Director of the National Parks Service. Secretary Morton has informed him that this position will be filled by a career member of the Parks Service. Baker is being offered the position of Deputy Assistant Secretary for Congressional Relations at the Department of Transportation.
- 3. Congressman William Bray is under consideration for a position on the American Battle Monuments Commission. If a vacancy cannot be created there, he will be appointed to the Board of the Armed Forces Museum.
- 4. Congressman Don Brotzman is under consideration for a Judgeship on the Court of Military Appeals. He is considering whether he wants to pursue this.
- 5. Congressman John Dellenback is being considered for an Ambassadorship in Africa by the State Department.
- 6. Congressman David Dennis has declined to pursue the possibility of a District Judgeship in Northern Indiana with the Department of Justice. He has indicated that he will practice law.
- 7. Congressman Bob Hanrahan is to get back to me if he is interested in pursuing a Regional position in Chicago or in some other appropriate position.
- 8. Congressman Dan Kuykendall has been employed as a Consultant to the Secretary of Transportation.
- 9. Congressman Richard Mallary is interested in serving either as a Staff Member of the Domestic Council or in a position at the Department of Interior.
- 10. Congressman Dave Martin is interested in a part time Board or Commission. We will be able to handle this.
- 11. Congressman Stan Parris is interested in being U.S. Attorney in Northern Virginia. Justice is contacting him.
- 12. Congressman Bob Price has talked to my office, Secretary Butz and Donald Rumsfeld. He wishes to be Secretary of Agriculture or serve in another important post. Nothing we currently have available interests him.

- 13. Congressman Bill Scherle wished to be Regional Director of GSA. The Civil Service Commission has ruled that will be a career position. He is also talking to the Department of Agriculture and to the Veterans Administration.
- 14. Congressman Dick Shoup is interested in serving as an ICC Commissioner. We have another candidate in clearance. We are discussing other possibilities with him.
- 15. Congressman David Towell is interested in working for the Department of Interior. We are trying to work something out.
- 16. Congressman Lawrence Williams has met with a number of people in the Administration. We are having trouble locating a position.
- 17. Congressman Roger Zion is interested in a consultancy in the energy area. We are trying to work something out with Interior or FEA.
