- 1. Howard, Tom Korologos informs me that you felt it essential we discuss strip mining immediately, and I wanted to fulfill that request.
- 2. I have anguished over my decision in this matter and in all good conscience I am compelled to (pocket?) veto the bill. I appreciate your interest but I am sure you will understand this is an exercise of my responsibility which, though very difficult, leaves me no alternative.

Dear Mr. President:

I thank you for including us in the Christmas party last evening. I believe it was the best White House party I ever attended.

During the course of the evening I had the opportunity to discuss with Secretary Rogers Morton the recently passed Strip Mine Bill. He indicated that he thought it would not be amiss for me to write you and to urge you again to sign the bill instead of vetoing it, notwithstanding your previous public statement on the subject. Both Secretary Morton and Administrator Train have, I believe, indicated a similar point of view to you.

I hope you will reconsider your previous statement with respect to the bill and sign it. I think the stiff environmental restrictions of the bill are necessary. I believe the price impact will be less than 10 percent, and possibly nonexistent in view of the present level of coal prices in this country. I believe that such a Federal law would remove the uncertainty from this field and encourage new production by environmentally acceptable techniques.

I strongly urge you to sign the bill into law.
