Jim, attached is your Hebert Library Ground-Breaking Ceremony in New Orleans schedule proposal.

We want tentatively to accept. But before we sign off on it, I need a memo back today laying out some alternative proposals. We do not want to go down just for the Navy League and the Ground-Breaking Ceremony.

I'd like to consider also a media breakfast or luncheon and a regional press conference so that we would have a full day's activities.

SUBJECT: Congressman Eddie Hebert (D-La.)

Congressman Hebert continues to press for a Presidential visit to New Orleans in late April for a ground breaking of the Hebert Library and a luncheon address before the National Convention of the Navy League.

We have tried to turn this off in several conversations with Congressman Hebert, but he has now pinned us down to a new date of April 23, recommending the President leave Washington early that morning for a 10:00 a.m. ground breaking followed by the luncheon address with a return to Washington at 2:00 p.m.

I have explained to Hebert that the President has out of town trips on the 17th and 18th of April and also the 25th plus heavy commitments here during the intervening days, but he insists we try again for the 23rd.

If you deem necessary we will, of course, turn this off completely, but because of Hebert's personal, close relationship with the President and importance to us on the Elk Hills and other Armed Service matters, I would want you to take one last look at the Congressman's request.
