The President's Pool

Work has begun on an outdoor, heated swimming pool on the White House grounds, near the President's Oval Office.

Reports around Washington are that some of the President's advisers strongly opposed constructing the pool at a time when he has called for a tight rein on spending.

But the President decided to ignore that advice, and he was perfectly right in doing so.

The pool is being built with woluntary contributions, as was President Franklin D. Roosevelt's in 1933, which was covered over to make room for the new White House press center during the Nixon administration.

President Ford, a ruggedly athletic man, for years has taken two swims a day — in the morning before going to work and in the evening after coming home.

Since entering the White House, he has tried to get his necessary exercise on the golf course from time to time, and by using a stationary bicycle. But neither really fills the bill.

So it's good that the President will have his pool and his twice-daily workout in it. After all, since it will be within a step or two of his office, those regular exercise peiods will take a lot less of his time than a round of golf and the miles of travel to the first tee.

Just stay afloat, Mr. President!
