Helen Bentley, Chairman, Federal Maritime Administration, has submitted her resignation, which is attached hereto. I feel confident that she is of the opinion that she was treated quite well by our office, but feels that the pressures created by the stories being circulated by her former Executive Assistant, and by other staff members, make it imperative that she resign. In particular, she is concerned by a current investigation of Jack Anderson.

Senator Inouye, whom she considers to be a friend, has specifically advised her to resign.

She did concede this morning that she has acted foolishly in a couple of matters over the years that could prove particularly damaging to her. She has a good executive job in the maritime industry which she will take as of July 1st.

She has, of course, asked that we protect her against any rumors that circulate following the announcement of her resignation. Since the FBI check has recently cleared her of any criminal wrongdoing, and since she has no active file in the Special Prosecutor's office, I see no reason why we cannot strongly state that the resignation is of her own volition and is regretted by the President.

I do believe that it would be wise for us to act quickly in accepting her recommendation, effective as of July 1st.

Doug Bennett is staffing the matter now as to who should be appointed Acting Chairman. Presumably he will suggest that Vice Chairman Day be so designated.

Mrs. Bentley has suggested that Day be made permanent Chairman, but I think it apparent that the Personnel Office will not recommend such action.
