I. BACKGROUND, PARTICIPANTS & PRESS PLAN

1. Background:

You last met with the Cabinet on June 25th when the agenda covered a discussion of affirmative action, a review of the crime message, presentations on the legislative clearance process and the refugee resettlement program, and a review of the railroad situation.

II. TALKING POINTS

1. This is Pat Moynihan's first meeting in his new position as U. S. Representative to the United Nations. I know you all join me in welcoming him, and we all look forward to working with him.
2. Stan Hathaway went into the Bethesda Naval Hospital last night for tests and observation. We don't know yet how long he will be there, but for the time being Kent Frizzell will serve as Acting Secretary of the Interior.

3. Before we start on the agenda, I want to comment on some of the changes that have taken place in the refugee program.

As most of you know, responsibility for the program has been transferred from the State Department to HEW. Everyone should realize that this transfer has occurred simply because most of the refugees are now here in the United States. It does not signal a lower priority, and no one should take this as an occasion for pulling back their people who have been working on the refugee task force. Those people from various departments and agencies such as State and Defense need to stay in place until the task force director has been satisfied that the work has been done.

OMB has been working with the task force for the past three weeks on a full management plan for the resettlement effort, including identification of added personnel that may be required. In the next few days your departments and agencies will be asked to provide a few more people. I will expect you to respond promptly and fully.

4. Last week I met with the Commissioners of the Independent Regulatory Agencies on regulatory reform. Several of you were at the meeting, but several were not. I would like to ask Jim Cannon and Rod Hills who worked on that effort to review that meeting for us.

Rod,...

I am sure all of you realize that reform is not restricted only to the Regulatory Agencies. We have had discussions before about the problems of Agency and Departmental regulations, and you all know my feelings on that issue. I would like each of you who have regulatory responsibilities to focus on five areas.

- 1) Review your major programs to insure that the benefits are worth the costs, and continue your efforts to make the inflation impact effort a success.
- 2) Minimize regulatory delays.
- 3) Continue your efforts to be more responsive to legitimate consumer interests.

4) Identify areas where regulation no longer makes sense and recommend changes to me.

5) Assist the independent agencies to do a better job.

The Domestic Council Review Group on Regulatory Reform will coordinate this effort. Within the next two weeks the heads of major Executive Departments and Agencies will be called together to select jointly specific objectives for reform. We intend first to look at EPA, FEA, Agriculture, HEW, Labor and Transportation.

I want you to give this effort your maximum support. I want an interim report by October and a completed effort by the end of the year. I intend to show the American people in my next State of the Union Address that we have concrete results in this area.

5. Jack Marsh has indicated to me that there have been some problems in the Congressional mail area. From my own years of experience, I can tell you how important it is that Congressional mail be answered promptly, accurately and politely. Jack has set up some new procedures here, and I would like him to describe them to you.

6. You have all been reading some press reports about activities in Berbera in Somalia. I have asked Jim Schlesinger to brief us on what has been happening there.

7. This week we have taken some steps in the energy area, and I am sure that during the course of the rest of the month you will be hearing much more about the subject. I would like Frank Zarb to brief us on the status of the energy program now.


