SUBJECT: Wilderotter's Request through Jim Connor for authorization to release Intelligence Community Post-Mortum Studies to the Church Committee

You will remember we discussed previously the post-mortum reports in the Middle East, Cyprus and the Indian Nuclear Test. At that time the report on Mayaguez had not been completed. We decided to hold all of the reports until Colby could complete work on the Mayaguez analysis.

1. I would strongly recommend that you call Colby to urge him to complete the analysis as soon as possible.
2. That we not send any reports to the Church Committee until they are all ready to go as a package.

Marsh has some background on this subject and should be consulted before providing anything to the Hill. Scowcroft's office physically has possession of three of the studies.

If pushed, I believe you could provide the studies on the Middle East, Cyprus and the Indian Nuclear Test and simply explain that the Mayaguez analysis will be provided as soon as it's completed.

I received a request today from Jim Wilderotter who indicated that there were post-mortems on intelligence community activities which the Church Committee is requesting. The studies are: Mayaguez, the Middle East, Cyprus, and the Indian Nuclear Detonation.

Wilderotter indicates that you have the studies and are the one who can release them for the Committee.

Marsh informs me that the Mayaguez study was not, the last time he saw it, in the proper form and that you had directed that CIA revise it according to the format of the other three studies.
