Dear Mr. President:

You will recall that during my last visit to the White House, when we were in the Rose Garden, you informed me that you planned to be in Cleveland at the National Conference of Christians and Jews on June 6th to honor your former colleague in Congress, the Honorable Frances P. Bolton, who will be given the annual Human Relations Award that day.

You also informed me that you were sending a personal note through your scheduling staff explaining your desire to be in Cleveland on that date to honor Mrs. Bolton.

Mr. President, I am aware that advance men have been in Cleveland making the necessary arrangements for security in the event that such a trip can be placed on your schedule.

I realize that your campaign staff is concerned at this time about the limitations of expenditures in your primary campaign, but hope that a financial accounting will permit a visit to Cleveland on June 6.

This large gathering of Clevelanders of all faiths and all political persuasions will honor one of the greatest women our country has had in public life.

Your presence, Mr. President, will honor Cleveland and reflect the high esteem you have for Mrs. Bolton who shared so many years with you in Washington.

Dear Mr. President:

I deeply regret that I cannot be among my fellow Republican Mayors to join with you in celebrating your resounding victories Tuesday. However, Mr. President, no one is more aware than you that local obligations and commitments must be met by those elected to serve their constituencies.

I am happy, though, that I have such a distinguished Republican as Mr. Robert E. Hughes, Chairman of the Cuyahoga County Republican Organization, to attend this gathering and personally relay my regrets and congratulations.
