#### I. PURPOSE

To attempt to persuade Mr. Wagner to support the President

### II. BACKGROUND, PARTICIPANTS, AND PRESS PLAN

A. <u>Background</u>: Mr. Wagner sells life insurance for Guardian Life Insurance Company. He is 33, married and has 2 children. He is a member of the Republican State Central Committee of Louisiana; ran for State Representative; has been active in many campaigns; and is a Fellow; Institute of Politics (Loyola). He is also very active in civic affairs.

He is interested in a Right to Life plank in the Platform. He may wish to discuss the Vice Presidential selection. Other uncommitted Louisiana delegates have indicated they will wait until the Democrats choose a Vice President.

Mr. Wagner was elected as an uncommitted. In a difficult contest in Louisiana "uncommitted" was a code word for anti-Reagan. Wagner apparently leans to the President. He will probably run for the Louisiana State Legislature in the next election but currently is helping Bob Livingston, a Reagan delegate, who is running for Eddie Hebert's Congressional seat and with whom the President met in late June.
