Dear Dr. Allen:

This is in response to your letter regarding the closing of Frankford Arsenal in Philadelphia.

The proposal which you mention was submitted by the Philadelphia Congressional Delegation through the Chairman of the House Armed Services Committee to the Secretary of the Army. The initial proposal received on February 9, 1976, suggested retaining fire control and optical missions at Frankford Arsenal. This was refined in another proposal forwarded by Chairman Price on March 31, 1976. This latter proposal would have established the Small Caliber Weapons Systems Laboratory of the Armament Research and Development Command at Frankford Arsenal instead of collocating this activity at Picatinny Arsenal, New Jersey, with the headquarters and Large Caliber Weapons Systems Laboratory as had been announced in the decision by the Secretary of the Army.


The Army conducted a thorough and complete review of the Philadelphia Delegation's proposal. The Secretary of the Army provided the results of that review to Chairman Price and to the Philadelphia Delegation on June 4, 1976. The attached document provides the details of the Army's evaluation.

Previous extensive Army studies and the review of the Philadelphia Delegation's proposal conclude that for managerial, operational and economic reasons the realignment of the Army's armament research and

development activities and the closure of Frankford Arsenal should proceed. The attached evaluation points out that the location of the Small Caliber Weapons Systems Laboratory at Frankford Arsenal would negate several important managerial and operational advantages gained by collocating this laboratory with other elements at Picatinny Arsenal. In addition, the relatively small, geographically separated facility would result in proportionately higher overhead costs than will the consolidated operation. The estimated annual operating cost would be approximately \$10 million greater for the Philadelphia Delegation's proposal than in the announced realignment.

While I fully appreciate your concern regarding this matter, I believe that the Army's decision in this matter is appropriate and is consistent with the overall goal of providing the most effective national defense at the least cost to the taxpayer.

Dear Mr. President:

We hereby request your ruling on the current status of the Frankford Arsenal, located in Philadelphia, Pennsylvania.

You undoubtedly know of the scheduled closing of the Arsenal within the coming year. However, a proposal has been submitted that could allow the location of the "Small Calibre Weapons Systems" laboratory in the existing buildings on the site of the Arsenal. I believe Senator Hugh Scott has been a proponent of this approach.

Such a location would be geographically ideal, as Philadelphia is the focus of the current arsenals at Watervliet, Picatinny, and A.P.G./Edgewood.

It seems far more feasible to the citizens of Philadelphia to relocate the 240 employees from Rockville and the 3 employees from Picatinny to Philadelphia, than to carry out the current plan to relocate all 1600 Frankford Arsenal employees, a move that would most likely necessitate military construction appropriations.

This is a matter of grave concern to me and to my constituents, and I would appreciate your immediate evaluation of the situation and a written report of efforts on behalf of the Frankford Arsenal and its 1600 employees.
