Director Sam Martinez of the Community Services Administration has put together an internal reorganization plan for his agency. The plan requests 1,196 positions, an increase of 236 over CSA's authorized full-time permanent strength of 960. Your 1977 Budget would have reduced this level to 900.

My staff has analyzed his plan and come to the conclusion that given the workload and proper management, the CSA functions could be carried out essentially with the staff on board today if CSA were completely reorganized and the positions reallocated to meet a proper headquarters/regional balance and skill requirements.

As you undoubtedly know, Martinez has a very difficult management job on his hands if the agency is to be focused, clearly directed, and efficiently organized. In particular, the agency probably has the strongest, most vocal and defensive union organization in the Federal Government.

Whatever actions are taken at CSA will be picked up by the media shortly thereafter, so that I would normally suggest delaying making any move for a few months to avoid this getting mixed up with unrelated issues. However, Congress and the press are both well aware that CSA has been promising reorganization for the last year and a half. Martinez was confirmed in April with the expectation that he would undertake a reorganization shortly. Not to act now could cause more problems than acting.

I propose to allow Martinez to increase his personnel by 100 positions over the 1976 level to give him the flexibility and "running room" so that he can impose proper management on

the organization. These additional positions will not increase 1977 outlays since the cost of these positions can be absorbed. Even though we have been unsuccessful in holding down CSA appropriations to your requested level in the past, I believe it is important that the CSA be well managed so that the funds are properly spent.

We will be criticized on the left for not giving CSA all the positions requested, and on the right for expanding the agency at all. I believe we have a sound argument that what we are doing is establishing an effective managerial organization under your general prescription for tight management of departments and agencies. In this case, the total budget for CSA is over a half billion dollars.

I recommend that we proceed as described above.
