Report to the President on Regulatory Reform

#### Issue

For the past several months the Domestic Council Review Group on Regulatory Reform (DCRG) has been preparing a report on its observations and findings regarding regulatory reform. This report entitled "The Challenge of Regulatory Reform" is intended to provide a summary of the regulatory problem, the progress achieved by the Ford Administration and the future directions which this important issue might follow.

We are recommending this report be printed for public distribution. We believe that it will help establish regulatory reform as a central issue of public concern in the years ahead and increase public respect for the important accomplishments that have been achieved in the last two and a half years.

We are seeking your decision on whether to make this report public and if so, what your participation, if any, would be in its release.
