Discussion

The USTS and its program were established in 1961 in the Department of Commerce for the purpose of encouraging foreigners to visit this country, and funds for this program are currently authorized through fiscal year 1976. The domestic tourism program originated in the Interior Department (National Park Service) in 1940: beginning in fiscal year 1971 the President's Budget has not included a request for that program, the authority for which was transferred to Commerce in December 1973 by P.L. 93-193. S. 2003 would authorize appropriations to USTS for its international tourism program of \$5 million for the July-September 1976 transition quarter, \$25 million for fiscal year 1977, and \$30 million for each of the fiscal years 1978 and 1979. The bill would also authorize appropriations to reinstitute a domestic tourism program of \$2.5 million for fiscal year 1976, \$625,000 for the transition quarter and \$2.5 million for each of the fiscal years 1977 and 1978. These levels are based on an integrated marketing plan developed for Commerce in 1972 by a management consultant firm.

On March 14, 1975, the Director of this Office sent an option paper to you to determine the Administration's position on the future of both the international and domestic tourism programs. In a letter of March 31, 1975, the Director informed Acting Secretary of Commerce Tabor, that you had decided to "seek a three-year extension of the International Travel Act of 1961 at a \$15 million authorization level" per year, and to "oppose the initiation of a domestic tourism program..." The Director also stated that you had "decided that there was not a national problem or need that would warrant such a new Federal program."

The enrolled bill is basically identical to H.R. 5357 which you vetoed on May 28, 1975. At that time, you indicated that the promotion and management of domestic tourism should remain the responsibility of both the private sector and of State and local governments. However, the Congress has recognized your concerns by incorporation of Section 5(b) in the enrolled bill which states that the Secretary of Commerce shall support only those domestic tourism programs "which are in the public interest and which do not compete with activities of any State, city or private agency." A review of any proposed programs and of your budget will be made to determine which activities, if any, would be consistent with language of the enrolled bill and your budget.

Despite the retention of features which the Administration has opposed, we do not find the enrolled bill sufficiently objectionable to recommend disapproval (especially in view of the compromise worked out with the Congress). We have attached a signing statement for your consideration. We believe that such a signing statement is desirable in order to provide a rationale for your recommended approval of the current enrolled bill in light of your disapproval of the similar enrolled bill, H.R. 5357.

"To amend the International Travel Act of 1961 to authorize additional appropriations, and for other purposes."

The enrolled enactment would authorize appropriations of not to exceed \$2.5 million for each of the fiscal years 1976, 1977, and 1978, and \$625,600 for the transition period between fiscal years 1976 and 1977 for domestic tourism; and \$5 million for the transition period, \$25 million for fiscal year 1977, and \$30 million for each of fiscal years 1978 and 1979 for international travel activities of the Department of Commerce. In addition, the enrolled enactment amends section 1 of the Act of July 19, 1940 (16 U.S.C. 18) so as to provide that any domestic tourism activities undertaken by the United States Travel Service must be in the public interest and not compete with activities of any State, city, or private agency.

The enrolled enactment is substantially the same as H.R. 5357, a bill which was vetoed on May 28, 1975, the only difference being the addition of the amendment to section 1 of the Act of July 19, 1940 noted above. However, we understand that the language of **S**. 2003 is now acceptable to the Administration, as a result of a compromise which was agreed to by the Congress and the President, and, accordingly, we recommend approval by the President of **S**. 2003.



Enactment of this legislation would authorize the appropriation of funds for the United States Travel Service beyond the amounts now authorized by law as indicated above.

Reference is made to your request for the views of this Department on the enrolled enactment of S. 2003, "To amend the International Travel Act of 1961 to authorize additional appropriations, and for other purposes."

The enrolled enactment extends for three years authorization of appropriations to carry out the provisions of the International Travel Act of 1961, as amended, relating to the promotion of foreign tourism in the United States. It authorizes appropriations not to exceed \$5 million for the transition period of July 1, 1976 through September 30, 1976 and appropriations not to exceed \$25 million, \$30 million, and \$30 million for fiscal years 1977, 1978, and 1979, respectively. The enrolled enactment also authorizes funding for domestic tourism promotion at the levels of \$2.5 million for the 1976 fiscal year, \$625,000 for the July-September 1976 transition period, and \$2.5 million for the 1977 and 1978 fiscal years. Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the first sentence of section 6 of the International Travel Act of 1961 (22 U.S.C. 2126) is amended by striking out "and" immediately before "(3)" and by inserting immediately before the period at the end thereof the following: "; (4) \$5,000,000 for the transition period of July 1, 1976, through September 30, 1976; (5) \$25,000,000 for the fiscal year ending September 30, 1977; (6) \$30,000,000 for the fiscal year ending September 30, 1978; and (7) \$30,000,000 for the fiscal year ending September 30, 1979". SEC. 2. (a) Section 5 of the Act entitled "An Act to encourage

SEC. 2. (a) Section 5 of the Act entitled "An Act to encourage travel in the United States, and for other purposes", approved July 19, 1940 (16 U.S.C. 18d), is amended to read as follows:

"SEC. 5. For the purpose of carrying out the provisions of this Act, there are authorized to be appropriated not to exceed \$2,500,000 for the fiscal year ending June 30, 1976; \$625,000 for the transition period of July 1, 1976, through September 30, 1976; \$2,500,000 for the fiscal year ending September 30, 1977, and \$2,500,000 for the fiscal year ending September 30, 1978.".

(b) The first section of such Act of July 19, 1940 (16 U.S.C. 18) is amended to read as follows: "That the Secretary of Commerce shall encourage, promote, and develop travel within the United States, including any Commonwealth, territory, and possession thereof, through activities which are in the public interest and which do not compete with activities of any State, city, or private agency.".

Distinguished Members of Congress, Members of the Executive Branch, and guests, those interested in travel and tourism:

Let me say it is a great privilege and pleasure to participate in the signing of this authorization for the travel service.

We did have some differences but I think with some air of responsibility and degree of cooperation we have come up with a good piece of legislation. It provides for the travel service, in the one instance, of \$90 million, running from July 1, 1976 to September 30, 1979. That is the program where we try to convince people in other countries to come to the United States in order to enjoy our people and the beauty of America.

The other part of the program, which also runs from July 1, 1976 to September 30, 1978, a total of about \$8,125,000, is a program aimed at getting the American people to enjoy the beauties of their own country and to get better acquainted with their fellow Americans.

Both programs, in my judgment, are worthy of support. The Department, the Executive Branch does have more flexibility in the new provision, which I can assure you will be judiciously and properly used.

I want to thank the Members of the Congress who participated in the reconciliation of differences, and I certainly wish to indicate to them that we will use this authority and handle this legislation and funding to the best advantage of the tourism program in the United States.

With that, I will thank them all again and sign the bill.
