





The Committee on the Judiciary, to which was referred the bill (S. 240), to amend the Act entitled "An Act granting a charter to the General Federation of Women's Clubs," having considered the same, reports favorably thereon without amendment and recommends that the bill do pass. PURPOSE

The purpose of the bill is to compensate for the changing value of the three buildings of the General Federation of Women's Clubs. It is necessary to again petition Congress for an amendment because of the inflationary spiral; the value of the property has again exceeded the amount designated by the charter. In view of the fact that this seems to be recurring problem involving

the same properties, it has been proposed that the monetary figure be deleted and that the real or personal property be determined by the current market value therein. STATEMENT

The General Federation of Women's Clubs is incorporated under a special charter granted by the Congress of the United States March 3, 1901, and any amendment of that charter requires an Act of Congress.

Founded in 1890, the General Federation is the largest organization of women in the world with a membership in excess of 10 million members in thousands of clubs and associate organizations throughout the United States and abroad.

The object of the General Federation is to bring into communication and to unite the women's clubs and like organizations throughout the world for the purpose of mutual benefit and for the promotion of their common interest in educational, industrial, philanthropic, literary,

artistic, and scientific culture as interpreted and implemented by established policy. Membership in the General Federation consists of women's clubs and organizations whose work and purpose are germane to the objectives of the General Federation. The real and personal estate of the General Federation consists primarily of three adjacent buildings in Washington, D.C.: 1734 N Street NW., purchased in 1922; 1738 N Street NW., purchased in 1951; and 1728 N Street NW., purchased in 1959. The main building at 1734 N Street NW. is a handsome five-story residence originally built in 1875 by Admiral William Radford. REPORT

[To accompany S. 240]

The Committee on the Judiciary, to whom was referred the bill (S. 240) to amend the Act entitled "An Act granting a charter to the General Federation of Women's Clubs" having considered the same, report favorably thereon with amendment and recommend that the bill as amended do pass. The amendment is as follows:

Page 2, after line 6, insert:

SEC. 2. Section 1 of Public Law 88-504 (78 Stat. 635; 36 U.S.C. 1101) is amended by adding a new item 49, as follows: "(49) General Federation of Women's Clubs."

PURPOSE

The purpose of the proposed legislation, as amended, is to delete the existing monetary limit on the value of corporate property in the incorporation statute of the General Federation of Women's Clubs so

that its property will not be subject to such a limit. The amended bill also provides that the General Federation of Women's Clubs will be added to the list of private corporations established under Federal law as contained in Public Law 88-504 so that the corporation will be subject to the requirements of that law concerning an annual audit and a report of that audit to the Congress.

STATEMENT

The General Federation of Women's Clubs is incorporated under an incorporation statute passed by the Congress and approved March 3, 1901.

Founded in 1890, the General Federation is the largest organization of women in the world with a membership in excess of 10 million members in thousands of clubs and associate organizations throughout the United States and abroad.

The object of the General Federation, as stated in its charter, is to bring into communication and to unite the women's clubs and like organizations throughout the world for the purpose of mutual benefit and for the promotion of their common interest in educational, industrial, philanthropic, literary, artistic, and policy. Membership in the General Federation consists of women's clubs and organizations whose work and purpose are germane to the objectives of the General Federation. In view of the fact that this has been a recurring problem involving the same properties, it is provided that the monetary figure be deleted and that the corporation be permitted to hold, manage and dispose of corporate property as provided in its charter in accordance with the purpose of its incorporation.

The committee amendment to the bill adds a new section 2 to the bill amending section 1 of Public Law 88-504 (78 Stat. 635; 36 U.S.C. 1101) to add a new item (49) providing-

"(49) General Federation of Women's Clubs".

This adds the General Federation of Women's Clubs to the list of similar organizations contained in Public Law 88-504 and thereby makes the corporation subject to the requirements of having an annual audit and making a report of that audit to the Congress as provided

in sections 2 and 3 of that same law. Public Law 88-504 originated as a bill before this committee and embodies the policy that such federal corporations should be subject to those requirements.

The committee recommends that the amended bill be considered favorably.

SEC. 2. The accounts of private corporations established under Federal law shall be audited annually in accordance with generally accepted auditing standards by independent certified public accountants or independent licensed public accountants, certified or licensed by a regulatory authority of a State or other political subdivision of the United States. The audits shall be conducted at the place or places where the accounts of the corporations are normally kept. All books, accounts, financial records, reports, files, and all other papers, things, or property belonging to or in use by the corporations and necessary to facilitate the audits shall be made available to the person or persons conducting the audits; and full facilities for verifying transactions with the balances or securities held by depositories, fiscal agents, and custodians shall be afforded to such person or persons.

SEC. 3. The report of each such independent audit shall be submitted to the Congress not later than six months following the close of the fiscal year for which the audit was made. The report shall set forth the scope of the audit and include such statements as are necessary to present fairly the corporation's assets and liabilities, surplus or deficit with an analysis of the changes therein during the year, supplemented in reasonable detail by a statement of the corporation's income and expenses during the year including the results of any trading, manufacturing, publishing, or other commercial-type endeavor carried on by the corporation, together with the independent auditor's opinion of those statements. The report shall not be printed as a public document, except as part of proceedings authorized to be printed under the Act of March 2, 1931, chapter 378, section 1, as amended.
