This responds to your request for the views of the Postal Service with respect to the enrolled bill:

H.R. 14503, "To name the new post office in Youngstown, Ohio, the "Michael J. Kirwan Post Office."

1. Purpose of Legislation as it pertains to the Postal Service.

The bill requires that the building being constructed by the Postal Service at 99 S. Walnut Street, in Youngstown, Ohio, be known and designated as the "Michael J. Kirwan Post Office".

2. Position of the Postal Service.

Postal regulations provide that a post office should bear the official name of the incorporated city, town or borough in which it is located. 39 CFR 242.1(b). This legislation would not, in our opinion, prevent the Postal Service from placing its normal sign on the Youngstown, Ohio, post office building, while, at the same time, it affixes a plaque to the building noting dedication of the building to Michael J. Kirwan. Accordingly, we have no objection to enactment of this bill.

3. Timing.

We have no recommendation regarding the timing of Presidential action on this measure.

4. Cost or Savings.

We have no estimate as to the cost or savings of this measure for the Postal Service.

5. Recommendation of  
    Presidential Action.

The Postal Service recommends that the President approve this measure.

**REPORT**

[To accompany H.R. 14503]

The Committee on Public Works and Transportation, to whom was referred the bill (H.R. 14503) to name the new post office in Youngstown, Ohio, the "Michael J. Kirwan Post Office", having considered the same, report favorably thereon without amendment and recommend that the bill do pass.

Congressman Michael J. Kirwan was born in Wilkes-Barre, Pennsylvania on December 2, 1886. He was educated in the public schools of Wilkes-Barre and moved to Youngstown, Ohio, in 1907. He served with distinction as a Sergeant in the 348th Machine Gun Company during World War I. Following his military service Mike Kirwan was engaged in commercial enterprise during the 1930's.

Congressman Kirwan was elected to Congress in 1936 and served until his death on July 7, 1970. As Chairman of the Subcommittee on Appropriations for Public Works, he served not only the State of Ohio but the entire country in helping to build America and to provide for numerous water resources, navigation and interstate road programs. In view of his long and distinguished career as a public servant, it is fitting and proper to name the Post Office in Youngstown, Ohio, in his honor.

**COSTS OF THE LEGISLATION**

COMPLIANCE WITH CLAUSE 2(1) OF RULE XI OF THE RULES OF THE HOUSE OF REPRESENTATIVES

(1) With reference to clause 2(1)(3)(A) of rule XI of the Rules of the House of Representatives, no separate hearings were held on the subject matter of this legislation by the Subcommittee on Investigations and Review. However, the Subcommittee on Public Buildings and Grounds held hearings on this subject matter which resulted in the reported bill.

(2) With respect to clause 2(1)(3)(B) of rule XI of the Rules of the House of Representatives the bill, as reported, does not provide new budget authority or increased tax expenditures. Accordingly, a statement pursuant to section 308(a) of the Congressional Budget Act is not required.

(3) With reference to clause 2(1)(3)(C) of rule XI of the Rules of the House of Representatives, the committee has not received an estimate and comparison prepared by the Director of the Congressional Budget Office under section 403 of the Congressional Budget Act.

(4) With reference to clause 2(1)(3)(D) of rule XI of the Rules of the House of Representatives, the Committee has not received a report for the Committee on Government Operations pertaining to this subject matter.

(5) With reference to clause 2(1)(4) of rule XI of the Rules of the House of Representatives, H.R. 14503, as reported, will not affect prices and costs since it does not authorize additional funds. Therefore, H.R. 14503, as reported, would not have an inflationary impact on the national economy.

## An Act

*Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That the building being constructed by the United States Postal Service at 99 South Walnut Street, in Youngstown, Ohio, shall be known and designated as the "Michael J. Kirwan Post Office". Any reference in any law, map, regulation, document, record, or other paper of the United States to such building shall be considered to be a reference to the Michael J. Kirwan Post Office.*
