#### STATEMENT BY DR. WILLIAM M. LUKASH

Mrs. Betty Ford has just completed five weeks of convalescence following surgery for breast cancer. During this period, special diagnostic studies and physical examinations have not identified any clinical evidence of residual cancer. Because two of the 30 lymph glands removed at surgery had revealed the presence of malignant cells, one cannot be entirely certain that undetected microscopic malignancy has not spread to other areas. For this reason, it has been decided that the First Lady will be treated with chemotherapy to insure more inclusive treatment against any possible remaining cancer. It is anticipated that this therapy will allow her to continue all normal activities as wife, mother and First Lady. Mrs. Ford's progress to date has been excellent and her outlook for prolonged good health is extremely favorable.

## Vest Can Stop A .44 (Excerpted from the Chicago Tribune)

The "unmentionable" being worn by President Ford -the bulletproof vest the Secret Services refuses to acknowledge -- apparently is a sleeveless, sweater-like garment containing 16 layers of a new synthetic fiber.

It is flexible, and conforms to the body's shape, but it can stop just about any bullet, including one from a Colt .45 automatic, such as was aimed at the President by Lynette Fromme in Sacramento.

Experts agree from its description by witnesses that the vest is probably made of Kevlar 29, a DuPont synthetic fiber said to be seven times as strong as steel by weight. Such a vest would be about half an inch thick, and weigh 2-1/2 to 4 pounds, depending on its dimensions. It would be worn under a regular shirt.

Velocity, bullet weight, and kind of bullet along with the range from which the bullet is fired and the angle at which it strikes the vest, are factors in how well a vest protects its wearer, the expert said.

Informed sources say Ford wore a bulletproof vest when he stepped down from Air Force 1 at Keene, N.H., Thursday.

It is not known whether any previous President ever wore a bulletproof vest. (9/13/75)
