



It would give us a chance to have "Pete" Crow up-date everyone on the project and to get some intelligence from the agencies concerning what they plan to have there. This would also help in forming a recommendation to the President concerning this possible announcement. As I discussed with you, "Pete" indicates that they are moving ahead with plans to have Jim Fletcher and John Warner hold a press conference on the subject on February 10th.

Jack also mentioned a need for Dick Hite to brief on logistics and security. Dick is ready with the latest information.

As soon as I can get a day and time, I'll work out the rest of the details.

Your presentation to the Federal Agency Bicentennial Task Force recently was outstanding. I mentioned to the President that you had given this briefing and outlined to him some of the things that Defense was planning to do, and is doing, during the Bicentennial year. It is a very impressive program.

One of the things you mentioned was having tours of the Pentagen. I think this is an excellent idea. During the time I was an Assistant Secretary of Defense, I raised the question of trying to establish a means of Pentagon tours similar to the type of tours we have here at the White House, and make these tours available to constituents of Members of Congress upon request. I believe there would be a tremendous interest of the visitors to Washington to visit the Pentagon.

Secondly, I believe you will find that Members are frequently looking for this type of opportunity to provide a different dimension to Washington visits.
