SUBJECT: Execution of Michaiiah Shobek
by the Government of the Bahamas

Question:

Did the United States Government take any action to assist Mr. Shobek?

Answer:

As is always the case with a serious trial, the American Embassy in the Bahamas followed very closely Mr. Shobek's trial. Mr. Shobek and his lawyer were visited many times by Embassy officials. Naturally any Embassy has the responsibility to see that American citizens are fairly and justly treated.

About a year ago when Mr. Shobek's guilty verdict was announced the American Embassy assisted in obtaining a prominent Bahamian attorney who perfected a right of appeal for Mr. Shobek and an appeal process was followed. The verdict was affirmed on appeal. Last Saturday the American Embassy conveyed to the Bahamian Government an appeal that Mr. Shobek's mother had made to the U. S. Government.

Dear Mr. President:

Enclosed is an article on Democratic National Committee Chairman Robert Strauss' interest in controversial property in San Antonio.

Strauss has made numerous telephone calls and has appeared at the offices of the San Antonio River Authority (SARA) in an attempt to get more than three times the common market price for the property.

The Edwards Aquifer Recharge Zone is part of a highly charged situation in San Antonio. Enclosed are stories which contain background information on the status of the land.

Ralph Brown, an attorney for SARA, speculated today that the trial for the appeal of the ruling against Strauss will not be held until after the November elections, although SARA has proposed an earlier available date.

These, then, are the facts as they now stand. If I can be of any assistance, please let me know.
