CREDIT

WIDOWS OFTEN HAVE PROBLEMS IN ADDITION TO THE INHERITANCE OF A FARM OR BUSINESS. WOMEN HAVE BEEN DISCRIMINATED AGAINST IN THE GRANTING OF CREDIT.

IN 1974 I SIGNED TWO PIECES OF LEGISLATION WHICH SHOULD ALLEVIATE
THIS SITUATION. I SIGNED THE HOUSING AND COMMUNITY DEVELOPMENT
ACT WHICH INCLUDES A PROHIBITION OF DISCRIMINATION ON THE BASIS
OF SEX IN HOUSING AND MORTGAGE CREDIT LENDING. LATER I SIGNED
THE EQUAL CREDIT OPPORTUNITY ACT WHICH PROHIBITS DISCRIMINATION
ON THE BASIS OF SEX AND MARITAL STATUS IN THE GRANTING OF CONSUMER
CREDIT. THIS YEAR I ALSO SIGNED LEGISLATION EXTENDING THE EQUAL
CREDIT OPPORTUNITY BAN ON DISCRIMINATION ON THE BASIS OF RACE,
COLOR, RELIGION, NATIONAL ORIGIN, AND AGE.
