THE PRESIDENT: Good morning.

It is my very strong conviction that the American people have a right to know where I stand on the issues and where my opponent stands on the issues. I challenged my opponent to a series of debates. I feel very strongly that the first debate should come a day or two after Labor Day, and I suggest perhaps September 8, September 9 and September 10.

I think there should be four debates and each debate should involve no less than 90 minutes on each occasion. The subject matters, of course, are those issues that the American people will want to know where my opponent stands and where I stand. They have a right to know.
