DENVER (UPI) -- JIMMY CARTER CRITICIZED PRESIDENT FORD MONDAY FOR "TOTAL LACK OF LEADERSHIP" IN HANDLING THE EARL BUTZ AFFAIR AND SAID THE AGRICULTURE SECRETARY SHOULD HAVE BEEN FIRED IMMEDIATELY WHEN HIS RACIAL REMARKS WERE FIRST PUBLICIZED.

ON THE WAY TO SAN FRANCISCO FOR HIS SECOND DEBATE WITH FORD, CARTER UNLEASHED SOME OF HIS STRONGEST WORDS OF THE CAMPAIGN AGAINST

THE PRESIDENT.

"EARL BUTZ NEVER SHOULD HAVE BEEN SECRETARY OF AGRICULTURE AND HE SHOULD HAVE BEEN FIRED A LONG TIME AGO," CARTER TOLD REPORTERS AT THE DENVER AIRPORT. "I BELIEVE THE WAY THIS WHOLE EMBARRASSING AND DISGUSTING ESPISODE WAS HANDLED BY PRESIDENT FORD SHOWS A CONTINUATION OF THE TOTAL LACK OF LEADERSHIP.

"INSTEAD OF MAKING HIS DECISION ON WHAT WAS RIGHT AND BEST FOR THE COUNTRY, HE VERY CAREFULLY WAITED UNTIL HE ASSESSED PUBLIC OPINION POLLS TO SEE WHAT WAS RIGHT POLITICALLY AND WHEN THE POLITICAL PRESSURE GOT SO GREAT ON HIM FROM HIS OWN PEOPLE WHEN HE FINALLY ACCEPTED EARL BUTZ' RESGINATION.

"I THINK HE SHOULD HAVE DONE IT IMMEDIATELY."

CARTER DID NOT USE THE ROUTINE QUOTES FROM HIS STANDARD SPEECH ON FOREIGN POLICY AND DEFENSE, AS HE CONTINUED TO MAKE A MYSTERY OF HOW HE WOULD APPROACH FORD ON THOSE SUBJECTS IN WEDNESDAY NIGHT'S SECOND DEBATE.

IT HAS BEEN SPECULATED THAT CARTER WOULD TAKE A CONSERVATIVE LINE ON DETENTE AND DEFENSE IN THE DEBATE FOLLOWING HIS FOUR-HOUR MEETING SUNDAY IN PLAINS, GA., WITH FORMER DEFENSE SECRETARY JAMES SCHLESINGER. SCHLESINGER WAS FIRED BY FORD AFTER HE SAID THAT THE UNITED STATES HAD GIVEN AWAY TOO MUCH IN ARMS TALKS WITH THE RUSSIANS.

LATER, AS CARTER ADDRESSED 2,000 CHEERING PEOPLE ON A DOWNTOWN STREET CORNER, HE REFERRED REPEATEDLY TO WHAT HE SAID WERE FORD'S TIES WITH SPECIAL INTEREST GROUPS AND LOBBYISTS.

CARTER CRITICIZED FORD FOR NOT HAVING A TELEVISED NEWS CONFERENCE "WHERE HE CAN BE CROSS-EXAMINED ABOUT HIS DEALINGS WITH LOBBYISTS AND SPECIAL INTEREST GROUPS."

"WE MAKE MISTAKES -- I GIVE INTERVIEWS -- BUT THEY ARE MISTAKES OF THE HEART," CARTER SAID, REFERRING TO HIS CONTROVERSIAL SEX-AND-RELIGION COMMENTS IN PLAYBOY MAGAZINE. "I DON'T THINK DEMOCRATS HAVE BEEN THE CAPTIVE OF SPECIAL INTEREST GROUPS THE WAY REPUBLICANS HAVE."

CARTER WAS CHEERED REPEATEDLY WHEN HE SAID "SOMEBODY HAS TO LEAD THIS NATION. NOW NOBODY'S LEADING IT AND THE COUNTRY IS DRIFTING."

Word of Butz resignation came as the Democratic presidential candidate was flying to San Francisco where he is to meet Ford Wednesday night in the second of their three scheduled debates. During a stopover here. Carter told an airport news conference that * the way this whole embarrassing and disgusting episode was handled by President Ford shows a continuation of lack of leadership... 'He said that Ford, instead of 'deciding what was right and best for the country, very carefully waited until he assessed public opinon polls to see what was right politically, and when the political pressure got so great on him from his own people, then he finally accepted Earl Butz: rsignation. ...

Carter spent part of Junday being briefed by former Secretary of Defense James Schlesinger, who was fired by Ford last year as the result of policy differences over national defense and detente with the Soviet Union.

Prior to the debate, which will deal with foreign and defense policy, he will be briefed again by Dr. Zbigniew Brzezinski, of Columbia University, Carter's top foreign policy adviser, and Rep. Les Aspin, D-Nis., who serves on the House Armed Services Committee. The aide also said Carter would have a question-and-answer session with top staff members to prepare for the debate.

Carter acknowledged over the weekend that his campaign style is .. I we been much more becoming more aggressive. In the past week, aggressive and much more specific than I have been, " Carter told a

group of black journalists in Washington Saturday. *There was a time . . . when I deferred too much to Ford simply because he was in the White House , . Carter added . . Now I m looking on him as a man who s running for president for the first time as I am, a hand-picked successor to Richard Nixon, a personification of

what the Republican party stands for, and an equal nominee of his party, compared to me.,,

Carter added he thought "the spirit of my campaign has picked up tremendously. The enthusiasm of the people has picked up." Carter later told reporters that he planned to show more aggressiveness in the debate.

Carter said in a campaign appearance over the weekend that Ford "for all practical purposes, has removed himself from the decision-making process, in foreign affairs, with Secretary of State Henry A. Kissinger making the major decisions. It's a point he's expected to press in the debate.

WASHINGTON (UPI) -- AGRICULTURE SECRETARY EARL BUTZ HANDED PRESIDENT FORD HIS RESIGNATION MONDAY, SAYING IT WAS THE PRICE FOR "GROSS INDISCRETION" -- A RACIAL SLUR THAT WAS BECOMING AN ISSUE IN THE 1976 PRESIDENTIAL CAMPAIGN.

BUTZ APOLOGIZED FOR HIS REMARKS ABOUT BLACKS AND SAID IN A STATEMENT, "BY TAKING THIS ACTION, I HOPE TO REMOVE EVEN THE APPEARANCE OF RACISM AS AN ISSUE IN THE FORD CAMPAIGN."

HE SAID HIS DECISION WAS ENTIRELY VOLUNTARY, AND THERE WAS "NO

PRESSURE" FROM THE WHITE HOUSE.

"PRESIDENT FORD IS A DECENT MAN WITH HIGH MORAL VALUES, WHO INSISTS THAT EVERY AMERICAN BE TREATED EQUALLY AND WITH DIGNITY," SAID BUTZ. "EVERY MEMBER OF HIS ADMINISTRATION MUST AND DOES SUBSCRIBE TO THE SAME VALUES."

FORD SAID HIS DECISION TO ACCEPT BUTZ' RESIGNATION WAS "ONE OF THE SADDEST" OF HIS PRESIDENCY. HE PRAISED BUTZ' WORK IN AGRICULTURE AND CALLED HIM "A CLOSE PERSONAL FRIEND, WHO LOVES HIS COUNTRY AND ALL THAT IT REPRESENTS."

PRESIDENTIAL PRESS SECRETARY RON NESSEN SAID FORD HAD NOT YET CHOSEN A SUCCESSOR FOR BUTZ, A FORMER PURDUE UNIVERSITY PROFESSOR WHO WAS APPOINTED AGRICULTURE SECRETARY IN 1971 BY RICHARD NIKON. AGRICULTURE UNDERSECRETARY JOHN KNEBEL SAID FORD ASKED HIM TO SERVE AS ACTING SECRETARY.

FORD REPRIMANDED BUTZ FRIDAY FOR "HIGHLY OFFENSIVE" REMARKS MADE IN A CONVERSATION WITH FORMER WHITE HOUSE COUNSEL JOHN DEAN AND ACTOR PAT BOONE ON A PLANE FROM THE GOP NATIONAL CONVENTION.

DEAN REPORTED THE REMARKS IN "ROLLING STONE" MAGAZINE, ATTRIBUTING

THEM TO AN UNIDENTIFIED CABINET MEMBER.

BUTZ, ASKED WHY MORE BLACKS DO NOT VOTE REPUBLICAN, SAID ALL "COLOREDS" WANT ARE THREE THINGS -- GOOD SEX, "LOOSE SHOES" AND INDOOR TOILET FACILITIES. HIS LANGUAGE WAS SO COURSE THAT MOST NEWSPAPERS AND BROADCAST STATIONS DID NOT USE HIS EXACT WORDS IN REPORTING THE REPRIMAND.

TEARY-EYED AFTER MEETING WITH FORD MONDAY, BUIL READ TO REPORTERS HIS RESIGNATION LETTER SAYING, "I SINCERELY APOLOGIZE FOR ANY OFFENSE THAT MAY HAVE BEEN CAUSED BY THE UNFORTUNATE CHOICE OF LANGUAGE USED IN A RECENT CONVERSATION AND REPORTED PUBLICLY."

BESIDES HIS LETTER OF RESIGNATION AND HIS ORAL STATEMENT AT THE WHITE HOUSE, BUTZ ISSUED A WRITTEN STATEMENT SAYING, "THIS IS THE PRICE I PAY FOR A GROSS INDISCRETION IN A PRIVATE CONVERSATION. THE USE OF A BAD RACIAL COMMENTARY IN NO WAY REFLECTS MY REAL ATTITUDE."

THEN FORD, HIS FACE GRIM AND AIDES SHIELDING HIM FROM REPORTERS' QUESTIONS, ENTERED THE ROOM AND SAID BUTZ WAS WISE AND COURAGEOUS ENOUGH "TO RECOGNIZE THAT NO SINGLE INDIVIDUAL ... SHOULD CAST A SHADOW OVER THE INTEGRITY AND GOOD WILL OF AMERICAN GOVERNMENT BY HIS

COMMENTS."

BUTZ HAD BEEN REPRIMANDED ONCE BEFORE BY FORD IN 1974 AFTER HE REPEATED A JOKE ABOUT THE POPE'S POSITION ON BIRTH CONTROL, CAUSING AN UPROAR IN THE ROMAN CATHOLIC COMMUNITY. FORD TOLD HIM THEN TO APOLOGIZE FOR COMMENTING: "HE (THE POPE) NO PLAYA DA GAME, HE NO MAKA DA RULES."

FORD HAD VALUED BUTZ IN THE CAMPAIGN BECAUSE OF THE SECRETARY'S INFLUENCE IN TRADITIONALLY REPUBLICAN MIDDLE WEST FARM AREAS, WHERE SOME FALLING PRICES AND LAST YEAR'S TEMPORARY FOREIGN GRAIN EXPORT EMBARGO WEAKENED THE PRESIDENT.

ALTHOUGH SOME FARM GROUPS HAD ASKED THE PRESIDENT TO RETAIN BUTZ DESPITE HIS REMARK ABOUT BLACKS, OTHERS WERE NOT SO FORGIVING.

SEN. EDWARD W. BROOKE, R-MASS., THE ONLY BLACK IN THE SENATE, ISSUED A STATEMENT MONDAY SAYING, "SECRETARY BUTZ' RESIGNATION IS

GOOD FOR THE COUNTRY, THE PRESIDENT, AND THE REPUBLICAN PARTY."

THE KANSAS SENATOR TOLD SEVERAL THOUSAND PERSONS ATTENDING AN AMERICAN BANKERS ASSOCIATION CONVENTION THAT IF CARTER "IS LESS THAN REASSURING ON THE QUESTION OF MAINTAINING OUR DEFENSE FORCES, HE IS DOWNRIGHT FRIGHTENING IN DISCUSSING HOW HE MIGHT USE THEM."

DOLE CITED A CARTER STATEMENT THAT SAID HE WOULD USE NUCLEAR WEAPONS IF THE NATION'S SECURITY OR EXISTENCE WAS THREATENED.

"THE LIMITING WORDS 'OUR NATION' NATURALLY CREATED ANXIETY AMONG

OUR ALLIES AROUND THE WORLD," DOLE SAID.

HE ALSO BLASTED STATEMENTS BY THE DEMOCRAT THAT HE WOULD SEEK APPROVAL FROM SUCH NATIONS AS GERMANY, AUSTRIA AND FRANCE BEFORE USING NUCLEAR WEAPONS IN EUROPE.

Dole, a long-time friend of Butz who had worked closely with him on farm legislation, was one of the first persons whose counsel Butz sought after published reports attributed to him a comment, made after the Republican convention in Kansas City last August, and subsequently quoted in two magazines. A Rolling Stone article; written by former White House aide and Watergate figure John Dean III, did not name Butz but New Times magazine identified him as the source of the remark.

IT WAS NOT KNOWN WHEN THE AUTO FIRM AND THE UNION WOULD MAKE THE OFFICIAL ANNOUNCEMENT AT FORD WORLD HEADQUARTERS IN SUBURBAN DEARBORN. BUT LOCAL UAW OFFICIALS WHO REPRESENT THE 170,000 FORD WORKERS SAID THEY WERE BEING TOLD THAT THE AGREEMENT HAD BEEN REACHED.

"ALL THAT'S LEFT TO DO IS TO DOT THE I'S AND CROSS THE T'S," ONE HIGH UNION SOURCE SAID.

THE UNION REPORTEDLY WON AGREEMENT ON REDUCING WORKING TIME IN A PLAN THAT WILL GIVE WORKERS FOUR EXTRA PAID DAYS OFF IN THE FIRST YEAR, EIGHT DAYS IN THE SECOND YEAR AND 12 DAYS IN THE THIRD YEAR. THE UNION SAID THIS WILL FORCE THE AUTO COMPANIES TO HIRE MORE WORKERS BUT LABOR OBSERVERS SAID IT WOULD ULTIMATELY LEAD TO THE FOUR-DAY WORK WEEK, A LONGTIME GOAL OF ORGANIZED LABOR.

THE NEW AGREEMENT REPORTEDLY ALSO INCLUDES A 3 PER CENT ANNUAL WAGE INCREASE, CONTINUED UNLIMITED COST-OF-LIVING IMPROVEMENTS, FINANCIAL AID FOR RETIREES AND GREATER FINANCING OF THE SUPPLEMENTAL UNEMPLOYMENT BENEFITS FUND THAT GIVES IDLED WORKERS UP TO 95 PER CENT OF THEIR TAKE-HOME PAY.

THE LABOR DISPUTE ALREADY HAS COST FORD WORKERS MORE THAN \$150 MILLION IN LOST WAGES. IT WAS ABOUT TO ENTER ITS FOURTH WEEK WEDNESDAY AND THREATENED TO CRIPPLE FORD'S 1977-MODEL CAR INTRODUCTION IF IT WENT PAST THE ONE-MONTH MARK.

"I SUPPORT A COMPREHENSIVE TEST BAN AGREEMENT WITH THE SOVIET UNION, COVERING BOTH WEAPONS TESTS AND SO-CALLED 'PEACEFUL' NUCLEAR

EXPLOSIONS." HE SAID.

"THE UNITED STATES AND THE SOVIET UNION SHOULD CONCLUDE SUCH AN AGREEMENT IMMEDIATELY, TO LAST FOR FIVE YEARS, DURING WHICH THEY SHOULD ENCOURAGE ALL OTHER COUNTRIES TO JOIN."

THE ARMS CONTROL ASSOCIATION, A PRIVATE ARMS CONTROL STUDY GROUP, PUT A SERIES ON QUESTIONS ON ARMS POLICY TO BOTH CARTER AND FORD.

THE WHITE HOUSE SAID FORD FEELS A TEST BAN "WOULD BE USEFUL IN STEMMING THE TIDE OF THE ARMS RACE, FIRST BY THE BAN ITSELF, AND SECOND, BY FOSTERING A SPIRIT OF COOPERATIONS BETWEEN THE UNITED STATES AND SOVIET UNION."

HOWEVER, THE PRESIDENT CONSIDERS A BAN MUST BE "BACKED BY ADEQUATE

SAFEGUARDS.'

THE FORD ADMINISTRATION HAS ARGUED NATIONAL MONITORING SYSTEMS ARE NOT YET SOPHISTICATED ENOUGH TO ACCURATELY DISTINGUISH UNDERGROUND TESTS FROM UNDERGROUND TREMORS AND EARTHQUAKES.

BUT CARTER SAYS THE UNITED STATES IS CAPABLE OF IDENTIFYING "EVEN VERY SMALL WEAPONS TESTS" WITHOUT ON-SITE INSPECTION AND CURRENT TECHNICAL MEANS ARE SUFFICIENT TO VERIFY A COMPREHENSIVE TEST BAN.

VIEWS OF THE CANDIDATES ON OTHER POINTS:

STRATEGIC ARMS LIMITATION TALKS:

FORD -- THE UNITED STATES MUST "RETAIN THE OPTION TO PROVIDE OUR FRIENDS AND ALLIES WITH THE WEAPONS NECESSARY TO PROTECT THEMSELVES" WHILE SELLING "ONLY TO THOSE WHO CAN DEMONSTRATE A VALID NEED."

FIRST USE OF NUCLEAR WEAPONS:

AM-COURT SKED 10-4 BY JAMES A. KIDNEY

WASHINGTON (UPI) -- THE SUPREME COURT MONDAY STOOD FIRMLY ON ITS RULINGS OF LAST JULY UPHOLDING CAPITAL PUNISHMENT FOR MURDER IN THREE STATES, BUT AGREED TO RESOLVE WHETHER A RAPIST CAN BE SENTENCED TO DEATH ALTHOUGH HIS VICTIM SURVIVES.

ON THE OPENING DAY OF ITS NEW TERM, THE COURT SUMMARILY REFUSED TO GRANT REHEARINGS IN CASES THAT RESULTED IN ITS DECISION LAST TERM FINDING THAT DEATH PENALTY LAWS IN GEORGIA, TEXAS AND FLORIDA DO NOT VIOLATE THE CONSTITUTION'S BAN ON "CRUEL AND UNUSUAL" PUNISHMENT.

THE COURT SAID LAST JULY ITS DECISION ONLY APPLIED TO NURDERERS, AND LEFT OPEN WHETHER THE PUNISHMENT CAN BE APPLIED WHEN A VICTIM DOES NOT DIE.

BUT ON OPENING DAY -- IN WHICH IT DISPOSED OF MORE THAN 700 APPEALS LEFT OVER FROM LAST YEAR AND FILED DURING THE SUMMER -- THE JUSTICES VOTED TO DECIDE THAT ISSUE IN AN APPEAL BY A GEORGIA RAPIST WHO CONTENDS CAPITAL PUNISHMENT IS CONSTITUTIONAL ONLY FOR MURDER.

THE COURT ALSO LIFTED A STAY OF EXECUTION, GRANTED PENDING MONDAY'S DENIAL OF REHEARING. THIS MEANS THAT NEARLY 200 CONVICTED MURDERERS ON DEATH ROWS IN FLORIDA, TEXAS AND GEORGIA MUST SEEK EXECUTIVE CLEMENCY FROM STATE GOVERNORS OR PURSUE FURTHER APPEALS ON TECHNICAL GROUNDS THAT THEIR ARRESTS OR TRIALS WERE UNFAIR.

OFFICIALS IN THE THREE STATES WERE RELUCTANT TO PREDICT WHICH MIGHT BE THE FIRST TO STAGE AN EXECUTION IN THIS COUNTRY SINCE 1967. A LAWYER FOR THE NAACP LEGAL DEFENSE FUND, WHICH BROUGHT THE DEATH PENALTY APPEALS, HAS SAID PECULIARITIES OF GEORGIA LAW MAKE THAT STATE A LIKELY CANDIDATE FOR THE FIRST EXECUTION -- BUT STATE AUTHORITIES DISPUTE THAT.

IN ANOTHER DEATH PENALTY CASE, THE COURT TOLD THE ARKANSAS SUPRENE COURT TO RE-EXAMINE ITS DECISION UPHOLDING THAT STATE'S DEATH PENALTY LAW IN LIGHT OF JULY'S DECISIONS.

ALL NINE JUSTICES WERE PRESENT FOR THE NEW TERM AND IMMEDIATELY JUMPED INTO A CONTROVERSIAL APPEAL BY IOWA CONTENDING THE "MIRANDA" RULE SHOULD BE LIBERALIZED OR ABOLISHED. JUSTICE THURGOOD MARSHALL, WHO SUFFERED A HEART ATTACK DURING THE SUMMER, WAS PRESENT AND ASKED SEVERAL QUESTIONS IN THE IOWA CASE.

THE COURT AGREED TO REVIEW ONLY 25 APPEALS FROM THE HUNDREDS ACTED UPON MONDAY. AMONG THOSE GRANTED WERE:

-- A CLAIM BY TWO ARIZONA LAWYERS THAT THE STATE'S PROFESSIONAL CODE BARRING PRICE ADVERTISING FOR STANDARD LEGAL FEES VIOLATES BOTH THE ANTITRUST LAWS AND A LAWYER'S RIGHT TO FREE SPEECH. ARIZONA'S RULE IS VIRTUALLY IDENTICAL TO THOSE IN ALL OTHER 50 STATES AND COMPLIES WITH RECOMMENDATIONS FROM THE AMERICAN BAR ASSOCIATION. THE JUSTICE DEPARTMENT HAS FILED A SIMILAR LAWSUIT CHALLENGING THE ABA CODE BUT IT HAS NOT BEEN HEARD IN DISTRICT COURT.

-- THE QUESTION OF WHETHER CUSTOMS INSPECTORS MUST OBTAIN A SEARCH WARRANT BEFORE OPENING SUSPICIOUS MAIL FROM OVERSEAS. LOWER COURTS HELD THAT INSPECTORS ERRED BECAUSE THEY DID NOT OBTAIN A SEARCH WARRANT TO OPEN A BULKY LETTER IN WHICH THEY FOUND HEROIN SENT FROM

THAILAND TO A WASHINGTON, D.C., ADDRESS.

-- ANOTHER JUSTICE DEPARTMENT APPEAL CLAIMING THAT A SEARCH WARRANT WAS NOT REQUIRED TO SEARCH A FOOTLOCKER FOUND IN A TRAIN STATION WHICH CONTAINED MARIJUANA.

-- WHETHER ILLINOIS MAY REVOKE A DRIVER'S LICENSE WITHOUT A HEARING. LOWER COURTS SAID "NO" AND ILLINOIS APPEALED.

AMONG THE CASES DENIED REVIEW WERE:

-- UNSUCCESSFUL CLAIMS BY CALIFORNIA LANDOWNERS THAT THEIR PROPERTY RIGHTS ARE VIOLATED BY A STATE REGULATION REQUIRING THEM TO ADMIT UNION ORGANIZERS ONT THEIR LAND.

-- EFFORTS BY THE U.S. CONPTROLLER OF THE CURRENCY AND FEDERALLY CHARTERED BANKS TO BYPASS BRANCH BANKING LAWS AND INSTALL ELECTRONIC TERMINALS IN GROCERIES AND OTHER RETAIL OUTLETS THAT ALLOW CUSTOMERS TO WITHDRAW FUNDS AND MAKE CREDIT PURCHASES DIRECTLY FROM THEIR BANK ACCOUNTS.

-- ANOTHER ATTEMPT BY OPPONENTS OF BOSTON'S SCHOOL DESEGREGATION PLAN TO GAIN SUPREME COURT REVIEW OF THE BUSING CASE. THE COURT TURNED DOWN THE CASE LAST TERM AND DENIED REHEARING ON THE MATTER MONDAY.

AM-TAXES SKED 10-4

WASHINGTON (UPI) -- PRESIDENT FORD MONDAY SIGNED THE LARGEST TAX REVISION BILL EVER PASSED ALTHOUGH CONGRESS DID NOT APPROVE HIS PROPOSED \$10 BILLION IN EXTRA TAX CUTS AND INCLUDED MANY PROVISIONS HE FOUND OBJECTIONABLE.

"ON BALANCE, HOWEVER, THIS LEGISLATION IS SOUND, POSITIVE AND LONG OVERDUE," SAID FORD IN SIGNING THE FIVE-INCH-THICK BILL IN AN OVAL OFFICE CEREMONY.

THE LEGISLATION CONTINUES CURRENT TAX CUTS, THUS LEAVING THE WITHHOLDING RATE UNCHANGED, BUT MAKES THOUSANDS OF OTHER TAX LAW CHANGES THAT WILL BENEFIT WORKING PARENTS, THE ELDERLY, FARMERS, SOME CORPORATIONS SUCH AS RAILROADS AND AIRLINES, AND MANY OTHER SEGMENTS OF AMERICAN SOCIETY.

IT WILL INCREASE TAXES ON SOME CORPORATIONS AND ON THE WEALTHY WHO HAVE BEEN USING SHELTERS AND TAX-FREE PREFERENCE INCOME TO AVOID TAX.

FORD SAID HE WOULD PROPOSE A NUMBER OF NEW TAX CHANGES NEXT YEAR, ASSUMING HE IS RE-ELECTED, INCLUDING AN INCREASE IN THE PERSONAL EXEMPTION OF \$750 TO \$1,000, AND "INTEGRATION" OF CORPORATE AND PERSONAL INCOME TAXES WHICH COULD LEAD TO A TAX CUT OF BILLIONS FOR EITHER CORPORATIONS OR THEIR STOCKHOLDERS.

HE ALSO SAID HE WOULD PROPOSE A FORM OF ACCELERATED DEPRECIATION FOR BUSINESSES WHICH OPEN NEW PLANTS OR BUY NEW EQUIPMENT IN HIGH UNEMPLOYMENT AREAS, AND WOULD PROPOSE A PROGRAM OF BROADENED STOCK

OWNERSHIP FOR LOW AND MIDDLE INCOME AMERICANS.

FORD WAS PARTICULARLY CRITICAL OF CONGRESS' FAILURE TO APPROVE AN EXTRA \$10 BILLION IN PERSONAL INCOME TAX REDUCTIONS, A PLAN ALMOST TOTALLY IGNORED BY LAWMAKERS AFTER DEMOCRATS CLAIMED MOST OF THIS EXTRA BENEFIT WOULD GO TO UPPER INCOME PERSONS.

BUT HE SAID HE WAS PLEASED BY ACTION TO CLOSE TAX LOOPHOLES AND WAS "GRATIFIED THAT THE CONGRESS HAS ADOPTED THE PROGRAM OF ESTATE TAK RELIEF WHICH I PROPOSED AT THE BEGINNING OF THIS YEAR."

THE BILL "DOES GO A LONG WAY TOWARD PROVIDING COMMON SENSE AND

EQUITY IN OUR TAX SYSTEM," HE SAID.

IN ITS FIRST FULL YEAR, 1977, THE BILL'S "LOOPHOLE CLOSING" AMENDMENTS INCREASE TAXES ON CERTAIN GROUPS BY \$3 BILLION, THE LARGEST INCREASE BEING THE \$1 BILLION INCREASE IN THE MINIMUM TAX.

THE BILL THEN GIVES AWAY \$1.4 BILLION THROUGH NEW OR EXPANDED TAX-BREAKS FOR INDIVIDUALS AND INDUSTRY, LEAVING THE BILL WITH A NET \$1.6 BILLION IN "REFORM" ITS FIRST YEAR. THIS DROPS OFF TO ABOUT \$1 BILLION A YEAR FROM 1978 THROUGH 1981 AS REDUCTIONS IN THE ESTATE AND GIFT TAX BEGIN TO TAKE EFFECT.

OTHER HIGHLIGHTS:

*Everything is going to be just fine, ** said Jack Kelly, puffing or his pipe as he surveyed the flurry of activity at the Palace of Fine Arts. President Ford and Limmy Carter will debate foreign policy and puffing on Arts. President Ford and Jimmy Carter will debate foreign policy and national security here Wednesday evening before a highly select live audience of 576 and a television audience of millions. The candidates were arriving in San Francisco on Monday amid * the biggest security effort ever here . , said Police Chief Charles Gain . * It's the first time we've had both a president and a presidential **It's the first time we've had both a president and a presidential candidate's opponent here together for an extended stay. There will be a rescheduling of some police days off and some overtime.''

Aides said Carter and Ford would spend most of Tuesday boning up for the debate. Carter will stay at the Sheraton-Palace Hotel, and Ford will stay at the home of a prominent San Francisco lawyer.

In their first debate, on Sept. 23 in Philadelphia, Ford and Carter were left standing in awkward silence after a \$1 piece of equipment failed, cutting the audio portion of the telecast.

ASSINGTON AP - President Ford WASHINGTON AP - President Ford signed a wide-ranging tax revision bill Monday that eases the tax burden for individuals and businesses across America. Ford signed the measure at a White House ceremony, commenting that the legislation is **sound, positive and long overdue.*,

Tax cuts included in the law total about \$18 billion, but workers should not look for any more money in their paychecks since these cuts are already in effect and are simply being extended.

Ford said the measure will **ensure that each taxpayer bears his or her fair share of the over-all tax burden.,
But he added that the law is 'far from perfect,, particularly because he said it failed to include his request for deeper cuts in individual taxes. He said he will continue to work for a 'better break for low and middle-income taxpayers...
Ford said he will urge the next Congress to raise the personal exemption to \$1,000 from the present \$750.

The bill is more than 1,000 pages long and was two years in the making. Provisions in the bill affect child care, pensions for housewives deductions for work done at home, investment and foreign tax credits and estate taxes, among other items. The Ford administration has expressed fears that Middle East peace efforts could be harmed by a section denying certain tax breaks to U.S. companies that participate in international boycotts such as the Arab action against Israel. Without this extension of tax cuts first introduced last year, taxes for a family of four earning \$15,000 would rise \$180 a year. A single person earning \$8,000 would pay \$182 more and a couple earning \$10,000 would face a \$204 tax increase.

Taxes of wealthy individuals will rise under the law, primarily because of an increase in the minimum income tax and new restrictions on the use of *tax shelters.*;

But taxes of eiglines resilenced absence in the minimum income tax and new restrictions on the use of *tax shelters.*; But taxes of airlines, railroads, shipping, insurance and some other companies, including those with high pollution control costs, will be reduced by other provisions.

Most of the tax changes will take effect this year or next, but some will not be phased in until later. Five years from now the bill will produce a net federal revenue increase of about \$984 million over the present law. Here are the major provisions of the new law: More 1510pED 10-04

INDIVIDUAL CREDIT - Each taxpayer will be allowed to subtract \$35 for himself and for each dependent from the total tax he owes. Or, he can subtract 2 per cent of his first \$9,000 of taxable income, up to a maximum credit of \$180. This will continue through Dec. 31, 1977. STANDARD DEDUCTION - Used by people who do not itemize their deductions, this is made permanent at existing rates, which were raised last year to a minimum of \$1,700 for single persons and \$2,100 for joint returns and a maximum of 16 per cent of taxable income, up to \$2,400 for single persons and \$2,800 for joint returns. CHILD CARE - A new deduction for child-care expenses is introduced under which up to \$400-a-year can be subtracted from taxes owed for expenses of caring for one child, up to \$800 for two or more. This replaces a system which was weighted toward families in the upper middle-income brackets.

HOUSEWIVES PENSIONS - If a worker qualifies for a tax-deferred Individual Retirement Account, he can increase the current \$1,500 maximum annual contribution to \$1,750 to benefit his spouse if she does not work outside the home.

CREDIT FOR THE ELDERLY - The elderly receive a credit of 15 per per cent on on a \$2,500 base for a single persons and \$3,750 for couples. This will apply to all types of income and replaces a complicated retirement-income credit.

WORK BONUS - The special tax cedit for poor working families with children is extended through Dec. 31, 1977. The credit is available even to people who owe no taxes. It is a 10 per cent credit on the first \$4,000 of earnings and decreases from that point to phase out at the \$8,000 level.

BUSINESS IN HOME - An individual will be allowed a tax deductions for a business in his home only if he uses a portion of the home regularly and exclusively for business and if it is his main place of business.

SIMPLIFICATION - The dozen confusing, fine-print tables in the instructions on Form 1040 will be condensed into two pages of schedules. The schedules will be available to 90 per cent of taxpayers, applying to those with taxable incomes up to \$20,000. SALE OF HOME - Up to \$35,000 of the sale price of a home will escape taxation if sold by a person 65 or older. The tax-free limit had been

\$20,000.
MINIMUM TAX - Aimed generally at persons who earn more than \$50,000 a year, the minimum tax, which is based on a percentage formula, will be increased on individuals and corporations.

MAXIMUM TAX - Designed to lure investors away from tax shelters, this provision limits the tax on earned income, such as salary, to 50 per cent and extends this protecton to pensions.

LEGAL SERVICES - This allows tax-free treatment of an employer's contributions to a group legal-service plan for his employes. This is already done for health-insurance plans.

INVESTMENT CREDIT - Corporations that purchase equipment will be allowed to deduct 10 per cent of the cost from taxes owed. This existing credit is continued through 1980. A corporation can increase the credit to 11 per cent by agreeing to use the extra to purchase

BUSINESS TAX CUTS - The tax cuts approved last year to aid small businesses continue through 1977. This sets a 20 per cent tax rate on

the first \$25,000 of income, 22 per cent on the second \$25,000 and 48 per cent on all other incomé.

ESTATE AND GIFT TAXES - Previous law exempted from inheritance and gift taxes \$90,000 of each estate. In addition, half the estate was gift taxes \$90,000 of each estate. In addition, half the estate was exempt if willed to the surviving spouse. The new law changes the exemption to a credit, which gradually will increase to the equivalent of a \$176,625 exemption by 1981. If the estate is willed to the spouse, half the value or \$250,000, whichever is larger, will be tax free. The law also increases income taxes on inherited property that subsequently is sold by the heirs.

EXPORTS - About one-third of the \$1.5-billion-a-year subsidy for exports is eliminated. Generally this subsidy will be available only for increases in export levels.

FOREIGN TAX CREDIT - Taxes on U.S. firms doing business abroad will be increased by ending an escape clause, known as the per-country limitation. In the foreign tax credit.

FOREIGN INCOME - The amount of annual income earned by an American abroad that could excape taxation is cut from \$20,000 to \$15,000.

CAPITAL GAINS - The tax on capital gains, increases in the value of property such as stocks or real estate, increases by \$11 million in 1977 and \$134 million a year by 1981.

SICK PAY - The law allowing a sick worker to avoid taxes on up to \$100-a-week in pay from his employer is repealed and replaced with a

JUAN MARIA DE ARALUCE VILLAR, 59, A MEMBER OF THE COUNCIL OF THE REALN, SPAIN'S HIGHEST ADVISORY GROUP, WAS HIT BY 15 TO 20 BULLETS, POLICE SOURCES SAID. THE TERRORISTS' SUBMACHINEGUN SALVOS SPRAYED AT LEAST 15 CARS IN THE ATTACK.

THE ATTACK WAS THE MOST SERIOUS GUERRILLA ACTION IN SPAIN SINCE THE ASSASSINATION THREE YEARS AGO OF PREMIER LUIS CARRERO BLANCO. PREMIER ADOLFO SUAREZ CALLED AN EMERGENCY MEETING OF THE GOVERNMENT.

In a footnote to that decision, however, the court added:
**We do not address here the question whether the taking of the criminal's life is a proportionate sanction where no victim has been deprived of life - for example, when capital punishment is imposed for rape, kidnaping or armed robbery that does not result in the death of any human being.;; A spokesman for the NAACP Legal Defense Fund, which is leading the fight against the death penalty, said about half a dozen men are undesentence of death in Georgia and Florida for rapes in which the victim did not die. Georgia and Florida are the only states in which rape is a capital offense, except for some states whose laws were invalidated by the Supreme court ruling. The case submitted to the court was that of Ehrlich Anthony Coker. Coker was convicted of raping a Waycross, Ga. woman on Sept. 2, 1974, after escaping from the Ware Correctional Institution during a Alcoholics Anonymous meeting. The woman was abducted from her home i the family car.

Coker was arrested while attempting to elude a police roadblock nea Waresboro, Ga., after abducting Mrs. Elnita Carver. Her husband. David, whom Coker had tied up, got loose and called the police. The couple had a three-week-old son. 1100aED 10-04

It said the principal reason for the department's decision appeared to have been Atty. Gen. Edward Levi's concern that entering the case "would have been misconstrued as a vindication of the violence which has accompanied desegregation in Boston.,

**This fear appears to have over-riden the department, original consideration of the strict legal merits of our petition,, the committee said. The committee said Solicitor Gen. Robert H. WASHINGTON AP - The second Ford-Carter debate Wednesday may crystallize defense policy differences which are now vague on certain

key issues. Democratic presidential candidate Jimmy Carter has disagreed with President Ford on defense budget cutting, the B1 bomber, deployment of U.S. forces in South Korea, foreign arms sales and the state of the military reserves.

But Carter has spoken in largely general terms on a number of the issues, and in some cases his positions do not appear very far apart

from Ford's.

Carter has not yet spelled out what he would do differently than Ford to maintain a **rough equivalency,, he uses Ford, s term with

the Soviet Union in military power.

Carter also has yet to offer any proposals to change basic U.S.

nuclear weapons strategy. However, he has hinted at reservations about
Ford's policy which contemplates possible limited strikes at selected military-related targets in Russia in event of an attack on Western

The Ford administration contends this policy gives presidents a wide choice of options less severe than massive retaliation, but critics argue it makes nuclear war **thinkable; and, thus, more likely.
Ford; defense policies are a matter of extensive public record
after his more than two years in the White House.
The President has met Carter; relatively mild criticisms of those

policies with some fairly harsh words.

Among other things, Ford has said that if Carter's proposed budget cuts were carried out, "it would be impossible to have a defense adequate to maintain our freedom and the freedom of our friends." Carter's plan to trim military spending by \$5 billion to \$7 billion would be applied to an expected defense budget of more than \$121 billion next year.

When asked how he would achieve his proposed military budget savings. Carter has promised to "cut the fat and frills." eliminate inefficiency and "get back to a defense establishment designed to

fight.,,

In broad terms, he has spoken of "change in the deployment of our armed forces, reduction in troops overseas, a change in personnel policies." He has suggested that he would do something about "the heavy overburden of excessive rank in the military forces." But Carter has not suggested any reduction in the nearly 2.1 million men and women in uniform, nor has he proposed cutbacks in major and

costly weapons systems.

Even on the B1 bomber Carter has stopped short of favoring cancelation of the project.

While Carter said he opposes production of the advanced bomber "at this time, , he said "we ought to keep the B1 bomber as a potential weapon, and not authorize its construction until it is obviously needed.

Accordingly, Carter is on record as supporting continued research and development work on the B1, which would add to the more than \$2 billion the Pentagon already has spent on this phase of the project. Ford takes the position that an early production decision should be made and his top defense aides contend any delay will only add to the currently forecast \$21.6 billion total cost.

The Democratic challenger and the President are clearly at odds over whether to bring home substantial numbers of the 42,000 U.S. troops now stationed in Korea.

Carter said "we could very well; withdraw U.S. Army ground troops from South Korea over a four- or five-year period. But he said he would keep U.S. Air Force squadrons there to maintain what he termed adequate air cover; for South Korea, so he is not urging a total disengagement of U.S. military forces from the Korean peninsula. Yet. Ford has responded to Carter's stand by attacking what he calls "the voices of retreat " and declaring himself against any "unilateral phased withdrawal ...

The condition of the National Guard and the military reserves is another point of difference between Ford and Carter.

The Democratic presidential candidate, a former Georgia governor, said the guard and reserve are "shot through with politics," inadequately trained and equipped and unprepared to fight.

In reply, Ford has said that the National Guard "has never been stronger or better prepared to meet any challenge to this nation's safety and freedom," and has pledged that "I intend to keep it that way . 33

Carter's differences with Ford on sales of arms abroad appear to be

mainly a matter of degree. "I believe very strongly . . . that the next president should move

to reduce arms sales abroad , , Carter has asserted. The Democratic presidential candidate said arms sales should be

assessed on a nation-by-nation basis. * If we think the sale of arms can better preserve peace in a portion of the world, and carry out our committed foreign policy, then

WASHINGTON (UPI) -- PRESIDENT FORD SAID TODAY HE HAD "PUNISHED" AGRICULTURE SECRETARY EARL L. BUTZ FOR MAKING A DISPARAGING RACIAL REMARK AND THE HEAD OF AN INFLUENTIAL FARMERS GROUP URGED BUTZ TO REMAIN AT HIS JOB.

POLITICANS FROM BOTH PARTIES CALLED ON FORD OVER THE WEEKEND TO FIRE BUTZ AND REPORTS CIRCULATED THAT BUTZ WAS PREPARED TO RESIGN. BUT A DEPARTMENT SPOKESMAN SAID TODAY BUTZ "HAS APOLOGIZED AND THAT'S IT."

THE PRESIDENT TALKED ABOUT THE CONTROVERSY WITH EMPLOYES AT A LITHOGRAPH PLANT WHERE HE WENT TO FILM A POLITICAL COMMERCIAL.

"THE WORKERS SAT IN A CIRCLE WITH MR. FORD AND ASKED HIM ABOUT TAKES, CRIME AND BUTZ," ACCORDING TO MRS. REGIS CUPPLES, WHOSE HUSBAND OWNS THE LITHOGRAPH PLANT.

FORD TOLD THE WORKERS "HE PUNISHED HIM VERY SEVERELY AND HE DOES

ALLAN GRANT, PRESIDENT OF THE AMERICAN FARM BUREAU FEDERATION, ISSUED A STATEMENT FROM PARK RIDGE, ILL., TODAY EXPRESSING SUPPORT FOR BUTZ.

"I KNOW THAT SECRETARY BUTZ IS NOT A RACIST," GRANT SAID. "HE HAS ALREADY SUFFERED GREAT DISTRESS BECAUSE OF HIS UNFORTUNATE REMARKS.

"THE PRESIDENT SAID BUTZ WAS MERELY TELLING A STORY FROM SOME TIME AGO," SHE SAID. "THE PRESIDENT SAID HE DID NOT CONDONE IT. THE

NEW YORK AP - A businessmen's organization says it believes it has won a commitment from Jimmy Carter that he would seek the expansion of "the small, independent business sector, relative to bis business and government.

The National Small Business Association said Carter's position was made in responsde to a request to him and President Ford for statements regarding what it claims is an erosion of the power of

small and medium-size companies. Ford impressed the group by advocating the development of a network of University Business Development Centers to cooperate with government in aiding small and medium-size businessmen.

Both candidates supplied the association with statements expressing support for the expansion of independent business, but Carter said he would use statistical yardsticks to measure the growth.

In his response, Ford reiterated a statement made earlier that "it is time you got back to working for your customers rather than the government. It is time the government minded its own business and let you run yours . ? ?

Milton Stewart, president of the politically independent
Washington-based organization, said it was the first time it had
obtained statements from both candidates in a presidential election.

*The two candidates have already given small business problems more
attention than any others in recent memory, * he said, but added that

*we hope they become specific enough so that small business can choose between them. ; ; The association, made up mainly of manufacturers and distributors in every state, describes as small or independent almost any company not included in the 1,000 largest industrial firms or the 300 largest finance and service concerns.

It maintains that the very largest corporations, unions and government have grown at the expense of what it calls the independent sector, partly because of "mistaken federal tax, spending, regulatory and other policies.",

The No. 1 priority of the organization, "the ultimate test of the success of the next four years," it said, will be whether the independent sector has a larger share of assets and jobs than it does now .

Neither candidate specifically endorsed that view, but Stewart said he interpreted Carter's promise of statistical measurements as indicating endorsement.

Cater's original statement was revised last week to add that " " I would introduce and support concrete proposals which would have as high priority the expansion of the independent small business sector of the economy.

**To measure the success of these proposals, my administration would develop specific statistical yardstick formulas to measure the relative growth of small business in relationship to other sectors of the economy . ; ;

NEW YORK: the economy.,, Both candidates invoked the name of former president Harry Truman, Carter declaring that if elected he would be the first small businssman since Truman to hold the top elective office. Speaking of the need to restrain government spending, Ford said, "Harry Truman, himself a former small businessman, saw the wisdom of this principle when he used the presidential veto an average of 35 times each year he was in office.;;

The candidates also expressed sympathy with the NSBA view that federal regulatory policy imposes a severe and sometimes needless burden on small businessmen, and both suggested streamlining.
Said Ford: "We need a top-to-bottom overhaul." Carter stating that 82 regulatory agencies put out more than 45,000 pages of regulations in 1975, promised to reduce red tape, paperwork and

unnecessary reporting requirements.

The candidates said they favor strict enforcement of antitrust laws.

Carter stated specifically that he would seek "tough, enforcement of the Robinson-Patman Act, which outlaws discriminatory

price-cutting.

Antitrust is a particular concern of the NSBA, which states that "more and more during the past 20 years small business and the rest of the independent sector have been squeezed into a shrinking segment of the economy by the growth of government on the one hand and big business and labor on the other., The result, it maintains, has been a diminishing of entrepreneurship, risk-taking, innovation and freedom.

WASHINGTON (UPI) -- SAYING HE HAD TO PAY THE PRICE FOR HIS "GROSS INDISCRETION," A TEARY-EYED SECRETARY OF AGRICULTURE EARL L. BUTZ RESIGNED TODAY BECAUSE OF HIS DISPARAGING RACIAL REMARK.

"THIS IS THE PRICE I PAY FOR A GROSS INDISCRETION IN A PRIVATE CONVERSATION," BUTZ TOLD WHITE HOUSE REPORTERS. "THE USE OF A BAD RACIAL COMMENTARY IN NO WAY REFLECTS MY REAL ATTITUDE."

FORD TOLD REPORTERS, "THIS (ACCEPTING BUTZ' RESIGNATION) HAS BEEN

ONE OF THE SADDEST DECISION OF MY PRESIDENCY."

BUTZ, 67, SERVED FIVE YEARS AS AGRICULTURE SECRETARY UNDER PRESIDENTS RICHARD NIXON AND FORD. BEFORE THE ANNOUNCEMENT WAS MADE, BUTZ MET WITH FORD AT THE WHITE HOUSE.

"BY TAKING THIS ACTION, I HOPE TO REMOVE EVEN THE APPEARANCE OF RACISM AS AN ISSUE IN THE FORD CAMPAIGN," BUTZ SAID IN A WRITTEN STATEMENT.

SEN. EDWARD W. BROOKE, R-MASS., THE ONLY BLACK SENATE MEMBER, IMMEDIATELY ISSUED A STATEMENT SAYING, "SECRETARY BUTZ'S RESIGNATION IS GOOD FOR THE COUNTRY, THE PRESIDENT, AND THE REPUBLICAN PARTY."

BUTZ HAD CALLED BROOKE ON THE TELEPHONE OVER THE WEEKEND THE EXPLAIN HIS REMARK, BUT BROOKE TOLD HIM HE WASN'T "FIT TO SERVE IN THE PRESIDENT'S CABINET."

"MY RESIGNATION MUST IN NO WAY BE INTERPRETED AS SIGNALLING A CHANGE IN THE FARM POLICIES OF THE FORD ADMINISTRATION," BUTZ' STATEMENT SAID.

"IT IS IMPORTANT THAT THE AGRICULTURAL PROGRAM OF THIS ADMINISTRATION BE CONTINUED ... THAT IS WHY I SHALL CONTINUE TO WORK TIRELESSLY FOR HIS ELECTION." THE STATEMENT SAID.

BUTZ, HIS EYES FILLED WITH TEARS AND HIS VOICE BREAKING, TOLD REPORTERS HE AND HIS WIFE DISCUSSED THE RESIGNATION AND PRAYED FOR GUIDANCE.

FORD PRAISED BUTZ' WORK AND SAID, "YET EARL BUTZ IS ALSO WISE ENOUGH AND COURAGEOUS ENOUGH TO RECOGNIZE THAT NO SINGLE INDIVIDUAL, NO MATTER HOW DISTINGUISHED HIS PAST PUBLIC SERVICE, SHOULD CAST A SHADOW OVER THE INTEGRITY AND GOOD WILL OF AMERICAN GOVERNMENT BY HIS COMMENTS."
