Dean Denies Ford's Testimony on Watergate Investigations

John Dean Wednesday, in an exclusive NBC News interview, contradicted 1973 congressional testimony by Gerald Ford that he did not recall aiding any attempt by the Nixon White House to block early Watergate investigations.

Dean said Ford did work with White House staff member Richard Cook, who Dean said reported to him on regular meetings with Ford.

Ford, when he was House Republican leader, told vice presidential confirmation hearings that "to the best of my recollection," he did not discuss any attempt to dam up the Watergate affair with any Nixon staffers.

"I can recall Dick (Cook) coming back and telling, for example, how Jerry was going to call a meeting of the minority members in Les Arends' (former GOP congressman from Illinois) office of the House floor and really tell them what they should do on the day of the vote and how they should hold together and things of this nature," Dean said.

Asked by correspondent Carl Stern if that meant they should block those hearings from going forward, Dean replied, "that's correct."

But, in a written statement to NBC, Cook denied Dean's allegations, and accused him of "vicious lies and clever distortions." Cook, who now works for Lockheed Aircraft, refused to be interviewed on film.

There's no question in my mind that the President told the truth," Cook said. He said he denied contacting Ford "despite John Dean's repeated and frantic requests" to get him to do so.

Ron Nessen said the matter had been disposed of in Ford's confirmation hearings three years ago.

Congresswoman Elizabeth Holtzman (D-N.Y.) has asked the Watergate Special Prosecutor's office to investigate whether Ford told the truth in the hearings.

Asked if the Nixon White House thought Ford was a "stooge," Dean said "no" but said they did think Ford was somebody who "would do their bidding when it needed to be done."

Atlanta Jewish voters —concentrated in key electoral states — could well play a pivotal role if the Carter-Ford race gets any tighter in the next two weeks.

Carter forces are monitoring Jewish sentiment closely in the wake of the White Their importance is magnified even furtherbecause Jews have the highest voter participation of any group in the country. Nearly 90 percent can be expected to turn out Nov. 2.



Senator Bob Dole returned to Washington Wednesday to prepare for his debate Friday with Walter Mondale.

Appearing before a Republican audience in Tennessee Tuesday night, Dole accused Jimmy Carter of lying about past statements on defense cuts and of misrepresenting his Georgia record as governor and supporter of civil rights.

Consumers Show New Confidence

Consumers are more willing to spend money now than they were three months ago because of election prospects and increased confidence in the economy, says a report by University of Michigan researchers.

The report was released Tuesday by the University's Survey Research Center's Director, Richard T. Curtin, and George Katona, survey founder. A total of 1,264 persons were interviewed in the poll.

The researchers said the 6.6-point between May and early September brings the Index of Consumer Sentiment to 88.8 points, based on 100 points recorded in February 1966.

The most noticable improvements were noted in attitudes toward the long-term business outlook and in market conditions for purchase of large household durables, such as furniture and television sets, the economists said.

In an effort to gauge the impact of the upcoming presidential elections on consumer attitudes, respondents were asked which candidate they thought would do a better job solving problems related to general business conditions, inflation and unemployment.

The response was about evenly split at 33 percent each between President Ford and Democrat Jimmy Carter. Ford held a slim 38 percent to 36 percent lead over Carter on the issue of reducing the inflation rate.

On unemployment, however, Carter was favored 2-1 over Ford as having potential to do the best job.

For the first time since the 1972 survey, the study reports, more upper-income families believe the next five years will bring good times rather than bad. While half of all families surveyed said they expect business conditions to remain the same in the next 12 months, the researchers said that is not an unfavorable sign, since current conditions are better than a year ago.

And for the first time in more than three years, a majority--53 percent--of all families felt it was a good time to buy large household durable goods.

Attitudes toward home buying also showed a marked improvement, although the report noted such sentiment is not an indication of intent to buy. While 47 percent felt it is a good time to purchase a home, many of them cannot afford to do so.

Showing a less marked improvement were attitudes toward changes in personal financial conditions. Fifty-three percent said they are financially better off than they were five years ago, compared with 49 percent in February 1975. --AP (10/13/76)



Dangers in an Archaic System

Eugene McCarthy's hope of controlling the election of the next President, though he has no hope of being elected, points to a perilously troublesome and outdated feature of our democratic system.

Voters who go to the polls November 2, technically, will not be voting for a President but for electors. The electors will vote for the presleverage far in excess of his public support.

The electoral system could even produce a minority winner from a field of two candidates without throwing the election to the House of Representatives. That is possible when, for instance, a candidate wins with huge margins in one region, then loses narrowly in a sufficient number of other states.

The Squabble

By all the signs, including polls and personal observation, a great many voters are turned off by the current presidential campaign. After watching what's happened to the campaign since the second television jousting match between Ford and Carter, it's not hard to see why.

The trouble begins with turning what ought to be a glory of the democratic process, the joint appearance of presidential candidates before millions of voters, into a media event. Once again the other evening we had the spectacle of reporters making; their own long speeches or so convoluting the; questions as to make them almost incomprehensible. It was often easier to tell the reporter's political philosophy than that of the candidates.


Still, there were one or two questions offering an opportunity for either man to give a thoughtful appraisal of our present foreign policy or say what he thought itought to be. Right at the beginning Mr. Carter was given a list of recent foreign policy moves of the Ford administration.

Neither these "debates" nor the campaign as a whole gives them much chance. With Mr. Ford we have some idea simply because he has been in office but his record has been a changeable one; it is still hard to tell which way he would move in the future. In the case of Mr. Carter we know only, so far, that he disapproves of the Ford record; most of the rest is lost in haze and contradictions.

Perhaps that is enough for a decision. In the real world elections often turn as much on style as on philosophy, as much on dissatisfactions with what we have got as on expectations of what we will get. So in the end this one may turn on what Jimmy Carter said in Playboy, Earl Butz



WASHINGTON (UPI) -- JOHN DEAN TODAY CONTRADICTED 1973 CONGRESSIONAL TESTIMONY BY GERALD FORD THAT HE DID NOT RECALL AIDING ANY ATTEMPT BY THE NIXON WHITE HOUSE TO STAVE OFF A WATERGATE INVESTIGATION.

FORD, WHEN HE WAS HOUSE REPUBLICAN LEADER, TOLD VICE PRESIDENTIAL CONFIRMATION HEARINGS THAT "TO THE BEST OF MY RECOLLECTION," HE DID NOT DISCUSS ANY ATTEMPT TO DAM UP THE WATERGATE AFFAIR WITH ANY NIXON STAFFERS.

DEAN, THE FORMER AIDE TO PRESIDENT RICHARD NIXON WHOSE MEMORY AND TESTIMONY RESULTED IN NIXON'S POLITICAL FALL AND RESIGNATION, CONTRADICTED FORD IN A TAPED INTERVIEW BROADCAST ON THE NBC TODAY TELEVISION PROGRAM.

DEAN SAID NIXON STAFF MEMBER RICHARD COOK HAD DISCUSSED THE MATTER WITH FORD MORE THAN A HALF DOZEN TIMES AND FORD AT ONE POINT INDICATED HE WOULD TELL REPUBLICAN MEMBERS OF THE HOUSE BANKING COMMITTEE "WHAT THEY SHOULD DO ON THE DAY OF THE VOTE" (DEAN'S WORDS) ON WHETHER OR NOT TO LOOK INTO THE WATERGATE CASE.

BUT IN A STATEMENT TO NBC, COOK DENIED DEAN'S ALLEGATIONS, ACCUSING DEAN OF "VICIOUS LIES AND CLEVER DISTORTIONS."

"THERE IS NO QUESTION IN MY MIND THAT THE PRESIDENT TOLD THE TRUTH," SAID COOK, WHO NOW WORKS FOR AN AIRCRAFT COMPANY. HE DENIED CONTACTING FORD "DESPITE JOHN DEAN'S REPEATED AND FRANTIC REQUESTS" TO GET HIM TO DO SO.

DEAN SAID HE PASSED HIS OWN CONVERSATIONS WITH COOK ABOUT FORD ALONG TO TOP NIKON AIDE H.R. HALDEMAN, WHO, IN TURN, DISCUSSED THEM WITH NIXON.

"COOK WAS THE MAN WHO DID THE LEG WORK AND DEALT WITH MR. FORD AND THE OTHER MEMBERS OF THE (BANKING) COMMITTEE" WHICH WAS CONSIDERING PROBING AT LEAST ONE ASPECT OF THE WATERGATE INVESTIGATION, SAID DEAN.

"I CAN RECALL DICK COMING BACK AND TELLING, FOR EXAMPLE, HOW JERRY WAS GOING TO CALL A MEETING OF THE MINORITY MEMBERS IN LES ARENDS' (FORMER REPUBLICAN CONGRESSMAN FROM ILLINOUS) OFFICE OFF THE HOUSE FLOOR AND REALLY TELL THEM WHAT THEY SHOULD DO ON THE DAY OF THE VOTE AND HOW THEY SHOULD HOLD TOGETHER AND THINGS OF THIS NATURE," SAID DEAN.

DID THAT MEAN THEY SHOULD BLOCK THOSE HEARINGS FROM GOING FORWARD? DEAN WAS ASKED.

"THAT'S CORRECT," HE REPLIED.

DETROIT (UPI) -- THE FIRST OF 170,000 FORD MOTOR CO. WORKERS BEGAN RETURNING TO THEIR JOBS TODAY AFTER NARROWLY APPROVING A \$1 BILLION-PLUS THREE-YEAR CONTRACT IN THE 28TH DAY OF THE NATIONWIDE STRIKE AGAINST THE NO. 2 AUTO COMPANY.

THE APPROVAL, WHICH WAS ANNOUNCED LATE TUESDAY, CAME ON JUST A 489-VOTE MARGIN BY SKILLED TRADESMEN WHO HELD A VETO POWER OVER THE AGREEMENT DESPITE THE FACT THAT THEY ACCOUNT FOR JUST ONE OF EVERY SEVEN FORD JOBS.

THEY HAD COMPLAINED AN EXTRA 20 TO 25 CENTS AN HOUR PAY HIKE FOR THEM WAS NOT ENOUGH AND COMPLAINED THEY WERE OFTEN NOT REPRESENTED BECAUSE OF THEIR SMALL NUMBERS. IN THE END, THEY ALMOST WON THEIR POINT BY NEARLY SCUTTLING THE AGREEMENT AND FORCING IT BACK INTO NEGOTIATIONS.

THE FIRST WORKERS BACK ON THE JOB REPORTED TO THE LIVONIA, MICH., TRANSMISSION PLANT, FOUR WEEKS TO THE HOUR AFTER THE STRIKE BEGAN AT MIDNIGHT, SEPT. 14. THE THE ASSEMBLY PLANT AT WIXOM, MICH., WAS TO RESUME OPERATIONS IN THE AFTERNOON AND THREE MORE ASSEMBLY PLANTS WILL REOPEN THURSDAY.

DESPITE THE WORKER RECALLS, THE DAYS OF THE STRIKE WILL BE COUNTED UNTIL THE FINAL ONE OF 99 LOCAL AGREEMENTS IS REACHED. IN 1967, A NATIONAL AGREEMENT WAS RATIFIED IN THE 47TH DAY BUT THE FINAL LOCAL CONTRACT WAS NOT SETTLED UNTIL THE 66TH DAY.

FORD LABOR VICE PRESIDENT SIDNEY MCKENNA SAID THE FULL RETURN TO PRODUCTION WOULD COME ONLY AFTER THE REMAINING 29 OF 99 LOCAL AGREEMENTS ARE SETTLED. STILL TO BE RESOLVED ARE LOCAL PACTS AT SIX OF THE 19 ASSEMBLY PLANTS AND 13 OF 43 BASIC MANUFACTURING PLANTS.

THE NEXT STEP FOR THE UAW IS TO TAKE THE BASIC FORD AGREEMENT TO GENERAL MOTORS, CHRYSLER AND AMERICAN MOTORS TO GAIN NEW THREE-YEAR CONTRACTS FOR ANOTHER 530,000 WORKERS. A DECISION BETWEEN GM AND CHRYSLER AS THE NEXT "TARGET" WILL BE MADE SOMETIME THIS WEEK, A UAW SPOKESMAN SAID.

THE AGREEMENT THAT GIVES WORKERS UP TO 13 MORE PAID DAYS OFF BY THE END OF THE THIRD YEAR OF THE CONTRACT PLUS A WAGE BOOST OF AT LEAST 12 PER CENT FOR ASSEMBLERS ALMOST WAS DEFEATED BY SKILLED TRADESMEN. SEVENTY PER CENT OF THE 25,000 SKILLED TRADESMEN -- ELECTRICIANS, MILLWRIGHTS, CARPENTERS, TOOL AND DIE MAKERS AND EQUIPMENT REPAIRMEN -- VOTED AND APPROVED THE PACT BY A NARROW 8,957-8,468 MARGIN.

EVEN FEWER OF THE 145,000 PRODUCTION WORKERS -- ABOUT 40 PER CENT -- CAST BALLOTS IN THE FOUR-DAY RATIFICATION AND VOTED 35,192-22,026 TO APPROVE THE PACT.

A MAJORITY OF EACH GROUP HAD TO APPROVE THE PACT OR IT WOULD HAVE BEEN SENT BACK TO THE NEGOTIATORS WHO STARTED BARGAINING JULY 20. THE AGREEMENT CAME LAST TUESDAY IN THE 21ST DAY OF THE STRIKE.

STARTUP AND MAINTENANCE WORKERS WERE THE FIRST BACK ON THE JOB AT SOME OF THE 102 FORD FACILITIES IN 22 STATES. A FULL RETURN TO PRODUCTION WILL DEPEND ON SETTLEMENT OF OUSTANDING LOCAL ISSUES, FORD AND UAW OFFICIALS SAID.

THE FIRST CARS TO COME OFF AN ASSEMBLY LINE WILL BE AT WIXOM, MICH., WHERE 4,500 WORKERS RETURN ON THE AFTERNOON SHIFT TO BUILD THE LINCOLN CONTINENTAL AND CONTINENTAL MARK V MODELS. ANOTHER 6,600 WORKERS WILL BE CALLED BACK THURSDAY AT ASSEMBLY PLANTS IN LOS ANGELES, CHICAGO AND NORFOLK, VA.

MCKEŃNA SAID MANUFACTURINÓ PLANT START-UPS WOULD VARY AND EMPLOYES WILL BE CONTACTED BY THEIR PLANT MANAGEMENTS REGARDING CALLBACKS. FORD OF CANADA ON MONDAY BEGAN RECALLING SOME OF THE 10,000 WORKERS IT HAD IDLED BECAUSE OF THE U.S. STRIKE IN ANTICIPATION OF THE END OF THE STRIKE.

"WE ARE HOPEFUL THAT NEGOTIATIONS ON LOCAL ISSUES WHICH STLL HAVEN'T BEEN RESOLVED CAN BE CONCLUDED SOON SO THAT THE STRIKE CAN BE TERMINATED COMPLETELY AT ALL COMPANY LOCATIONS AND ALL OF OUR EMPLOYES MAY RETURN TO WORK," MCKENNA SAID. THE LOCAL ISSUES INVOLVE SUCH ITEMS AS CAFETERIAS, PARKING LOTS,

THE LOCAL ISSUES INVOLVE SUCH ITEMS AS CAFETERIAS, PARKING LOTS, WASHROOMS, PRODUCTION STANDARDS AND THE MORE CRITICAL HEALTH AND SAFETY PROBLEMS. A HOLDUP AT A KEY PLANT COULD LEAD TO A CONTINUED SHUTDOWN THAT COULD DISRUPT ALMOST ALL FORD PRODUCTION, SPOKESMEN SAID.

FEDERAL HEALTH OFFICIALS HAVE URGED SEVERAL STATES TO RESTART SWINE FLU IMMUNIZATION PROGRAMS SUSPENDED BECAUSE OF THE DEATHS OF SOME ELDERLY PERSONS FOLLOWING INOCULATIONS.

"ANYTIME YOU'RE INOCULATING LARGE NUMBERS OF PEOPLE THERE ARE GOING TO BE SOME COINCIDENTAL THINGS HAPPENING," SAID DR. DAVID SENCER, DIRECTOR FOR THE FEDERAL CENTER FOR DISEASE CONTROL IN ATLANTA.

HE STATED THERE WAS NO KNOWN CONNECTION BETWEEN THE REPORTED DEATHS OF SIX AGED PERSONS IN PENNSYLVANIA, FLORIDA AND OKLAHOMA AND THE GOVERNMENT'S \$135 MILLION IMMUNIZATION PROGRAM TO PROTECT AMERICANS FROM A POSSIBLE FLU EPIDEMIC THIS WINTER.

HEALTH AUTHORITIES IN AT LEAST TEN STATES HAVE SUSPENDED FLU SHOT PROGRAMS. TEMPORARILY SHELVED VACCINATION PLANS WERE ANNOUNCED IN ALASKA, ILLINOIS, LOUISIANA, MAINE, TEXAS, VERMONT, WISCONSIN, NEW MEXICO AND IN LARGE SECTIONS OF VIRGINIA AND PENNSYLVANIA.

KENTUCKY ANNOUNCED IT WOULD CANCEL ITS PROGRAM THURSDAY IF DOUBT OVER THE FLU VACCINE'S SAFETY REMAINED. SO FAR 118,000 PERSONS, MAINLY HIGH-RISK INDIVIDUALS, HAVE RECEIVED PREVENTIVE DOSES.

ADDITIONALLY, SEVERAL STATES THAT RECEIVED SOME OF THE SAME VACCINE INJECTED IN THE VICTIMS IN PENNSYLVANIA AND FLORIDA HAVE SHELVED IT. ABOUT 1.1 MILLION OF THE DOSES WERE MANUFACTURED BY PARKE DAVIS PHARMECUTICALS OF DETROIT, MICH.

IN PITTSBURGH, JULIA BUCCI, 75, CHARLES GABIG, 71, AND ELLA MICHAEL, 74, ALL OF WHOM HAD HEART DISORDERS AND OTHER AILMENTS, DIED MONDAY ABOUT TWO HOURS AFTER RECEIVING INOCULATIONS DURING A ONE-HOUR PERIOD AT THE SAME NEIGHBORHOOD HEALTH CLINIC.

IN FORT LAUDERDALE, SAUL GELMAN, 63, SUNRISE, FLA., DIED TUESDAY OF A HEART ATTACK 90 MINUTES AFTER RECEIVING THE SAME TYPE OF VACCINE ADMINISTERED TO THE PITTSBURGH VICTIMS.

A DIFFERENT BATCH OF VACCINE REPORTEDLY WAS INVOLVED IN THE OKLAHOMA DEATHS REPORTED TUESDAY. HEALTH OFFICIALS SAID JOE MALASKI, 71, OKLAHOMA CITY, WHO SUFFERED FROM HEART TROUBLE AND EMPHYSEMA, DIED FRIDAY HOURS AFTER BEING INOCULATED. AN ELDERLY UNIDENTIFIED OKLAHOMA WOMAN REPORTEDLY DIED UNDER SIMILAR CIRCUMSTANCES.

THE CDC HAS NOT STUDIED THE FLORIDA AND OKLAHOMA DEATHS, BUT AS IN THE PITTSBURGH CASES, LOCAL AUTHORITIES IMMEDIATELY DOUBTED ANY CONNECTION BETWEEN THE DEATHS AND THE IMMUNIZATION PROGRAM.

"WHEN YOU'RE DEALING WITH PEOPLE IN OLDER AGE GROUPS, THERE'S GOING TO BE A CERTAIN NUMBER OF PEOPLE WHO DIE WHETHER THEY HAVE THE FLU VACCINE OR NOT," SENCER SAID.

SENCER SAID THAT INITIAL CDC FINDINGS ON THE PITTSBURGH DEATHS --BASED ON AUTOPSY REPORTS, CDC EPEDEMIOLOGISTS FIELD STUDIES AND RESULTS OF THE IMMUNIZATION PROGRAM ELSEWHERE -- SHOWED THERE WAS NO CONNECTION TO THE FLU SHOTS.

RESEARCHERS AT THE FEDERAL BUREAU OF BIOLOGICS IN BETHESDA, MD., TUESDAY EXAMINED RESIDUE TAKEN FROM THE BOTTLES OF VACCINE USED TO INOCULATE THE PITTSBURGH VICTIMS.

CONNECTICUT GOV. ELLA GRASSO TODAY WAS SCHEDULED TO DRAMATIZE THE SAFETY OF THE SHOTS BY BEING INOCULATED PUBLICLY.

UNDER THE SWINE FLU PROGRAM PASSED BY CONGRESS, THE FEDERAL GOVERNMENT ASSUMES LIABILITY IN CASE A VACCINE RECIPIENT WANTS TO SUE FOR AN ADVERSE REACTION. IF THE PLAINTIFF WINS THE CASE, THE GOVERNMENT CAN THEN DECIDE IF IT, IN TURN, WANTS TO SUE THE VACCINE MANUFACTURERS.

IT WAS HOPED THAT BY THIS ARRANGEMENT, THE NUMBER OF SO-CALLED "NUISANCE SUITS" WOULD BE REDUCED.

PRESIDENT FORD IS USING BASEBALL TERMS TO SUGGEST THAT JIMMY CARTER ISN'T CAPABLE OF SERVING IN THE WHITE HOUSE.

FORD STAUNCHLY DEFENDED HIS TWO YEARS IN THE WHITE HOUSE IN AN APPEARANCE TUESDAY BEFORE A GROUP OF EDITORS IN NEW YORK, AND HE CRITICIZED CARTER FOR HIS CAMPAIGN STATEMENTS ON GOVERNMENT REORGANIZATION AND SPENDING.

"I THINK I HAVE HAD A GOOD BATTING AVERAGE," FORD SAID. "HE IS A MINOR LEAGUER. HIS SCORECARD WOULD NOT PUT HIM_IN THE BIG LEAGUES."

TUESDAY NIGHT, IN A SPEECH TO A \$1,000 A PLATE FUNDRAISING DINNER, FORD SAID HE HASN'T BEEN HIDING OUT -- "I'VE BEEN PLAYING HIDE AND SEEK. I'M TRYING TO FIND THE CANDIDATE WHO USED TO SAY THAT HE WOULD NEVER LIE TO YOU."

"I SAY PARENTHETICALLY, HE SEEMS TO HAVE DISAPPEARED," FORD ADDED. _WHILE FORD CAMPAIGNED IN NEW YORK CITY, CARTER WAS RESTING AT HOME IN PLAINS, GA. THE DEMOCRAT ISSUED A STATEMENT ACCUSING FORD OF DOING NOTHING TO COMBAT FRAUD IN THE MEDICAID PROGRAM WHILE PROPOSING THAT MORE MEDICARE PATIENTS PAY A BIGGER SHARE OF THEIR HOSPITAL BILL.

CARTER NOTED THE SOCIAL SECURITY ADMINISTRATION RECENTLY ANNOUNCED THAT PATIENTS IN THE PROGRAM WILL NOW HAVE TO PAY THE FIRST \$124 OF HOSPITALIZATION COSTS -- A 19 PER CENT INCREASE OVER THE PREVIOUS \$104.

IT HAS BEEN A MONTH SINCE A SENATE COMMITTEE REVEALED THAT BETWEEN \$3 BILLION AND \$5 BILLION IN MEDICAID FUNDS IS BEING LOST EACH YEAR THROUGH FRAUD, CARTER SAID, AND "STILL THE ADMINISTRATION HAS MADE NO RESPONSE AT ALL."

CARTER SAID HE WOULD RESTRUCTURE THE MEDICAID SYSTEM TO ELIMINATE FRAUD AND WASTE AS PART OF A GRADUAL PHASING IN OF A NATIONAL, COMPREHENSIVE HEALTH CARE SYSTEM.

FORD TOURED JEWISH, IRISH AND ITALIAN NEIGHBORHOODS IN NEW YORK, EACH TIME TOUCHING OFF LOUD CHEERS WHEN HE SAID HE WAS PRESIDENT OF A NATION AT PEACE.

"THERE IS NOT A SINGLE YOUNG AMERICAN FIGHTING OR DYING ON FOREIGN SOIL," FORD SAID REPEATEDLY.

BÉFORE LEAVING FOR NEW YORK, FORD TOLD ETHNIC LEADERS IN WASHINGTON THAT HE WAS MISTAKEN IN LAST WEEK'S DEBATE WITH CARTER WHEN HE SAID EASTERN EUROPE WASN'T DOMINATED BY THE SOVIET UNION.

"I DID NOT EXPRESS MYSELF CLEARLY. I ADMIT IT," FORD SAID. "... THE ORIGINAL MISTAKE WAS MINE."

"I THINK THE BUMPS ARE BEHIND US NOW," FORD LATER TOLD THE NEW YORK EDITORS.

INDEPENDENT CANDIDATE EUGENE MCCARTHY, IN AN INTERVIEW ON PUBLIC TELEVISION, SAID CARTER, IF ELECTED, WOULD "OVER-PERSONALIZE THE OFFICE AND I THINK THAT'S HIGHLY DANGEROUS IN EVERY RESPECT."

"WHEN CARTER BEGINS TO TALK ABOUT THE PRESIDENCY," MCCARTHY SAID, "I FIND HIM SAYING THINGS IN TERMS OF LANGUAGE THAT ARE VERY SIMILAR TO WHAT NIXON SAID, THE IDEA THAT IT IS A PERSONAL OFFICE, OR THAT NIXON SAID HE WAS THE MORAL LEADER OF THE COUNTRY."

IN MARYVILLE, TENN., GOP VICE PRESIDENTIAL NOMINEE ROBERT DOLE CHALLENGED CARTER TO REVEAL THE NAMES OF CORPORATE CONTRIBUTORS TO HIS 1970 CAMPAIGN FOR GOVERNOR OF GEORGIA.

DOLE SAID TWO ACCOUNTANTS WHO WORKED IN THE CAMPAIGN WITH CARTER CLAIM THERE WERE COMPUTER LISTS IDENTIFYING SUCH CONTRIBUTORS. DOLE SAID CARTER HAS SAID THERE ARE NO SUCH RECORDS.

WITH 17 MORE DAYS TO GO BEFORE ELECTION DAY, FORD IS TRYING RECOUP FROM WHAT HIS CAMPAIGN COUNSELORS CALLED A BLOOPER IN THE DEBATE WHEN HE SAID EASTERN EUROPE WAS NOT DOMINATED BY THE SOVIET UNION.

SINCE THEN FORD HAS ADMITTED HE MADE A MISTAKE -- THAT WITH 30 DIVISIONS IN EAST EUROPE, RUSSIA DOES "OF 'COURSE" DOMINATE THAT SPHERE. BUT NOW BEFORE CARTER HAD CHARGED FORD WAS "BRAINWASHED" ON HIS TRIP TO POLAND AND WAS "A DISGRACE TO OUR COUNTRY."

AFTER CARTER'S DRUMFIRE ATTACK, SOME OF HIS SUPPORTERS TOLD HIM TO COOL IT, THAT HE WAS COMING OFF "TOO SHRILL." THEY URGED THE DEMOCRATIC PRESIDENTIAL NOMINEE TO LET THE MEDIA POINT OUT FORD'S ERRORS.

FORD, ALSO AT THE URGING OF ADVISERS, HAS GONE ON THE OFFENSE, QUESTIONING CARTER'S FITNESS FOR THE PRESIDENCY AND HIS LEADERSHIP QUALITIES.

THE PRESIDENT, PERHAPS MORE THAN CARTER, HAS A LOT RIDING ON THE NEXT DEBATE -- WHICH WILL BE HELD NEXT FRIDAY IN THE HISTORICAL SETTING OF COLONIAL WILLIAMSBURG, VA.

SO FAR, THE POLLSTERS FIGURE FORD WON THE FIRST DEBATE, AND CARTER THE SECOND. BY ALL ODDS, FORD SHOULD HAVE WON THE SECOND DEBATE WHICH FOCUSED ON FOREIGN POLICY. THE THIRD AND LAST WILL BE MORE FREEWHEELING WITH THE PRESS PANEL PERMITTED TO ASK QUESTIONS ON ANY TOPIC.

FORD HAS BEEN ADVISED TO START WAGING A TOUGHER CAMPAIGN. HE IS STILL BEHIND IN THE POLLS, BUT BELIEVES THAT HIS BIGGEST TROUBLES ARE BEHIND HIM. HE HAS OTHER PROBLEMS, HOWEVER, WITH THE SPECIAL WATERGATE PROSECUTOR LOOKING INTO HIS CAMPAIGN RECORES WHEN HE AS A CONGRESSMAN FROM GRAND RAPIDS, VA.

FORMER AGRICULTURE SECRETARY EARL H. BUTZ' "GROSS INDISCRETION" IN MAKING A RACIAL SLUR AGAINST BLACKS LED TO BUTZ' RESIGNATION AND ALSO SHOOK THE FORD CAMPAIGN WHEN IT WAS ON THE UPSWING. AND NOW JOHN DEAN SAYS THE NIXON WHITE HOUSE TOLD FORD TO COOPERATE IN THE WATERGATE COVER-UP.

MUCH DEPENDS ON THE AMERICAN VOTERS AND THEIR PERCEPTIONS OF THE CANDIDATES, GOOFS AND ALL.

BOTH HAVE RUN ON PERSONAL APPEALS THAT THEY CAN THE TRUSTED. BOTH HAVE STUMBLED -- CARTER WITH HIS STATEMENT ON "ETHNIC PURITY" AND "BLACK INTRUSION."

to if he didnot have to. As the Republican vice presidential nominee describes it, few voters will even tune in Friday night to watch him and his Democratic counterpart, Sen. Walter F. Mondale, have a go at each other at the Alley Theater in Houston, Tex. Mere people will probably be attending high school football games, Dole has often said. Given a choice, he would too, he adds. But campaign aides say that despite Dele's constant belittling of the debate, he is actually taking it very seriously and has been spending almost all of his free time since Saturday boning up for it. Dole also notes that the debate will be 15 minutes shorter than the presidential debates = 75 minutes instead of 90.

"That in itself ought to be an inducement .. to watch it, he told a GOP fund-raising dinner Tuesday night in Maryville. Tenn. where he noted that Mondale was home studying while he was out campaigning. where he

"There will be no interruptions for commercials ... he told the same andience. "Probably no interruptions for anything. Probably nothing, period ...

period." Asked at & recent news conference to sum up how he thought the debate would come out, Dole responded: "Dull." The Kansas senator, whose sharp and often biting wit has made some campaign strategists claim he may turn in a better debate performance than President Ford, seems to be deliberately downplaying both the upcoming debate and his role in it. He frequently calls it the "Doyle and Mundale" debate, suggesting that many people den't even knew the names of the candidates. "We take ourselves too serieusly sometimes." he said recently. "We're not going to have any great impact on the election. I'm pretty mich constrained by what President Ford has said and Mondale is constrained by what Gov. Carter has said. We can't go out and make policy." policy."

Dole said here been preparing for the debate by "studying briefing

Dele said hers been preparing for the debate by "studying briefing books and reading Mondale clips" from newspapers. Press Secretary Larry Speakes said Dele has been studying the briefing books, which include those used by the President as well as some put together by Dele's own staff, "just about full time" since Saturday with the exception of a few campaign events. Dele belittles the upcoming debate almost as much as he does the office of vice president, a jeb he often claims has little going for it besides the fact that "it's indoor work with no heavy lifting." Dele also never misses an eppertunity te get in a jab at Mondale, often claiming, "I haven't selected my make-up man yet for Friday night but he's get his - George Meany." Dele has frequently made an issue of the AFL-CLO president's endersement of the Democratic ticket, claiming it means Democratic presidential candidate Jimmy Carter and Mondale are little more than puppets of Meany. 0313aED 10-13

"THE FACT IS THAT MR. CARTER'S WHOLE HOUSE OF CARDS IS BUILT NOT ON WHAT HE TELLS THE PEOPLE BUT ON WHAT HE REFUSES TO TELL THEM," THE GOP VICE PRESIDENTIAL CANDIDATE TOLD A CROWD OF ABOUT 500 AT A \$10-A-PLATE FUND RAISING DINNER IN MARYVILLE.

DOLE MET WITH FORD MONDAY AMID SPECULATION HE WOULD CARVE OUT A TOUGHER STAND AGAINST CARTER, BUT OBSERVERS SAID TUESDAY'S LANGUAGE WAS MILD COMPARED TO EARLIER CRITICISM.

RECALLING CARTER SAID THERE WERE NO RECORDS LEFT OF CONTRIBUTIONS TO HIS 1970 CAMPAIGN FOR GOVERNOR OF GEORGIA, DOLE SAID TUESDAY TWO ACCOUNTANTS WHO WORKED IN THAT CAMPAIGN, BILL LYNCH AND RICHARD HARDEN, HAVE SINCE SAID THERE WERE COMPUTER PRINT-OUTS OF SUCH DONATIONS.

"THEIR STORIES ON THE 1970 CAMPAIGN CONTRIBUTIONS ARE DIAMETRICALLY OPPOSED TO EACH OTHER," SAID DOLE, WHO CHALLENGED CARTER TO MAKE PUBLIC THE CORPORATE CONTRIBUTIONS TO HIS GUBERNATORIAL CAMPAIGN.

CARTER AIDES SAY THEY HAVE FOUND SOME LISTS GOING BACK TO THE 1970 CAMPAIGN AND WILL MAKE THEM PUBLIC, BUT THE RECORDS DO NOT DISTINGUISH BETWEEN SUPPORTERS AND CONTRIBUTORS OR LIST THE AMOUNTS OF CONTRIBUTIONS.

CARTER HAS "A CHANCE TO GIVE SUBSTANCE TO HIS CLAIM THAT HE DOESN'T OWE ANYBODY ANYTHING," DOLE SAID. "THAT MAY BE TRUE, OR IT MAY BE THAT HE HAS ALREADY PAID OFF WHOEVER HE OWED."

CARTER'S DENIAL IN THE OCT. 6 DEBATE THAT HE HAD RECOMMENDED A \$15 BILLION DEFENSE SPENDING CUT WAS ALSO QUESTIONED.

DOLE CITED TWO PUBLISHED REPORTS (SAVANNAH MORNING NEWS OF MARCH 18, 1975 AND LOS ANGELES TIMES OF MARCH 20, 1975) QUOTING CARTER AS RECOMMENDING THAT MUCH OF A CUT.

"HE IS DOCUMENTED ON THE EAST COAST AND ON THE WEST COAST AND THE SIMPLE FACT IS THAT MR. CARTER DID NOT TELL THE TRUTH IN THAT DEBATE." SAID DOLE.

CARTÉR'S AIDES SAY THE FORMER GOVERNOR DOES NOT RECALL MAKING SUCH A STATEMENT AND THAT HE WAS ON THE RECORD BEFORE AND AFTER THOSE DATES AS CALLING FOR DEFENSE CUTS OF \$5 TO \$7 BILLION.

CARTER RETURNS TO ACTIVE CAMPAIGNING THURSDAY WITH A THREE-CITY TOUR OF NEW YORK STATE AND THEN WILL TOUR MICHIGAN, MISSOURI AND OHIO BEFORE TAKING ANOTHER BREAK.

The judgment on the chemical bill was favorable. The Alabama widow, however, became the object of Ford's 61st veto. The ban on polychlorinated biphenyls, or PCBs, was part of the Toxic Substances Control Act. The new law authorizes the Environmental Protection Agency to block or limit the marketing of new chemical products judged to be harmful.

EPA can require manufacturers to conduct tests on new chemicals and must be given 90 days , notice before one is marketed.

The law specifically bans PCBs, a class of industrial chemicals linked with serious ailments in laboratory animals and recently detected by the EPA in human mothers; milk.

Ford's latest veto denied retroactive benefits to Pamela Hester of Foley Ala. the widow of John A. Hester, an Air Force employe who died in 1972.

She would be entitled to his civil service survivors; benefits, but for a legal quirk involving her prior diverce. Ford said he has signed other bills rectifying inequitable circumstances caused by the "length of marriage; requirement in the

dvil service retirement laws. But in this bill, he said he objected to provisions giving Mrs. Hester 6 per cent interest on the benefits accrued since 1972 and \$5,000 compensation for her trouble in collecting it.

Ford signed a measure compensating another widow, Alice Olson, for the death of her husband with \$750,000.

Dr. Frank Olson plunged to his death from a window in 1953 after unwittingly taking LSD in a Central Intelligence Agency experiment. The true cause of his death came to light in 1973. 0727aED 10-13

AM-Retail Sales, 200 MARCALL Sales, 200 WASHINGTON AP - Retail sales flattened out in September, marking the third month out of the last five that consumer buying has failed to show a significant increase, the government reported Tuesday. Since consumer sympting generated much of the force behind emergence from the reconside last year, the latest flattening is in line with other economic indicators and also signalled that no upsurge seems inginent.

The Genmerce Department said retail sales rese \$65 million for enc-tenth of one per cent, in September, to \$54.6 billion after adjustment for seasonal variations. for the

Adjustment for seasonal variations. At the same time, Commerce also revised downward the August increase in retail sales. The preliminary estimate of August sales had been set last month at 2.3 per cent, but Commerce said additional data made the advance figure 1 per cent. The major factor in the September performance was a 2.5 per cent decline in automobile sales. The decline in auto sales of \$347 million wane on the heels of a \$404 million increase in August. Aside from autos, the other major sectors were either flat or showed on increase of 2 per cent or less. 2225pHD 10-12

r a czcwyfzvt PM-Consumers 450 ANN ARBOR, Mich. AP - Consumers are more willing to spend money now than they were three months ago because of election prospects and increased confidence in the economy, says a report by University of Michigan researchers .

The report was released Tuesday by the university's Survey Research Center's director, Richard T. Curtin, and George Katona, survey founder. A total of 1,264 persons were interviewed in the poll. The researchers said the 5.6-point gain between May and early September brings the Index of Consumer Sentiment to 88.8 points, based on 100 points recorded in February 1966.

The most noticable improvements were noted in attitudes toward the long-term business outlook and in market conditions for purchase of large household durables, such as furniture and television sets, the economists said.

In an effort to gauge the impact of the upcoming presidential elections on consumer attitudes, respondents were asked which candidate they thought would do'a better job solving problems related to general business conditions, inflation and unemployment. The response was about evenly split at 33 per cent each between President Ford and Democrat Jimmy Carter. Ford held a slim 38 per cent

to 35 per cent lead over Carter on the issue of reducing the inflation rate.

inflation rate. On unemployment, however, Carter was favored 2-1 over Ford as having potential to do the best job. Respondents generally thought the new president, wheever he is, will improve business conditions. But, the researchers noted, data from past election years showed similar expectations, which dissipated after the elections. For the first time since the 1972 survey, the study reports, more upper-income families believe the next five years will bring good times rather than bad. While half of all families surveyed said they expect business conditions to remain the same in the next 12 months, the researchers said that is not an unfavorable sign, since current

conditions are better than a year ago. And for the first time in more than three years, a majority - 53 per cent - of all families felt it was a good time to buy large household durable goods .

Attitudes toward home buying also showed a marked improvement although the report noted such sentiment is not an indication of intent to buy. While 47 per cent felt it is a good time to purchase a bome, many of them cannot afford to do so. Showing a less marked improvement were attitudes toward changes in personal financial conditions. Fifty-three per cent said they are

financially better off than they were five years ago, compared with 49

WASHINGTON AP - Former White House counsel John W. Dean III said today that President Ford had a role - although probably an unwitting me - in the early stages of the Watergate cover-up.

Dean said the incident occurred during September and October 1972 when the White House was seeking to block a pre-election investigation of Watergate by the late Rep. Wright Patman's House Banking and Currency Committee.

President Richard M. Nixon, according to the White House tapes directed that then-House Minority Leader Gerald R. Ford be enlisted to

help block Patman's probe. It was not clear at the time, nor from Dean's just-published book on Watergate, whether Nixon's instructions were carried out or whether Ford actually discussed the matter with the Nixon White House.

At his confirmation hearings for vice president in 1973. Ford swore be had not talked to Nixon, chief of staff H. R. Haldeman, domestic aide John D. Ehrlichman or Dean about stopping the Patman hearings. But Ford added he was in almost daily contact with White House lobbyists, although he did not recall discussing the matter with any of them.

Dean in an interview broadcast by NBC as "Today show today said one of those lobbyists Dick Cook, did talk to Ford about the Patman strategy and reported back to the him on its progress.

*I can recall Dick coming back and telling, for example, how Jerry was going to call a meeting of the minority members . . . and really tell them what they should do on the day of the vote and how they should hold together . . Dean said.

Ford did not deny in his confirmation hearings that he sought to block the Patman inquiry. But he said he did so on his own initiative, and not at the behest of the White House.

NBC quoted Cook, now with the Lockheed Aircraft Corp., as saying: "Despite John Dean's repeated and frantic requests. I never spoke with Mr. Ford about the need to deny Mr. Patman's request for subpoena power ... the issue on which the investigation eventually was killed. NBC said Cook accused Dean of using vicious lies and clever distortions in his account, adding: "There is no question in my mind that the President told the truth o during his confirmation hearings.

White House Press Secretary Ronald Nessen, the network said, told MBC Ford would stand on his testimony and would have nothing to add. Dean, when asked to check his records regarding the contacts with Cook, reportedly said they showed about 15 contacts with the White House liaison, including nine telephone conversations between Sept. 6 and Oct. 12. In more than a balf dozen of those conversations, NSC

quoted Dean as saying, Cook reported on meetings with Ford about he Watergate problem.

Matergate problem. The Fatman committee eventually voted 20 to 15 to deny the chairman the subpeens power he needed to carry out a probe. All 15 Republicans on the committee and five Democrats united against Fatman. Dean was asked whether he thought Ford knew about the ongoing cover-up when he helped block the congressional investigation. "I don't think that anybody had briefed Mr. Ford or that Mr. Ford had any intimate knowledge as to what was going on '' Dean said. "I think it was very clear that the White House didn't want this investigation going on just before an election." "O

WASHINGTON AP - President Ford bad twice as much campaign money left to spend in the last five weeks before the election as Jimmy

Carter, according to finance reports made public today. Through Sept. 50. Ford had spent only \$5.5 million of the \$21.8 million he is allowed to spend in the general election under federal law. Carter, however, had spent \$12.5 million of his identical allotment.

That left Ford with \$13.3 million spending room compared to \$9.3 million for Carter - an edge that could prove critical in the final days of advertising blitzes and other last-minute efforts to win what is regarded as a close election Nov. 2.

However, the reports filed with the Federal Election Commission do not show whether, for example, Carter may have already spent money for media advertisements which have yet to appear, or whether Ford may havealready incurred obligations for which bills had not yet been received.

Both candidates, campaign committees are operating with federal funds for the first time in the nation's presidential election history. By accepting the taxpayer money, the candidates are forbidden from receiving any private contributions and are bound to the \$21.8 million spending limit.

Each mational party, however, can spend an additional \$3.2 million on behalf of its presidential candidate. During September, Carter was on the campaign trail much of the time while Ford ventured out only occasionally - one factor presumably leading to the difference in expenditures.

Carter also won his party's nomination five weeks earlier than Ford, meaning he's had more time in which to spend his funds so far. Costs of each candidate a running mate campaign also come out of the same allotment. 1047aED 10-13

WASHINGTON (UPI) -- INFORMED DIPLOMATIC SOURCES SAID WEDNESDAY THE UNITED STATES HAS AGREED TO SELL ISRAEL TWO NEW WEAPONS SYSTEMS WHICH HAVE NEVER BEEN SEEN IN THE MIDDLE EAST BEFORE -- A "CONCUSSION BOMB" AND AN INFRA-RED SYSTEM THAT CAN "SEE" IN THE DARK.

THE ARMS PACKAGE, WHICH PRESIDENT FORD APPROVED LAST WEEK WAS ANNOUNCED ON MONDAY AT THE WHITE HOUSE, BUT WITHOUT ANY DETAILS ON THE NEW ARMS INVOLVED.

THE INFORMED SOURCES SAID THAT THE NEW ARMS SALES WOULD COST A LITTLE LESS THAN \$200 MILLION, AND CONGRESSIONAL APPROVAL WILL BE REQUIRED WHEN CONGRESS RECONVENS AFTER THE FIRST OF THE YEAR.

ALTHOUGH BOTH SYSTEMS HAVE BEEN USED BY U.S. FORCES, NEITHER THE CONCUSSION BOMB NOR THE HEAT-SENSITIVE EQUIPMENT HAS EVER BEEN SOLD TO FOREIGN GOVERNMENTS OR NATO. DETAILS OF THE PROPOSED SALE LEAKED OUT WHEN PENTAGON AND STATE DEPARTMENT OFFICIALS EXPRESSED CONCERN AT WHAT THEY FEARED WOULD BE ANOTHER SIGNIFICANT STAGE IN A MIDDLE EAST ARMS RACE.

AS DESCRIBED BY PENTAGON SOURCES, THE CONCUSSION BOMB IS AN AEROSOL-LIKE DEVICE WHICH SPRAYS OUT A MIST OF INFLAMMABLE FUEL OVER AN AREA AS LARGE AS 700 SQUARE FEET. THE MIXTURE IS THEN IGNITED, KILLING ANYTHING LIVING IN THE AREA.

U.S. FORCES USED THE WEAPON IN THE LATE STAGES OF THE VIETNAM WAR TO CLEAR HELICOPTER LANDING ZONES AND TO KILL HEAVILY DUG-IN ENEMY TROOPS.

THE INFRA-RED HEAT SENSITIVE SYSTEM, WHICH IS USED BY THE U.S. FORCES MANNING THE SINAI OUTPOSTS BETWEEN EGYPTIAN AND ISRAELI FORCES, DETECTS MINUTE CHANGES IN TEMPERATURES, AND SPOTS THE MOVEMENT OF PEOPLE OR VEHICLES.

THE INFORMED SOURCES SAID THE DECISION TO SELL ISRAEL THE NEW EQUIPMENT WAS A PRESIDENTIAL DECISION AND THE TECHNICAL LEVELS OF THE PENTAGON AND THE STATE DEPARTMENT WERE NOT CONSULTED. THE SOURCES SAID THAT SUCH A PROCEDURE IS "NORMAL" ALTHOUGH THE KINDS OF WEAPONS INVOLVED MAY "BE MORE THAN ROUTINE."

THE ARMS SALE IS PART OF A PROJECTED \$10 BILLION PROGRAM STRETCHING OVER FIVE YEARS. THE NEW ARMS WILL NOT INCREASE THE TOTAL SIZE OF THE PACKAGE, SO SOME OLDER, CONVENTIONAL ARMS DELIVERIEIS WILL HAVE TO BE ELIMINATED, ACCORDING TO THE SOURCES.

"WE HAVE HEARD ALL FOUR SIDES OF THE TAX ISSUE -- THREE OF THEM FROM JIMMY CARTER," FORD SAID AT THE SECOND CAMPAIGN STOP OF THE DAY. "THE LIVELIEST DEBATE IS BETWEEN JIMMY CARTER AND JIMMY CARTER." HE SAID CARTER CLAIMED TO BE IN FAVOR OF A BALANCED BUDGET, BUT

OPPOSED FORD'S VETOES OF SPENDING BILLS.

"HE CAN'T HAVE IT BOTH WAYS, AND WE'RE NOT GOING TO LET HIM DO IT," FORD SAID.

He said that in the past four years more than \$30 billion have been handed out to 39 000 government units under the federal revenue-sharing plan, and said this "has held the state and local property taxes in check and promoted economic well-being in theusands of communities.

"With revenue sharing we are restoring local control over local decisions rather than leaving them in the hands of some bureaucrat in Wishington . >>

Ford said many Democrats in Congress had opposed the extension. "The Democrats in Washington don't trust local governments. The Democrats in Washington want to tell you how to run your state and local affairs, "the said. "They would make federal government bigger, more powerful and more expensive . ??

Ford jabbed at Carter, saying the Democratic presidential candidate has stated his opposition to general revenue sharing in its present form, but found use for \$141 million in such funds when he was governor of Georgia. A VIRGINIA HEALTH OFFICIAL TODAY ORDERED THE RESUMPTION OF THE STATE'S SWINE FLU IMMUNIZATION PROGRAM DESPITE THE DEATHS OF AT LEAST NINE ELDERLY PERSONS IN FIVE STATES WHO RECEIVED SWINE FLU SHOTS.

FEDERAL OFFICIALS STRESSED THAT THE DEATHS OF ELDERLY PERSONS INOCULATED AGAINST THE DISEASE WERE NOT RELATED TO THE VACCINE.

DR. ROBERT L. WOOD, HEAD OF THE VIRGINIA SWINE FLU INOCULATION PROGRAM, ORDERED THE PROGRAM RESUMED AFTER LEARNING FROM PENNSYLVANIA OFFICIALS THAT THE DEATHS OF THREE ELDERLY PERSONS THERE WERE UNRELATED TO THE VACCINE. VIRGINIA HAD SUSPENDED THE PROGRAM TUESDAY UPON FIRST LEARNING OF THE DEATHS.

"THE REASON WE SUSPENDED THE PROGRAM WAS BECAUSE WE DIDN'T KNOW ANYTHING ABOUT THE DEATHS, OTHER THAN THAT THE PEOPLE DIED AFTER RECEIVING SHOTS," HE SAID. WOOD ADDED HE HAD RECEIVED ASSURANCES FROM PENNSYLVANIA HEALTH

WOOD ADDED HE HAD RECEIVED ASSURANCES FROM PENNSYLVANIA HEALTH OFFICIALS THAT "THE DEATHS WERE UNRELATED TO THE VACCINE."

BUT MICHIGAN TODAY ORDERED A HALT TO ITS IMMUNIZATION PROGRAM FOLLOWING THE DEATHS OF TWO ELDERLY PERSONS AND HEALTH OFFICIALS IN NINE OTHER STATES TEMPORARILY SUSPENDED VACCINATION PROGRAMS. THEY SAID THEY WERE AWAITING WORD FROM FEDERAL RESEARCHERS ON WHETHER THE DEATHS COULD BE LINKED TO THE VACCINE.

FEDERAL HEALTH OFFICIALS HAVE ASSURED STATES THE SWINE FLU PROGRAM IS SAFE AND HAS URGED THOSE STATES WHICH SUSPENDED THEIR INOCULATION PROGRAMS TO RESUME GIVING SHOTS TO THE ELDERLY AND OTHER "HIGH RISK" PERSONS BEFORE THE FLU SEASON STRIKES THIS WINTER.

THE PROGRAM IS PART OF A NATIONWIDE, \$135 MILLION IMMUNIZATION EFFORT.

AT LEAST NINE PERSONS, ALL ELDERLY, IN FIVE STATES HAVE DIED FOLLOWING SWINE FLU SHOTS, OFFICIALS REPORTED. DEATHS FOLLOWING VACCINATIONS WERE REPORTED IN MICHIGAN, PENNSYLVANIA, OKLAHOMA, TENNESEE AND FLORIDA.

THE WHITE HOUSE SAID PRESIDENT FORD HAD BEEN INFORMED OF THE SITUATION, BUT THERE WAS NO FURTHER WORD EVEN THOUGH THE ADMINISTRATION-BACKED SWINE FLU PROGRAM APPEARS TO HAVE SUFFERED A SETBACK BECAUSE OF THE DEATHS AND SUSPENDED STATE PROGRAMS.

THERE WERE NO REPORTS OF PANIC FROM AROUND THE COUNTRY BECAUSE OF THE DEATHS.

"WE THOUGHT WE WOULD GET A RASH OF CALLS. THERE'S BEEN NOTHING AT ALL. THERE'S NO PANIC," SAID MRS. HELEN GOMEZ, A NURSE AT THE PLATTE COUNTY HEALTH DEPARTMENT CLINIC NORTH OF KANSAS CITY.

SHE SAID PERSONS COMING IN FOR SWINE FLU SHOTS WERE AWARE OF THE DEATHS.

"THEY'VE BEEN TELLING ME ABOUT IT," SHE SAID. "IT DOESN'T SEEM TO BOTHER THEM."

DR. LEO L. WALTER, DEPUTY COMMISSIONER FOR HEALTH AFFAIRS IN SOUTH CAROLINA, SAID SOME DEATHS FROM OTHER CAUSES FOLLOWING INOCULATIONS COULD BE EXPECTED.

WASHINGTON (UPI) -- GEN. ALEXANDER M. HAIG, COMMANDER OF ALLIED TROOPS IN EUROPE, SAID TODAY THAT HE EXPECTS CONFRONTATIONS WITH THE SOVIET UNION IN THE NEAR FUTURE WOULD PROBABLY BE IN THE THIRD WORLD -- BUT, NEVERTHELESS, MILITARY STRENGTH IN EUROPE MUST BE MAINTAINED.

IN A SPEECH TO A MEETING OF THE ASSOCIATION OF THE UNITED STATES ARMY, HAIG DISCUSSED THE LATEST SERIES OF MILITARY EXERCISES IN EUROPE, THE THREAT FROM THE SOVIET UNION AND ITS ALLIES, AND WHAT THE WEST MUST DO TO COUNTER IT.

"WHAT WAS ONCE AN ESSENTIALLY CONTINENTAL SOVIET MILITARY CAPABILITY CONFINED LARGELY TO EUROPE HAS TODAY BECOME A GLOBAL CAPABILITY PROVIDING THE SOVIETS THE POTENTIAL FOR AN IMPERIALIST PHASE IN THEIR FOREIGN POLICY," HE SAID. "MANAGING GLOBAL SOVIET MILITARY POWER HAS ACCORDINGLY_BECOME A MAJOR TASK FOR THE WEST."

HAIG SAID THE JOB OF STANDING UP THE RUSSIANS WILL DEPEND ON REGIONAL BALANCES OF POWER AND POINTED OUT THAT SOVIET PRIORITIES STILL RANK EUROPE HIGH ON THE LIST.

"HOWEVER," HE SAID, "I DON'T THINK THAT MEANS THE WEST IS LIKELY IN THE NEAR TERM TO SEE A DIRECT MILITARY CHALLENGE IN CENTRAL EUROPE.

"RATHER, IN CONFLICT TERMS, WE ARE FAR MORE LIKELY TO BE FACED WITH A CONTINUATION OF AMBIGUOUS, AMBILALENT SITUATIONS ON THE FLANKS AND PERIPHERY -- CHALLENGES RESULTING FROM THIRD WORLD DYNAMICS, AND WHICH MAY NOT EVEN RESULT FROM DELIBERATE SUPERPOWER INSTIGATION, BUT WHICH COULD EASILY INDUCE CONFRONTATION."

THEREFORE, HAIG CONCLUDED, "MANAGING THESE SITUATIONS WILL CLEARLY REQUIRE NATO TO MAINTAIN A MILITARY BALANCE FLANK TO FLANK."

HAIG'S OUTLOOK WAS OPTIMISTIC, SAYING THE ARMY IN EUROPE WAS "MAKING TREMENDOUS STRIDES. WHILE WE STILL HAVE SOME CRITICAL PROBLEMS OF EQUIPMENT, AMMUNITION, AND FORCED POSTURING, THE LEVEL OF PROFESSIONALISM AT EVERY ESCHELON HAS STRINGINGLY IMPROVED."

Associated Press Writer WASHINGTON AP - The new package of arms aid being arranged for Israel includes a tactical weapon used by the United States in Southeast Asia called the CBU - for cluster bomb units.

It was learned today that the CBU55 weapon will be provided Israel along with several other types of arms, including, as previously disclosed, a missile guidance system that uses infra-red rays to find targets .

The CBU is used primarily against tactical targets such as truck and petroleum depots and masses of tanks. For instance, the United States used CBUs in the early 1970s to clear belicopter landing zones in Southeast Asia.

Basically, a CBU sets off a concussive effect on a target that

crushes any object in the area. Israel has had CBUs in the past, but of less magnitude than the 55 series. The new arrangement will follow the old agreement under which Israel agreed not to use the bomb against civilian targets. Informed sources said that the sale of the bombs as well as the

infra-red targeting device is part of a series that may also include additional tanks.

So far, the value of the guidance systems and the CBUs total between \$150 million and \$200 million. Under federal law, the Ford administration must inform Congress once the actual offer has been made to Israel. Congress then has 30 days to specifically disapprove

the sale or it goes through. Administration officials said Congress probably would not be informed of the newest transactions until the new session begins next

January. The sale of the CBUs as well as the targeting system is part of a previously agreed-to aid program under which israel will get in excess of \$1 billion in military equipment. In other words, the newly disclosed transactions do not represent additional aid to the Jerusalem government. 1210pED 10-13

be meaningless. The jury said its members "do not have and cannot foresee, any agreement on any of the three indictments. The clerk read each separate indictment and on behalf of the jury,

AP - Campaigning in middle-class New York City suburbs, President Ford renewed his attacks on Jimmy Carter's positions on taxes and economic issues Wednesday, and promised his own administration would show "compassion for the American taxpayer." Reviving a previ ,ngGiused theme, the President repeatedly told crowds that Carter would raise taxes on middle-income Americans. "He's for higher taxes for people earning over \$14,000," Ford said. Carter has denied that, saying he wants to shift the tax burden to higher incomes, eliminate what he calls tax loopholes which benefit the rich and reduce taxes for lowers and middle-income which benefit

the rich, and reduce taxes for lower- and middle-income taxpayers. In a speech before a large crowd in front of the White Plains City Hall Ford said 'I say the middle-income taxpayer is already overtaxed, overburdened and underrepresented." Ford was the only one of the four national candidates on the

campaign trail, and attracted sizable crowds as he moved through the populous region of New York and New Jersey. He was to return to

Washington later in the day. Earlier, Ford signed a bill extending the multibillion dollar federal revenue-sharing program for another 32 years. The signing ceremony took place on the City Hall steps in Yonkers, a city which has suffered from financial difficulties similar to those of nearby New York City. Yonkers, the state is fourth largest city, came close to default last winter but was rescued by loans from the state and a consortium of banks.

Ford told the crowd at the signing ceremony that the revenue-sharing program, under which block grants go directly to state and local governments, has "begun to restore the necessary balance between the

federal government and local units of government. "That means you'in Yonkers, you in Westchester County will be making the decisions rather than some bureaucrat on the banks of the Potomac, and I have a lot more faith in you than I have in them.,, Ford went on to portray Carter as saying he is opposed to revenue sharing "in its present form., The President said Carter has described the revenue-sharing program

"A big hoax and a mistake . . . But he Carter apparently had no trouble finding uses for the \$140 million in general revenue-sharing funds that came to Georgia during his one term as governor of that state. He didn t send a single penny of that big boax revenue sharing back to Washington during those four years . ? ?

Carter has said he favors extending federal revenue sharing but with some changes, in particular to bypass the states and give money directly to local governments. This would give them more autonomy in using the money and also help relieve them of the need for new tax sources which are harder for cities to find than for states. Carter says. He also has said revenue sharing violates a basic principle of government in that it separates the responsibilities of raising and spending public funds.

Carter has put no specific price tag on his projected programs but says his measures to cut spending and improve the economy would produce \$60 billion in new revenue which would be used to pay for them.

He also has said no new programs would be launched until revenue was available to pay for them without a general tax increase.

Ford said Carter at one point favored elimination of the deduction on income taxes for home mortgage interest and then reversed himself. IN YONKERS, FORD SIGNED A \$25.6 BILLION REVENUE SHARING BILL AND CLAIMED THE PROGRAM HAD HALTED A TREND TOWARD "MORE CENTRALIZED GOVERNMENT" IN WASHINGTON.

INVESTIGATING "SOME" OF THEM. THE VICTIMS SUCCUMBED TO HEART ATTACKS. CDC MEDICAL DETECTIVES WERE "TYING UP LOOSE ENDS" IN THEIR ACTIVE FIELD INVESTIGATION IN PITTSBURGH, WHERE THE CASE BROKE TUESDAY, AND MAY RETURN TO GEORGIA BEFORE THURSDAY.

THEY CONCLUDED THE DEATHS OF THREE PERSONS AGED 71-75, WHO RECEIVED FLU SHOTS AT THE SAME NEIGHBORHOOD CLINIC IN PITTSBURGH MONDAY, MAY HAVE BEEN DUE TO STRESS, AND NOT CONTAMINATED VACCINE.

"JUST GETTING ON A TROLLEY (TO TRAVEL FOR A FLU SHOT) IS A STRESSFUL SITUATION FOR ELDERLY PEOPLE," SAID CDC EPEDIMIOLOGIST DR. PHILIP L. GRAITCER.

HE NOTED THAT TWO OF THE PITTSBURGH VICTIMS HAD ALSO EXPERIENCED EMOTIONAL STRAIN BY WATCHING THE THIRD VICTIM COLLAPSE AT THE HEALTH CENTER BEFORE RECEIVING THEIR SHOTS.

A NATIONWIDE SURVEY SHOWED THAT MANY PROGRAMS DID NOT EXPERIENCE A DROPOFF IN PARTICIPATION, BUT OTHERS DID.

IN SAN JOSE, CALIF., AN ESTIMATED 7,500 PERSONS, MOSTLY ELDERLY, TURNED OUT FOR FLU SHOTS ON THE OPENING DAY OF SANTA CLARA COUNTY'S PROGRAM. ONE WOMAN WAS TAKEN TO A HOSPITAL, BUT PHYICIANS SAID SHE ONLY SUFFERED FROM "ANXIETY AND FEAR."

"WE THOUGHT WE'D GET A RASH OF CALLS," SAID GREG HOBBINS OF A KANSAS CITY, MO., CLINIC. "THERE'S BEEN NOTHING AT ALL. THERE'S BEEN NO PANIC."

EDDIE BOURGEOIS, 74, WAS NEXT IN LINE AT THE ALBURG, VT., CLINIC WHEN STATE OFFICIÁLS ÓRDERED IT CLOSED.

"IF THEY REINSTATE THE INJECTIONS, I'LL GO BACK," HE SAID.

WASHINGTON (UPI) -- GOVERNMENT SOURCES SAID TODAY THAT NORMAL STATE DEPARTMENT AND PENTAGON CHANNELS WERE BYPASSED IN THE PRESIDENTIAL DECISION TO SUPPLY ISRAEL WITH TWO NEW WEAPONS SYSTEMS WHICH HAVE NEVER BEFORE BEEN SOLD TO OTHER COUNTRIES.

THE SOURCES DESCRIBE THE WEAPONS AS A FUEL AIR EXPLOSIVE (FAE) ANTIPERSONNEL CONCUSSION BOMB, AND A HIGHLY SOPHISTICATED FORWARD LOOKING INFRARED SYSTEM (FLIR) WHICH ENABLES PLANES AND ARTILLERY TO LOCATE AND DESTROY TARGETS AT NIGHT.

THE SOURCES SAID THE USUAL PROCEDURE IS FOR THE JOINT CHIEFS OF STAFF TO PREPARE A STUDY ON THE ADVISABLITY OF SELLING THE WEAPONS TO ANOTHER COUNTRY. THIS STUDY IS THEN CIRCULATED FOR COMMENT THROUGH THE GOVERNMENT.

"THIS WAS NOT DONE IN THIS CASE," ONE OFFICIAL SAID. "WE WERE NOT ASKED. IT WAS AN AREITRARY DECISION BY THE PRESIDENT. BUT, I SUPPOSE, THIS IS THE SEASON FOR THAT SORT OF THING."

THE OFFICIAL REFERRED TO THE DECISION BY PRESIDENT FORD BEING MADE PUBLIC AT A TIME WHEN HE HAD BEEN CRITICIZED BY JIMMY CARTER FOR NOT GIVING ENOUGH ASSISTANCE TO ISRAEL. THE WHITE HOUSE HAS DENIED THE DECISION WAS POLITICALLY MOTIVATED AND SAID IT HAD BEEN UNDER CONSIDERATION FOR SEVERAL WEEKS.

DEFENSE MINISTER SHIMON PERES SHRUGGED OFF SUGGESTIONS OF POLITICAL MOTIVATION, SAYING THE UNITED STATES IS "A DEMOCRATIC COUNTRY AND THEY HAVE ELECTIONS ALL THE TIME."

U.S. OFFICIALS SAID THE FAE BOMB, DEVELOPED BY THE U.S. NAVY FOR USE IN VIETNAM, IS A VARIATION ON AN AEROSOL SPRAY, A INFLAMMABLE MIST IS SPRAYED OVER AN AREA UP TO 700 SQUARE FEET, AND THEN IGNITED. IT KILLS EVERYTHING LIVING IN THE EXPLOSIVE AREA EITHER THROUGH CONCUSSION OR SUFFOCATION.

THE FLIR SYSTEM, WHICH IS USED ON AMERICAN A7, F4 AND E52 AIRCRAFT, PERMITS THE PILOT TO DETECT AND DESTROY HUMAN BEINGS OR VEHICLES FROM THE HEAT THEY EXUDE. IT IS A HIGHLY ADVANCED SYSTEM WHICH HAS NOT YET BEEN GIVEN TO NATO ALLIES.

LEGALLY, THE ADMINISTRATION COULD PUT THROUGH THE ISRAELI ARMS DEAL WITHOUT CONGRESSIONAL APPROVAL.

BUT SINCE CONGRESS IS IN RECESS, THE 30 DAYS WOULD ELAPSE WITHOUT THE KEY COMMITTEES TAKING THE REQUIRED VOTE AND THE SALE COULD PROCEED. IN PRACTICE, SAID U.S. OFFICIALS, THE ADMINISTRATION WILL NOT TRY TO SNEAK THE DEAL THROUGH, SINCE IT COULD AROUSE CONGRESSIONAL OPPOSITION TO FUTURE DEALS.

President Ford had the campaign stump all to bimself Wednesday as he signed the renewal of federal revenue sharing and attacked Jimmy Carter's economics. He toured middle-class areas around New York City while the other candidates stayed home. Carrying familiar themes to new platforms in half a dozen New York

and New Jersey cities. Ford treated his audiences to a catalogue of what he called Carter's contradictions on tax and economic issues. He picked a financially distressed city with a Republican mayor -Yonkers. N.Y. - in which to sign the 45-month revenue sharing extension that will provide states and cities with \$25.5 billion.

In Plains, Ga., Carter was keeping a promise to devote two days to his family rather than to his campaign. On Thursday he planned a trip to New York state which would give him extensive exposure in some of the same media markets that Ford hit Wednesday and Thursday.

Meanwhile, not a peep was heard from vice presidential canidates Walter Mondale and Bob Dole. Aides said they spent the day in the

company of briefing books and advisers, preparing for their debate Friday in Houston. Tex. At the signing ceremony in Yonkers, hard beside equally troubled but Democratic-controlled New York City, Ford said Democrats in Congress had balked at renewing revenue sharing and that Carter wants to alter

the program. Unlike most other federal aid programs, revenue sharing provides money that states and cities can spend on virtually whatever they chose. "That means you in Yonkers, you in Westchester County will be making the decisions rather than some bureaucrat on the banks of the Potomac, " Ford said .

The President said Carter has called revenue sharing "a big boax and a mistake . ? ?

Carter apparently had no trouble finding uses for the • But be \$140 million in general revenue sharing funds that came to Georgia during his one term as governor of that state, . Ford said. "He didn't send a single penny of that big boar revenue sharing back to

Washington during those four years Carter has said he program ought to be extended but revised to omit states and go to cities only, because he thinks local governments cannot generate tax revenue so easily as states can.

Before a crowd of 15,000 in White Plains, N.Y., Ford said, "The liveliest debate of this campaign has been between Jimmy Carter and Jimmy Carter . ? ?

Running through what he called Carter's inconsistencies. Ford said: "He says he's for a balanced budget, but he refused to support my 60 vetoes that have saved the American taxpayer \$9 billion." "He says America is weak militarily, but he wants to cut the defense budget by \$15 billion.

Carter says the United States is the world's strongest nation militarily but is weak over-all because of its domestic economic problems and what he calls a lack of respect abroad. In several appearances. Ford told crowds Carter would raise taxes on middle income Americans. ""He's for higher taxes for people earning over \$14,000 ** Ford said.

over \$14,000, "Ford said. Carter has said he wants to raise taxes in higher income brackets and reduce them for lower and middle income Americans. In a September interview with The Associated Press, Carter was asked what he thought of as higher. He replied, "I don't know. I would take the mean or median level of income and anything above that would be higher and anything below that would be 'lower." Then it was pointed out that median family income was around \$12,000 and persons earning \$15,000 a year were not thought of as

\$12,000 and persons earning \$15,000 a year were not thought of as rich, and Carter said, "I understand. I can't answer that question because I haven't gone into it. I don't know how to write the tax code now in specific terms . ;;

Aides said later Carter thought of middle income as up to \$25,000 a year .

In another development, finance reports filed with the Federal Election Commission showed Ford had twice as much campaign money left to spend in the last five weeks before the election as Carter.

Through Sept. 30. Ford had spent only \$3.5 million of the \$21.8 million allotted to each candidate under federal law. Carter had spent \$12.5 million.

The difference may have resulted from Carter's almost constant travel during September, which Ford spent mostly at the White House. But the reports do not show whether Carter may have already spent money for advertisements which have yet to appear or whether Ford may have already incurred obligations for which bills had not yet been received .

A CARTER SPOKESMAN WAS QUOTED BY ANDERSON AS SAYING THAT THE DEMOCRAT HAD DONE NO FAVOR IN EXCHANGE FOR THE EXPENSE PAID TRIP. SINCE THE AIRCRAFT WAS MADE IN MARRIETTA, GA., THE THEN-GOVERNOR FELT IT WAS PROPER TO PUSH GEORGIA PRODUCTS.

ACCORDING TO THE LETTER QUOTED BY ANDERSON, CARTER PROMISED TO WORK "PRIVATELY AND PUBLICLY" TO PROMOTE THE FIRM'S C130.

FORD, TRYING TO PROJECT AN AGRESSIVE IMAGE IN THE FINAL THREE WEEKS BEFORE THE ELECTION, STUMPED IN NEW YORK CITY'S SUBURBS AND TOOK SLAPS AT WHAT HE CLAIMED WERE CARTER'S INCONSISTENCIES.

"WE HAVE HEARD ALL FOUR SIDES OF THE TAX ISSUE -- THREE OF THEM FROM JIMMY CARTER," FORD SAID ON THE STEPS OF CITY HALL IN WHITE PLAINS, N.Y. "THE LIVELIEST DEBATE IS BETWEEN JIMMY CARTER AND JIMMY CARTER."

Associated Press Writer WASHINGTON AP - Increased production loan rates for wheat and feed grains were announced Wednesday by the Ford administration. Increases had been urged by many farmers and also by the Democratic presidential candidate. Jimmy Carter. Acting Agriculture Secretary John A. Knebel denied that the increased rates were "in response to Jimmy Carter's cries.", "They were a result of a commitment the President has made to American agriculture." Knebel said at a press conference in announcing the new rates. Production loans are used with the error as security to finance

Production loans are used, with the crop as security, to finance planting and other production expenses or at the end of a harvest to allow farmers to hold their crops until they can get a better market price.

The loan rate for wheat was increased 50 per cent from \$1.50 to \$2.25, while the rate for corn was increased 20 per cent from \$1.25 to \$1.50. The rate for soybeans remained at \$2.50 per bushel. Knebel said the rates would apply immediately to 1976 crops as well as next year's crops. He said that the move was not political but a "necessary and

appropriate way to bridge the gap,, between a tight credit situation in counties dominated by grain producers and the "very bountiful barvest, of grains reflected in Tuesday, USDA crop report. That report showed a crop of a record 5.87 billion bushels of corn a near-record 2.13 billion bushels of wheat and over-all 183 million

metric tons of feedgrains.

After that report came in Knebel told reporters, he sent a series of options to the White House at Ford's direction, but made no specific recommendation on the loan rates which wheat growers have said for months were too low. 16490ED 10-13

BRUSSELS (UPI) -- THE U.S. DOLLAR BROKE THE 5-FRANC BARRIER FOR THE FIRST TIME SINCE MID-AUGUST WEDNESDAY, AND INDICATIONS WERE THE GOVERNMENT INTENDED TO LET THE FRENCH CURRENCY FIND ITS LEVEL. THE POUND IMPROVED SLIGHTLY AGAINST THE DOLLAR BUT FELL AGAINST EUROPEAN CURRENCIES.

THE PRICE OF GOLD CLOSED 25 CENTS HIGHER IN LONDON AND ZURICH. CLOSING AT \$114.875 AND \$114.84 RESPECTIVELY, DEALERS SAID THE MARKET WAS QUIET.

IN PARIS. THE BANK OF FRANCE MADE NO EFFORT TO HALT FRANC'S THE SLIDE TUESDAY AND INTERVENED ONLY MARGINALLY WEDNESDAY AS THE DOLLAR TOPPED 5 FRANCS FOR THE FIRST TIME SINCE MID-AUGUST. IT CLOSED AT 5.0155 AGAINST 4.9935 TUESDAY. THE FRANC TOUCHED RECORD LOWS IN FRANKFURT AND ZURICH.

BANKERS IN PARIS SAID THE FRANC'S WEAKNESS WAS LARGELY DUE TO THE ABSENCE OF ANY IMMEDIATE ACTION BY THE GOVERNMENT TO CUT THE COUNTRY'S \$3 BILLION BALANCE OF PAYMENTS DEFICIT. THEY ANTICIPATED THE TREND WOULD CONTINUE UNTIL NEW AUSTERITY MEASURES SUCH AS

WAGE -PRICE GUIDELINES TAKE EFFECT NEXT YEAR. BANKERS SAID THE LACK OF INTERVENTION BY FRANCE'S CENTRAL BANK INDICATED THE GOVERNMMENT'S INTENTION TO LET THE FRANC FIND ITS OWN LEVEL .

IN LONDON, STERLING IMPROVED AGAINST THE DOLLAR CLOSING AT \$1.6545 AGAINST \$1.6530 TUESDAY, BUT FELL AGAINST THE MARK AND THE SWISS

THE RADIO SAID THE PLANE FELL ON A SCHOOL IN THE TOWN IN THE TROPICAL LOWLANDS OF CENTRAL BOLIVIA AND THAT "ABOUT 100 PERSONS WERE KILLED." IT GAVE NO FURTHER IMMEDIATE DETAILS.

Q. There are press reports today that the DNC will file a complaint with the Federal Election Commission alleging that members of the White House staff who are on the public payroll are doing campaign work in violation of the campaign funding law. Do you think it is fair for you to use White House employees for campaign purposes when Jimmy Carter must use his limited campaign

funds to support his entire staff?

We have bent over backwards to operate completely within the new campaign law. Any campaign expense incurred by a member of my White House staff is paid by my Campaign Committee. Any campaign work they do is done on their own them -- in addition to fully performing their official duties.

The simple fact is that I must continue to exercise the responsibilities of the Presidency even while I am campaigning. This requires me to do both jobs and often my staff must do likewise.
