Dear Mr. Lynn:

Pursuant to the provisions of Section 605 of Title 28, United States Code, I submit for your consideration and transmittal to the Congress a request for an amendment of the Judiciary's budget for fiscal year 1976 to include the sum of \$3 million for the participation of the courts in the observance of the American Revolution Bicentennial. It is proposed that the appropriation remain available until expended. We plan to allocate the funds to the respective United States courts of appeals and district courts so that they may participate in programs and projects on a local level as well as on a national level. The proposed language for this appropriation is as follows:

> "For expenses to be incurred by the Judiciary in the observance of the American Revolution Bicentennial, \$3,000,000, which sum shall be available for allocation by the Administrative Office of the United States Courts to the respective United States courts of appeals and district courts and for programs or projects conducted on a national level, to remain available until expended."

This request for \$3 million was included in the President's Budget Message to the Congress as an item

for later transmittal based on existing legislation. The
request, therefore, has already been taken into account
--but has not yet been formally submitted for consideration.

Your expediting the transmittal of this request would be greatly appreciated considering the fact that our Hearings before the House Appropriations Committees has been scheduled for the last week of February.
