The Committee consists of the Attorney General, The Secretary of HEW, the Secretary of Labor, the Director of the Special Action Office for Drug Abuse Prevention, the Secretary of Housing and Urban Development, the Assistant Administrator of the Office of Juvenile Justice and Delinquency Prevention, the Deputy Assistant Administrator of the Institute for Juvenile Justice and Delinquency Prevention, or their respective designees and twenty-one members appointed by the President.

The Committee was established by Public Law 93-415 of September 7, 1974, to make recommendations to the Administrator of the Law Enforcement Assistance Administration at least annually with respect to planning, policy, priorities, operations, and management of all Federal juvenile delinquency programs. The Committee shall meet at the call of the Chairman but not less than four times a year.
