This request will enable the Department of Commerce to assume a leadership role for energy conservation in the American business community. For expenses necessary to carry out the provisions of the Offshore Shrimp Fisheries Act of 1973, \$230,000 to remain available until expended.

Fishermen's Guaranty Fund

For an additional amount for the "Fishermen's Guaranty Fund", \$1,910,000 to remain available until expended.

These proposed supplemental requests will provide compensation for enforcement and surveillance services provided by Brazil in conjunction with U.S. shrimp fishing off the coast of that country, and will provide for compensation to participating vessel owners and crews for losses incurred as a result of fishing vessel seizures by foreign governments.
