Dear Mr. Lynn:

Included in the fiscal year 1975 appropriation of \$3,319,000.00 for Furniture and Furnishings, Library of Congress, was a non-recurring item for \$20,000.00 to purchase two exhibit cases for the Gutenberg Bible and the Giant Bible of Mainz. needed exhibit cases must be custom designed to incorporate features not currently available from commercial sources. It is now apparent that we will not be able to complete the design in time to award a fabrication contract and obligate the funds before June 30, 1975. Therefore, I am requesting that the \$20,000.00 appropriated for this purpose in fiscal year 1975 remain available until June 30, 1976. I propose the following appropriation language be added to the fiscal year 1976 appropriation for Furniture and Furnishings, Library of Congress:

> Not to exceed \$20,000.00 of the unobligated balance of the appropriation under this heading for the fiscal year 1975, which would have otherwise lapsed, is hereby continued available until June 30, 1976.

The necessary budget schedules to affect this action are enclosed. The Chairmen of both the House and Senate Subcommittees on Legislative Branch Appropriations have been apprised of this request.
