The proposed amendments would provide additional funds for the Animal and Plant Health Inspection Service to meet the 50 percent Federal share under the cooperative Federal-State meat and poultry inspection program. These funds will enable the States to continue to provide the required level of protection to consumers.

The proposed amendments would:

- 1. Provide funds to pay landowners and operators for carrying out agricultural conservation practices. A proposal to rescind the authority to enter into such cost-sharing contracts during the authorized period of July, 1974, through December, 1975, was not approved by the Congress.
- 2. Provide funds to indemnify beckeepers who, through no fault of their own, have suffered losses as a result of the use of economic poisons which had been registered and approved for use by the Federal Government. The claims for such indemnities have exceeded the amounts previously estimated.
