#### SOCIAL AND REHABILITATION SERVICE

### SPECIAL ASSISTANCE TO REFUGEES FROM CAMBODIA AND VIETNAM IN THE UNITED STATES

The amount provided under this head in Public Law 94-24 (89 Stat. 89) of May 23, 1975, shall be, upon enactment into law of H.R. 11473 (94th Congress) or similar legislation, available to assist refugees from Cambodia, Vietnam, and Laos in the United States.

This proposal would allow the use of previously appropriated funds to assist refugees from Laos, in addition to refugees from Cambodia and Vietnam whose assistance is presently allowed by Public Law 94-24.

### ADMINISTRATION OF FOREIGN AFFAIRS

### PAYMENT TO CONDITIONAL GIFT FUND, GENERAL

For payment to the Conditional Gift Fund, General, as authorized by Public Law 94-141, for the purpose of furnishing or refurnishing the diplomatic reception rooms of the Department of State, not to exceed \$125,000, to remain available until expended: Provided, That payment shall be made upon the deposit of an equivalent amount in the general fund of the Treasury pursuant to the bequest made by the late Ambassador Walter Thurston to the United States.

This supplemental appropriation will allow an amount equal to the bequest of Ambassador Thurston to be used as intended by section 103 of the Foreign Relations Authorization Act, Fiscal Year 1976.

#### INTERNATIONAL ORGANIZATIONS AND CONFERENCES

INTERNATIONAL CONFERENCES AND CONTINGENCIES

For an additional amount for "International conferences and contingencies", \$1,325,000, to remain available until December 31, 1976, and of which not to exceed \$10,000 may be expended for representation allowances as authorized by section 901 of the act of August 13, 1946, as amended (22 U.S.C. 1131) and for official entertainment.

This supplemental appropriation is required to support United States participation in the Conference on International Economic Cooperation (CIEC) and its associated commissions in Paris. The Conference is expected to end in December 1976.

#### OTHER

### SPECIAL ASSISTANCE TO REFUGEES FROM CAMBODIA AND VIETNAM

The amount provided under this head in Public Law 94-24 (89 Stat. 89) of May 23, 1975, shall be, upon enactment into law of H.R. 11473 (94th Congress) or similar legislation, available for the relocation and resettlement of refugees from Cambodia, Vietnam, and Laos.

This proposal would allow the use of previously appropriated funds to relocate and resettle refugees from Laos, in addition to refugees from Cambodia and Vietnam for whom provision was made in Public Law 94-24.
