The President departed the Marriott about two minutes late and proceeded directly to his lime for an uneventful ride to the High School. Upon arriving he was taken to a holding room and separated from your pool until he appeared in the gym.

After finishing up in the gym, Ford walked to the adjoining field house where 700 or 800 spectators overflow had been waiting. He thanked them for being so patient and offered to take four questions. One was a question about individual freedoms including the freedom to send your kids to the school of your choice. Ford reiterated his opposition to courtordered busing to achieve racial balance.

He was asked if he would support Reagan if the latter got the nomination. "I don't deal in speculation," he said. "I deal in reality, and I firmly believe we're going to get the nomination. So I deal in the facts of life. I've always supported the Republican candidate but in this case I think I'm going to be the nominee. "
