Sir:

I ask the Congress to consider, for the Judiciary, fiscal year 1976 and transition quarter supplemental appropriations and an amendment to 1977 appropriations requested in the 1977 budget. The requests are in these amounts: \$2,313,000 for fiscal year 1976, \$735,000 for the transition quarter, and \$964,000 for fiscal year 1977.

The details of these proposals are set forth in the enclosed letter from the Director of the Administrative Office of the U.S. Courts.

As required by law, these requests are transmitted without change.

Dear Mr. Lynn:

Pursuant to the provisions of Section 605 of Title 28, United States Code, I submit for your consideration and transmittal to the Congress requests for supplemental appropriations for the Judiciary for fiscal year 1976 and the transition quarter, as well as an amendment for fiscal year 1977 as indicated in the attached schedules.

Fees of Jurors

With regard to "Fees of Jurors," the supplemental requests of \$2,000,000 for fiscal year 1976 and \$500,000 for the transition quarter are based on payments of juror fees and allowances for the first eight months of fiscal year 1976 which averaged 14 percent over the same period of fiscal year 1975. If this trend continues, our obligations for fiscal year 1976 will approximate \$20,000,000, or \$2,000,000 in excess of the amount presently available. There has been an increased use of grand juries as a result of the enactment of Speedy Trial legislation. We have also experienced an increase in petit jury trials which is due to an effort by the courts to reduce their backlog of criminal cases.

Salaries and Expenses of Referees

With regard to "Salaries and Expenses of Referees," the supplemental requests of \$313,000 for fiscal year 1976 and \$235,000 for the transition quarter, and the amendment to the fiscal year 1977 budget increasing our pending request by \$964,000, are required to fund statutory increases provided by Public Law 94-217, approved on February 27, 1976. This Act raised the salaries of full-time bankruptcy judges from \$33,200 to \$37,800, effective March 1, 1976. The supplemental requests and the amendment represent increases in compensation and benefits under the Act. Honorable James T. Lynn Page two

We would appreciate your giving this matter your early attention. It is imperative that the funds be made available before the end of the fiscal year to obviate deficiencies which may force a suspension of jury trials and defer the payment of the salaries of bankruptcy judges.
