Sir:

I ask the Congress to consider, for the Department of Transportation, a request for a fiscal year 1976 supplemental appropriation and an amendment to fiscal year 1977 appropriations requested in the 1977 budget. New budget authority is requested in the amount of \$2,500,000 for fiscal year 1976 and \$1,390,000 for fiscal year 1977.

The details of these proposals are set forth in the enclosed letter from the Director of the Office of Management and Budget. I concur with his comments and observations.

Facilities, Engineering and Development

For an additional amount for "Facilities, engineering and development", \$2,500,000, to remain available until expended.

The supplemental appropriation would allow the Federal Aviation Administration to expedite civil aviation security efforts currently underway, develop new techniques for explosives detection, and modify an existing government facility for explosives testing.

unobligated balances in the appropriations for "Civil Supersonic Aircraft Development" and "Civil Supersonic Aircraft Development Termination" may be transferred to this account for necessary expenses to conduct a study of high altitude pollution:

The proposed additional amount of \$1,390,000 would allow the Federal Aviation Administration to increase civil aviation security research and development efforts to develop prototype detection hardware and improved security systems. Reprogramming from within this account from funds available to purchase an aircraft will provide an additional \$1.2 million for security research. The proposed appropriations language would permit the transfer of funds into the expanded High Altitude Pollution Program (HAPP).
