

I ask the Congress to consider, for the legislative branch, fiscal year 1976 supplemental appropriations, and amendments to 1977 appropriations requested in the 1977 budget. Budget authority requests total \$531,000 for fiscal year 1976, and \$1,374,000 in new budget authority and \$494,000 in reappropriations for fiscal year 1977.

The details of these proposals are set forth in the enclosed letters from the Architect of the Capitol and the Public Printer and the attachments. As required by law these requests are submitted without change.



Not to exceed \$193,500 of the unobligated balance of that part of the appropriation under this head for the fiscal year 1975, continued available until June 30, 1976, is hereby continued available until September 30, 1977.

CAPITOL GROUNDS

Insert the following language, under this heading, immediately after the 1977 appropriation text on page 21 of the 1977 Budget Appendix:

Not to exceed \$94,500 of the unobligated balance of the appropriation under this head for the fiscal year 1976 is hereby continued available until September 30, 1977.

SENATE OFFICE BUILDINGS

Insert the following language, under this heading, immediately after the 1977 appropriation text on page 22 of the 1977 Budget Appendix:

Not to exceed \$120,000 of the unobligated balance of the appropriation under this head for the fiscal year 1975, continued available until June 30, 1976, is hereby continued available until September 30, 1977.

LIBRARY BUILDINGS AND GROUNDS
STRUCTURAL AND MECHANICAL CARE

Insert the following language, under this heading, immediately after the 1977 appropriation text on page 25 of the 1977 Budget Appendix:

Not to exceed \$71,000 of the unobligated balance of the appropriation under this head for the fiscal year 1976 is hereby continued available until September 30, 1977.
