- By a record vote of 227 yeas to 162 nays, the House passed H.R. 4690, to increase the public debt limit set forth in section 21 of the Second Liberty Bond Act.
- Prior to final passage, by a record teller vote of 180 yeas to 212 nays, the House rejected an amendment by Mr. Patman that sought to strike out section 3 (authorizes issuance of \$10 billion of Federal bonds without regard to the 4½ percent interest limitation).
