UNDER THE INTERGOVERNMENTAL PERSONNEL ACT, THE CIVIL

SERVICE COMMISSION IS NOW ASSISTING STATE AND LOCAL GOVERNMENTS BY FUNDING IMPROVED TESTING AND SELECTION PROCEDURES.

A PRESIDENTIAL EXECUTIVE ORDER FORBIDS DISCRIMINATION WHEN STATE AND LOCAL UNITS ARE INVOLVED IN FEDERAL CONTRACTING. WITH GENERAL REVENUE SHARING NOW A REALITY, AND WITH OTHER SPECIAL REVENUE SHARING BILLS PENDING BEFORE THE CONGRESS, THE SEVERAL STATES AND THE MANY MUNICIPALITIES WILL FIND THE FEDERAL GOVERNMENT LOOKING OVER THEIR SHOULDERS IN THE AREA OF CIVIL RIGHTS. STATE AND LOCAL GOVERNMENTS CAN BE ASSURED OF ENFORCEMENT BY THE FEDERAL GOVERNMENT WHENEVER FEDERAL FUNDS ARE INVOLVED.

THE ELIMINATION OF DISCRIMINATORY PRACTICES AND THE GENERAL ADVANCEMENT OF HUMAN RIGHTS HAS BEEN ONE OF THE HIGHEST PRIORITIES OF MY OFFICE.

THROUGHOUT THE VARIOUS DEPARTMENTS OF THE EXECUTIVE BRANCH THERE ARE DEDICATED PUBLIC SERVANTS, MANY OF WHOM MAY BE A MEMBER OF YOUR GROUP, WHO ARE WORKING AT

ELIMINATING DISCRIMINATION.

YOU HAVE SEEN THE HEADLINES CREATED BY THE OFFICE OF CIVIL RIGHTS AT THE DEPARTMENT OF HEALTH, EDUCATION AND WELFARE IN SCHOOL AND COLLEGE INTERGRATION. FAIR HOUSING, VOTING RIGHTS, LAW ENFORCEMENT AND EMPLOYMENT ARE ALL GIVEN OUR ATTENTION AT THE WHITE HOUSE.
