Dear Mr. President:

When a number of Senators and I met with you last Monday, I indicated my hopes to be elected Chairman of the Republican Senatorial Campaign Committee. At that time, I asked if you would be willing to sign a fund-raising letter for the Republican Senatorial Campaign Committee. You asked to see the letter. A draft of that letter is enclosed.

Feel free to alter the substance. What is important to the Senatorial Campaign Committee is:

1. Your willingness to allow us to use your signature;
2. Refraining from giving your name to any other massive Republican mailing (the Congressional Campaign Committee or the Republican National Committee) until February 1st;
3. Permission to have access to the contributors to your Presidential campaign for nomination so that the same letter might be mailed to them.

Mr. President, time is of the essence. This letter will be mailed in January if you can simply leave permission for your signature to be used and further permission to have access to your contributors so that the letter may be sent to them.
