A Timely Review

On his swing through California over the weekend President Ford had much to say about the menace of "Big Brother bureaucracy" to American citizens. This formed an appropriate accompaniment for action by the White House yesterday halting the award of contracts for the Tierrasanta prison facility until the entire project can be reviewed.

Mr. Ford said growing federal power has tended to reduce the public to a "faceless set of digits." That's how many San Diegans felt in the long battle with the federal Bureau of Prisons and General Services Administration over locating a prison facility where it does not belong. We trust that federal officials will approach the forthcoming review of the project with one ear tuned to the people of San Diego and the other to President Ford's admonitions about bureaucracy getting too big for its britches.

Prisons Agency Breaks Rules

San Diego city officials have asked President Ford to intervene personally to prevent the U.S. Bureau of Prisons from going ahead with construction of a prison facility near the Tierrasanta residential development. The issue may be minor in the context of other White House responsibilities but it deserves the President's attention.

It is not a minor issue in terms of the relationship between the federal government and all of the communities across America in which the government is a property owner.

The federal government enjoys immunity to local building regulations and planning and zoning laws. Its property also is exempt from the California Coastal Zone Conservation Act passed by voters in 1972 to regulate development along the coast. The three-year effort by San Diegans to forestall the location of a prison facility in a neighborhood where it obviously does not belong is an example of headstrong use of those immunities by a federal agency.

The Bureau of Prisons has violated the spirit of the Intergovernmental Cooperation Act which requires federal agencies to seek conformity with local planning policies in their activities within a community. The prison project does not conform to the community plan for the surrounding area. It has been opposed by the San Diego city council, the San Diego school board, the San Diego County Comprehensive Planning Organization and the Tierrasanta Community

Council. Only under the pressure of a lawsuit did the bureau file an environmental impact report on the project.

The bureau has offered only the barest justification for rejecting nine alternative sites in the San Diego area more remote from developed residential property—and a more reasonable distance than 400 feet from an elementary school site, which is the case at Tierrasanta. The government's General Services Administration has proceeded with preparations for construction work at the site as if the indignant citizens on the periphery and the protesting San Diego agencies did not exist.

This does not strike us as intergovernment cooperation. It is highhandedness on the part of the Bureau of Prisons and an abuse of the exemption from planning and zoning which the federal government enjoys as a property owner.

President Ford and others before him have spoken of the need to reverse the flow of power from Washington back to local communities. Such programs as revenue sharing were designed to do this. The confrontation between San Diego and a distant Bureau of Prisons over the siting of a penal institution reminds us that money isn't everything. Here is a case where Washington is running roughshod over local determination on an issue crucial to the quality of life in a community, and it appears only the intervention of the White House can do anything about

pressed for about five years. They were reiterated here at a public hearing last week in the presence of the director of the U.S. Bureau of Prisons.

Elected officials of the city, the county and the school district expressed their opposition to the

project. So did an overflow audience of citizens.


But there was no indication that the federal authorities are any more willing to listen to the community objections than they have ever been.

The federal government can ride roughshod over local wishes because federal agencies do not have to comply with local planning and zoning laws. They can violate the community master plan at will.

Such extraordinary power to override local objections should be used, however, only when justified by absolute necessity. In this case there is no such justification.

Dear John:

Thank you for your letter of <u>November 16</u> referencing the planned construction of a Federal Youth Facility in San Diego.

As you probably know, my administration has long opposed the construction of Federal facilities within the State of California. It has been my position that Federal need for correctional facilities and services should be coordinated with State resources.

Currently, the California Department of the Youth Authority has approximately 50 Federal offenders housed in State youth facilities. The Federal Government pays for these youths on a contractual basis. Other facilities capable of housing Federal offenders exist within the State.

Approximately one year ago, representatives from my administration met with Attorney General Kleindienst and discussed our position on this matter. Basically, that position provided that Federal funds available for construction of correctional facilities in California should be directed to the State of California to provide facilities and correctional programs to meet those federal needs. If appropriate, these funds could be passed through the State to local government. In most cases, however, the State of California is in the best position to provide services to Federal offenders. My position has not changed from these earlier discussions.

I have already sent the attached letter to Attorney General Saxbe concerning this situation. I hope that this letter will forestall Federal construction plans in your area and produce a better working relationship in correctional planning between California and the Federal Government.

It is my understanding your administration is in the process of constructing a Federal Intermediate Youth Facility in San Diego, California. Construction of this facility is being opposed by the community residents but they have been frustrated in their attempts to secure public hearings to discuss the merits of the proposed facility.

I am extremely concerned that a major issue such as this is not being discussed publicly with the citizens affected.

I am also concerned that federal facilities are being planned within California's boundaries. Approximately one year ago discussions were held between my staff and then Attorney General Kleindienst. We indicated our willingness to work cooperatively with the Nixon Administration in the orderly development and placement of correctional programs within California's boundaries. At that time my staff indicated that existing available correctional resources in California were adequate to accommodate Federal prisoners who were residents of this Since then, this State has made several overtures to the Pederal Bureau of Prisons to provide on a contractual basis facilities for residents of this State who have violated Pederal laws. To date, officials in the Bureau have indicated little desire to utilize California facilities.

I believe it is imperative that you or your representatives get together with a representative of my administration to discuss mutual problems such as the one in San Diego.

Dear Mr. President:

I am writing to you an support of the citizens of San Diego and their opposition to the construction of a Federal Youth Facility in San Diego County. Although opposition to the prison was originally predicated on the inappropriateness of the Tierrasanta site, it has now come to my attention that such a facility is in total contradiction to the progressive philosophy toward youth corrections which has been adopted by the San Diego County Board of Supervisors. The correctional program which has been adopted in the Charty is one which is oriented toward behabilitation within small, community-based centers rather than in large institutions, which have a record of repeated failure.

I would bring to your attention, also, the Juvenile Justice and Delinquency Provention Act off1974, which mandates a similar orientation for Federal correctional programs. The law provides special emphasis on the development of programs and services which will encourage increased diversion of juveniles from the traditional juvenile justice system. The citizens of San Diego have thosen to adopt the approach suggested by the 1974 Act.

I urge you to act swiftly to hald this project which neither fits the plans of the local citizenry, nor complies with the ppirit of the law in the correction of youthful offenders.

On May 7, 1975, the Executive Board of the San Diego-Imperial Counties Labor Council reviewed the community input relative to the Federal Youth Center to be built at Tierrasanta. It is evident that the community of Tierrasanta is diametrically opposed to the building of this facility, as is the community of Scripps Farms.

The National Council on Crime and Criminal Justice, as well as the President's Committee on Criminal Justice, have asked for a ten-year moratorium on building federal correctional institutions.

Recently the Labor Council sponsored an eight-week course studying the Crime and Criminal Justice System. This course, as well as numerous related studies, has proven institutional incarceration has not rehabilitated individuals and that the system has failed, primarily because of the dehumanizing of individuals.

Five recommendations were considered by the San Diego-Imperial Counties Labor Council, i. e. --

- 1) Since the incarceration of individuals in institutions has failed miserably, the community-based rehabilitation facilities should be given full and due consideration.
- 2) The national correctional attitude for youth correctional systems is shifting to community-based systems.
- 3) A community-based facility places the burden equitably with the communities of both wasp and ethnic composition.

- 4) A community-based rehabilitation facility is primarily a unit of 15 individuals who are wards of the Criminal Justice System and live in a homogeneous atmosphere.
- 5) The cost to provide community-based rehabilitation centers is no greater than the cost of building a large, multi-facet institution and provides an equal amount of employment.

It was, therefore, the recommendation of our Labor Council to disengage the mombithic thinking of the Federal Bureau System and support the community by opting to a community-based federal youth rehabilitation program. San Diego-Imperial Counties Labor Council is therefore joining the factions who are opposing the building of the Federal Youth Center in the Tierrasanta community in supporting the community-based concept for federal youth rehabilitation centers.

Your support relative to the community and Labor Council's recommendation is looked upon with great concern.
