Dear President Ford:

Dear Mr. President:

I have given very careful and deliberate thought over the past four days to your request that all Republican Members of Congress suggest Vice Presidential nominees. I have approached this by making a list of every possible qualified individual, and then proceeded by the process of elimination.

In doing this I have asked myself (1) what person would best serve as President in the event succession became necessary, (2) from a Party standpoint who would be of most assistance in building the Republican Party and (3) who would have reasonably certain chances of being confirmed by both the House and Senate.

I have concluded that any one of the following three persons would meet those requirements, and have listed them in preferential order:

First Choice: Governor Ronald Reagan

Second Choice: Senator Barry Goldwater

Third Choice: Honorable George Bush

I do not believe that any person prominently connected with the Watergate matter should be selected, nor anyone who pronounced early judgment on Mr. Nixon. For this reason I strongly recommend against choosing Elliot Richardson.

From a partisan standpoint, I believe it would be very devisive to select Senator Charles Percy.

In the South, where our potential for Republican growth is greatest, the selection of Nelson Rockefeller would be harmful.
