Dear Mister President:

John Rhodes has advised me that you would like the views of the House members on the selection of a Vice President.

I am pleased to make recommendations, although I am certain that whomever you choose would be entirely satisfactory to me.

The primary and principal criteria for the selection of a Vice President is a person who would have the abilities and qualifications to carry on as President in the event that he were required to do so. In addition, he should be a person who is compatible with you, since a good relationship between the President and the Vice President is highly desirable.

In addition, there are other factors that ought to be considered. The approval of the Vice President-Designate by the Congress should be free of a lot of rancorous bickering. It would be good to have a Vice President from a different section of the country than the Midwest. It would be helpful to select a Vice President who would appeal to a broad segment of the American people. It would also be desirable to have a Vice President who has previously held public office and has a known record of achievement.

It would also seem desirable that before you make your selection, you have a full discussion with such person so that his understanding of his role is consistent with your ideas on this subject.

Again, I reiterate that I am certain I would be fully satisfied with whomever you would select. On balance, it seems to me that Governor Rockefeller would appear to have about all of the qualities that I mentioned above, and I would therefore suggest his name to you for consideration.
