I recommend the President meet with the whole legislative team once a week, preferably Menday mornings for fifteen minutes to brief him on the week's congressional activity, problem areas, etc.

In addition, I recommend Bill Timmens meet four days a week with the President for five minutes to update him on legislative developments.

SUBJECT: Daily Meetings

Representatives of this office attend four daily meetings:

(1) 7:30 a.m. <u>Domestic Council</u> (Cole). Most WH sections have personnel on the deputy level at this meeting to discuss policy issues, make recommendations and give assignments for staff work.

- (2) 8:00 a.m. <u>Senior Staff</u> (Rumsfeld). Section chiefs report on daily activities within their jurisdiction. Information exchanged.
- (3) 8:30 a.m. <u>Legislative Staff</u> (Timmons). Plan tactics and make assignments for daily legislative workload.
- (4) In addition this office participates, as an average, in one structured meeting with other WH sections (OMB, NSC, Domestic Council, CIEP, Economic Committee, etc) each day on a specific issue.

It is my view that the legislative staff holds the 7:30 a.m. meeting together, passing out much more information than we receive. In fact, these meetings are usually cancelled when Max or Tom do not attend while Congress is in recess. It is almost impossible for this group to make policy decisions or articulate positions already decided because it is a meeting without all principals and is too large to be effective.



The 8:00 meeting is interesting but seldom productive from a substantive point of view. It is too large to delve into program details and time is too short for full discussions.

WH staff seem to fall into two categories - those that have daily operational responsibilities and those that have longer-range consulting roles. The former must act, the latter must think. While not technically a line versus staff difference, the analogy is not dissimilar.

From my gerochial interest, it would be helpful to have you chair a morning meeting with heads of the operational arms of the WH: Legislative, NSC, Domestic Council and Press Office. Following that this group should meet briefly with the President to inform him of activities and receive his guidance on key issues.

This would replace both the 7:30 and 8:00 meetings and principals could return for their own staff meetings with "marching orders".

It may be that you would want to have a separate meeting with the President's advisory heads: Economic Committee, CEA, Energy Committee, CIEP, Counsel, Counsellors, etc.

Presidential Press Conferences

As a suggestion, you may want to include the President's Assistant for Legislative Affairs in briefings for the President before any press conferences.

While the WH press corps seldom ask questions on legislation, there is always the possibility the President could be embarrassed by failing to properly respond to tough questions on measures he should know about.

For example:

- Mansfield's new legislation on Turkish aid cut-off
- Campaign Reform
- Cargo Preference
- Surface Mining
- Freedom of Information
- Privacy legislation
- Continuing Resolution status
- Nixon tapes bill status
- ERDA conference report
- Veterans Education

and so forth.

Also the President should always be alert to opportunities at press conferences to mention good works of Republican Congressmen (Dole, Cook, Bellmon, for example). The Administration so far is a handicap to most GOP Members and a few good words could help. For instance, the requirement for legislation to carry an inflation impact statement was originally Bob Dole's and while the President didn't give him credit in the congressional speech he could give him a plug in the press conference.

MEMORANDUM FOR THE WHITE HOUSE STAFF

SUBJECT: Safeguarding Classified and Sensitive Information

Each staff office is requested to establish adequate internal procedures to assure that classified and sensitive documents and related materials are protected at all times. A specific person in each office should be given this responsibility, but it should be made clear that the last person in an office assumes the responsibility for the security of classified material.


The Executive Protective Service officers have been instructed to conduct a thorough after-hours security inspection of each staff office in the White House and Executive Office Building (EOB) on a nightly basis. Their authority to inspect extends to all exposed classified or sensitive documents, as well as all other related materials not properly secured. Classified material to be destroyed should be handled in the manner prescribed below. All other classified material should never be left unattended on desks. When an office is closed or unattended, materials should be locked in a secure cabinet. In the event of a serious security violation, the Executive Protective Service will file a formal report with the office concerned.

All classified and sensitive materials to be destroyed should be separated from other office trash and waste materials and placed in a specific container designated for this purpose. At present, paper bags marked "BURN" are available from the White House Supply Room and can be ordered along with other office supplies. Burnbags are collected under Executive Protective Service supervision and are disposed of in the secure macerator located in the EOB. Since the macerator has a limited capacity, all nonclassified and nonsensitive waste materials are collected and disposed of by the regular GSA cleaning force.

The provisions of the memorandum do not apply to the Situation Room since, because of the volume, separate disposal procedures are required.

A long time A/A indicated to me serious concern over the state of the White House Congressional Relations with GOP Members of the House and their staffs. This A/A expresses concern over the "grumblings" he has heard not only between GOP Members but also among the GOP Steering Committee people and a group of A/A's whom he considers are expressing the complaints and erosion of good will as stated by their "Bosses."

These complaints range all the way from the "snub" as disclosed in the attached newspaper article which I am told is actively being discussed among GOP House Members to complaints about W/H treatment in general including telephone manners and responses.

The sincerity and magnitude of this complaint illustrates that if the newspaper article is receiving that kind of play, coupled with the wounds and bruises lingering from the Nixon days, the Pardon furor, and the economic message (surtax) just prior to election, plus general vascillation by the Ford Administration in the closing days of the 93rd Congress, there is a lot of fence mending to be done with House GOP Members to establish better Congressional Relations. This is a block of 144 votes that the President should be able to count on in crucial situations. At the present, it appears the President cannot count on that kind of support from GOP Members of the House.

Recommendations:

- That Jack Marsh, Max Friedersdorf and staff meet with all House GOP 1. Members or the Freshman separately to determine what CR problems there are and set out to correct them.
- The President, Marsh and Friedersdorf meet with all House GOP Members 2. some evening for approximately one hour in a give and take session to determine any CR problems, or meet with the freshmen Members only to determine the same.

Congressional Relations

The 7:30 a.m. staff meetings have indicated that there will be future Presidential Messages being sent to the Congress. These separate messages are in the drafting stages at this time and will most likely involve general revenue sharing, land use, transportation, legislation in support of the President's budget and proposals on legislation that is expiring by operation of law.

In order to establish and maintain the best possible relationship with the Congress it is suggested that Members of Congress of both parties, especially those who have demonstrated an expertise or because of their leadership position on Committees, Subcommittees or otherwise, be consulted and given an opportunity to express their views on the subject or matter.

Such consultation should take place after the Administration has considered the over-all program, the problems involved and prior to a final position being taken by the Administration. The manner of consultation should outline the program from the Administration's view point, identify problems or needs with the program and the options available.

The Member or Members with whom the Administration is consulting should then be asked his judgment or opinion on a series of options presented to him on paper at that meeting. The Member or Members should then be given an opportunity to express any other views they may want to suggest for further consideration by the Administration both orally or in writing.

The above consultative procedure should be started, if it is not being done. My experience on the Hill and association with Members of Congress establishes the lack of consultation as the <u>primary</u> reason for confrontation between the Administration and the Congress.

It is suggested that this procedure be started at the Department or Agency level or at the OMB-Domestic Council level which ever is more appropriate but more meaningful in terms of Congressional relations. This procedure in my judgment would clearly establish a two-way street for consultation between the Administration and Congress. It will provide the Members of Congress with the kind of opportunity they want to make an input into the decision-making process. In some cases, but limited, this will involve a pet project of the program in which the Member or Members are involved. In the final analysis it gives the Members the opportunity to act like decision makers, get their pet peeves off their chest, and remove the primary complaint that they are not consulted with a fait accompli which they are asked to support blindly.

The establishment of some kind of consultative procedure in the Ford Administration with Members of Congress will coincide with the changes occurring in the decision making process on the Hill, i.e. changes ranging from Committee Chairman and Ranking Minority Members, to Subcommittees and King Caucus rule.

A consultative procedure with the Members of Congress will permit the Administration to gain quick insight into the make-up of the new 94th Congress, provide the basis for communication, consultation, cooperation and compromise as expressed and extended by the President, and result in Congressional approval of the President's program to a greater extent that has been achieved in the past with an opposition Congress.

Jack, I had an extended discussion with Terry O'Donnell concerning the proposal relative to the seating of Members in the East Room for ceremonial occasions. In point of fact. Terry advises me that he has the principal responsibility for the control and coordination on all of these events. Every effort is made to place all appropriate MC's on the platform, and to reserve a sufficient number of front row seats for other Members of Congress.

I discussed with Terry a number of unhappy experiences we have had in this general area.

The following recommendations resulted from our discussion:

- Earlier notification and coordination by our Legislative Affairs Office with Terry O I onnell in order that a plan might be instituted as far in advance as possible.
- 35 Assure the presence of a representative of our House and Senate side types to permit immediate identification and proper seating (or platform placement) of Members of Congress.

In summary, Terry is willing to cooperate in any way possible to eliminate any and all problems relative to the attendance of MC's at East Room ceremonial functions. Any individual suggestions from our Office of Legislative Affairs can either be forwarded to me. or directly to Terry.

I want to talk with you about two problems which are occurring involving Members who are visiting the White House on special occasions.

The first, and the most important, relates to their being expedited and passed through the gates. There has been a tremendous number of complaints about delay at the gates and I believe something can be done to expedite this. My suggestion would be that we bring in the Chief of the Force and discuss it with him in a cooperative way as opposed to a critical way. What's happening is that the Member once he gets to the gate is cleared rapidly; however, in many cases there is a delay in getting him to the gate and in some cases, a failure to identify him as a Member of Congress.

The second problem is of a lesser nature but it relates to the seating of Members in the East Room for ceremonial occasions. The Military Office seems to be placing non-platform Members who are guests in the back rows. I mean by this, the third and fourth rows rather than the first row. Something should be done to try and get more Members on the platform and secondly, to place in the front rows Members who are not located on the platform.

For your information, Terry O'Donnell has a big role in the platform guests, but I suspect the Military Office, Maria Downs, and Tex Scouten have the authority in the regular seating. I think the place to start is with the Military Office and with Maria. But endeavor to do this in the spirit of cooperation rather than in a spirit of criticism,

In all events, I would like to discuss it with you before you begin.

In the meantime, I think you should speak with Bill Kendall who has observed a number of the problems and I think he can sum up quite accurately the problem as it exists.
